- 4. Discussion, Consideration and Possible Approval of Resolution 2020-1057, a Resolution of the Mayor and Common Council of the Town of Camp Verde, Yavapai County, Arizona, declaring and adopting the results of the General Election held on November 3, 2020.** Staff Resource Cindy Pemberton

Town Clerk Cindy Pemberton stated that the Resolution before them was to adopt the results of the General Election that was held on November 3, 2020 noting that there were 7,222 registered voters in Camp Verde and a total of 5,311 votes were cast for the Permanent Base Adjustment. There were 44 rejected ballots within our precinct which resulted in a voter approval of Proposition 452, with 2,838 voting yes and 2,473 voting no.

On a motion by Councilor Jackie Baker, seconded by Councilor Bill LeBeau Council voted to approve Resolution 2020-1057, a Resolution of the Mayor and Common Council of the Town of Camp Verde, Yavapai County, Arizona declaring and adopting the results of the General Election held on November 3, 2020. Motion passed 5-0. Mayor Jenkins, Vice Mayor Butner, Councilor Baker, McPhail and LeBeau voted in favor
