6. Special Announcements and presentations

Presentation of Motorola Command Solutions Management Analytic Software.
 Staff Resource Corey Rowley

Marshal Corey Rowley introduced Richard Hendricks from Command Solutions who gave an overview of the Records Management Software System.

Mayor Jenkins asked for Point of Clarification, is there a motion needed or is this just a presentation. Town Clerk Cindy Pemberton stated this item is not an action item so no action is needed. Marshall Rowley stated this is a demonstration in preparation for Capital Improvement item to be voted on at a later meeting.

7. Discussion, Consideration and Possible Approval of a sewer fee adjust for RV parks and hotel/motels for the calendar year 2021. Staff Resource: Steve Ayers

Economic Development Director Steve Ayers stated at an earlier meeting, a request was brought to the town that asked for an adjustment for fees they are currently being charged. The Town received instruction from members of Council to look at it in relation to residential fees. After looking into rates he put together a rate comparison that broke down cost analysis (see spreadsheet). He feels an adjustment is needed but have to figure out how to break it down. Staff is proposing one of two methods of adjustment- one based on water usage and one based on occupancy rates.

Representative of Red Moon Brad Woodruff introduced himself and appreciates everyone's time. He is attending if Council has questions.

Councilor LeBeau asked if there are different rates for commercial vs residential. Mr. Ayers stated yes, all hotels/RV parks (room vs spaces) are charged at a residential rate. Commercial rate is based on public amenities. They have a mixed zoning & mixed rate.

Councilor LeBeau asked what was the town's involvement in getting the system set up, how invested are we? Mr. Martin said there is a connection fee, capital fee. Troy Odell stated a lift station was put in and they were reimbursed for the area of land that had the lift station on and a larger line that was installed.

Mr. Ayers said it was the Town's decision to put in a larger line in that was required at that time. A hole had to be dug either way, the Town just paid the difference in anticipation of future needs that could come up. Electrical for the Lift station is being supplied by RV Park.

Councilor Baker suggested putting together a new rate study at a later date.

Mr. Ayers reviewed the three different rates and how they were calculated.

Troy O'dell is concerned about future adjustments that may be requested. Finance Director Mike Showers spoke to Troy's concerns and said we should not be using reserve to make this cut. He is predicting good revenues from waste water fees. This is a one-year proposal to come to a solution.

Motion by Councilor Murdock to approve the establishment of a sewer fee adjustment for RV parks and hotel/motels for the calendar year 2021 based on the occupancy percentage and the Chet Teague version. Second was made by Councilor Baker.

Doing well with revenues. Anticipate December revenues to be up as well.

Operational Update- Town Manager Russ Martin

Vaccines should be coming to Camp Verde soon for first responders (Spectrum Employees or Camp Verde Fire). Hospitals are doing better this week than last week. Staff continues to follow guidelines. The Town received about 40 rapid tests to use if needed. Stored in the Risk Manager's Office. These are self-administered tests. If constituent's need PPE's the Town has access to supplies, have them contact the Town.
