

PROCLAMATION

DESIGNATING THE WEEK OF DECEMBER 19TH THROUGH DECEMBER 26TH, 2021 AS 'VERDE RIVER WEEK'

WHEREAS ten years ago, on December 27, 2011, Friends of Verde River Greenway was formed with the stated purpose to preserve, enhance, and promote the scenic, natural, historic, cultural and recreational resources of the Verde River Greenway corridor by working with stakeholders and increasing public awareness as to the variety of recreational, natural, and historic resources within the Verde River Greenway, a unit of Arizona State Parks.

WHEREAS the initial Board of Directors were Delbert "Chip" Norton, Tony Gioia, Marsha Foutz, Peggy Chaikin, Bob Rothrock, Jane Moore, Diane Joens, and Steven "Max" Castillo, with the officers being Chip Norton, President; Tony Gioia, Vice-President; Diane Joens, Treasurer; and Co-Secretaries Marsha Foutz and Peggy Chaikin.

WHEREAS in 2011 the Cooperative Invasive Plant Management Plan was completed with a vision that "the Verde River and its tributaries comprise a diverse, self-sustaining and resilient riparian ecosystem in which invasive plant species are controlled through cooperative stakeholder participation" through the cooperative participation of over 20 stakeholders including federal and state land managers, wildlife management agencies, businesses, university, nonprofit organizations, and others; and that out of this process arose the Verde Watershed Restoration Coalition.

WHEREAS in 2016 Friends of the Verde River, in partnership with The Nature Conservancy, Walton Family Foundation, Environmental Defense Fund, and Bonneville Environmental Foundation teamed up to form the Verde River Exchange, a program that connects businesses willing to temporarily reduce their water usage with groundwater users seeking to reduce the impacts of the water usage; the first buyers of water offset credits were Page Springs Vineyards and Merkin Vineyards.

WHEREAS in 2017 Friends of the Verde River was born out of the merger of three organizations: Friends of Verde River Greenway, Verde River Valley Nature Organization, and Verde River Basin Partnership; and the Board of Directors at that time were Delbert "Chip" Norton, President; Tony Gioia, Vice-President; Harry Sweet, Treasurer; Peggy Chaikin, Secretary; and Brent Bitz, S. Max Castillo, Susan Culp, Jeni O'Callaghan, Marsha Foutz, and Siera Russell.

WHEREAS in 2021 the mission and vision of Friends of the Verde River is to work collaboratively for a healthy, flowing Verde River system that supports our natural environment, vibrant communities, and quality of life for future generations; focusing on restoring habitat,

sustaining river flows, and building supportive communities through working proactively in a combination of "boots-on-the-ground" projects and policy solutions guided by sound conservation principles to meet human and environmental needs in an outcomes-oriented manner.

WHEREAS to date the Friends of the Verde River has employed 200 Conservation Corps youth and military veterans to restore 10,357 acres of riverside forest to native vegetation; has kept 19 million gallons of water in the Verde River since 2016 through the Verde River Exchange; issued the first Verde Watershed Report Card in 2020; has mobilized countless volunteers working to restore habitat and promote the Verde River to the public; brings over 450 people annually to Cottonwood and the Verde Valley for the Verde Valley Birding & Nature Festival along with other events; and annually contributes significantly to the local economy.

THEREFORE BE IT RESOLVED that the week of December 19th through December 26th, 2021, will be designated as Verde River Week in honor of this history of Friends of the Verde River and its contributions community.

Background Information:

Mayor and Town Council met with the Magistrate finalist and have selected Gary Horton to become the next Presiding Town Magistrate after interviews and deliberation on December 6th. This would be a 2 year contract for services with Gary Horton.

Recommended Action (Motion): Move to approve a contract with Gary Horton for two years with a contract commencing on December 16th and expiration of December 31st, 2023.

INDEPENDENT CONTRACTOR AGREEMENT

THIS INDEPENDENT CONTRACTOR AGREEMENT ("Agreement") is entered into the date below signed by and between Common Council of the Town of Camp Verde, Arizona, hereinafter referred to as "The Council", and Gary Horton, hereinafter referred to as "Mr. Horton", witnesseth:

WHEREAS, the Council desires to contract with Mr. Horton as The Town Magistrate of Camp Verde, Arizona, and provide for conditions of Mr. Horton's service hereunder; and,

WHEREAS, Mr. Horton desires to be under contract with the Town of Camp Verde as Town Magistrate of Camp Verde, Arizona, under the terms and conditions outlined herein,

NOW THEREFORE, in consideration of the mutual covenants, promises and payments hereinafter set forth, it is agreed between the parties as follows

T.

The Council hereby appoints Mr. Horton as the Town's Presiding Magistrate to perform the functions and duties specified in Section 5-2-1 of the code of the Town of Camp Verde, Arizona, and such other reasonable functions and duties as the Council may direct.

 Π

This Agreement is based on the Arizona Constitution's requirement of separation of powers and the necessity of judicial independence to preserve and protect that separation. This Agreement shall set forth the parameters, guidelines, duties and rules of conduct, and compensation during the term of this Agreement. It is agreed as follows:

- 1. Term. This Agreement shall be effective from the 15th day of December 2021 through the 30^{th} day of December, 2023.
- 2. Compensation. Mr. Horton shall be paid the sum of \$72,800 in twenty-six (26) biweekly installments and is based on a 28 hour per week which is inclusive of any on-call time, meetings, travel and education that is necessary throughout the year. The expected typical work week will consist of 28-hours per week for the term of this Agreement. Mr. Horton shall be an independent contractor and shall not be an employee of the Town of Camp Verde. As a result, Mr. Horton shall be responsible for all payroll withholdings as required by law and shall be entitled to no employee benefits. Nothing in this agreement shall prevent, limit or otherwise interfere with the right of Mr. Horton to resign at any time from the position of Magistrate. In the event Mr. Horton voluntarily resigns as Magistrate with the Town of Camp Verde before expiration of the term of this Agreement, Mr. Horton shall give the Council sixty (60) days written notice, unless the parties otherwise agree in writing.
- 3. Duties. Mr. Horton shall perform all duties as set forth in Section 5-2-2 of the Town Code as well as any other duties required by law or the Judicial Code of Conduct or by the Presiding Superior Court Judge of Yavapai County. Mr. Horton shall assist in the preparation of the budget for the municipal court and shall report to the Town Council regarding the state of the municipal court upon request. Mr. Horton shall perform the duties of Presiding Town Court Magistrate pursuant to all laws, ordinances and rules of the State of Arizona, Town of Camp Verde and Arizona Supreme Court. The budget shall include an amount for judge pro tem services, and Mr. Horton shall limit his time off during each fiscal year so that the judge pro tem budget is not exceeded. He shall devote such time as necessary to cause the Town Court to

function in a proper manner and may use assistant magistrates within the constraints of the approved budget of the Town Court.

4. Conditions of Service.

- (a) Mr. Horton shall preside as Presiding Magistrate over the Town of Camp Verde Municipal Court System and other assistant magistrates of the Camp Verde Municipal Court whether full time or part time.
- (b) Mr. Horton shall at all times ensure that his conduct as Magistrate of the Town Court of the Town of Camp Verde does not violate the Code of Judicial Conduct, Rule 81 of the Rules of the Arizona Supreme Court, dated September 1, 2009, and any other Rule or law governing the conduct of magistrates during the terms of this Agreement.
- (c) The Town shall also bear full cost of any fidelity or other bonds required of Mr. Horton under any federal, state or local law or ordinance.
- (d) Mr. Horton shall make available to the citizens/customers, a Customer Service Survey evaluation in the lobby of the Camp Verde Court at all times.
- 5. Training and Support. The Town will pay all necessary dues, membership fees, and publication/subscription fees for legal materials and other required supporting materials, subject to proper budgetary authority. Mr. Horton shall be allowed to attend at Town expense the annual Judge' Conference subject to proper budgetary approval and Town Council approval for any additional conferences, training sessions, or seminars that are related to the functioning of the Town Court, criminal law, or criminal procedure. The Town shall provide suitable municipal court facilities and staff.
- 6. Termination. The parties hereto agree that this appointment may be terminated for cause, or by mutual agreement, during the term hereof. Should the Town of Camp Verde determine that cause for termination may exist, it shall provide not less than ten (10) days written notice to Mr. Horton setting forth the specific cause and a time and place for a hearing. At any hearing so established, Mr. Horton may be represented by independent legal counsel, have the benefit of full disclosure as to said cause, may call witnesses on his own behalf, and shall have the right of cross examination of any witnesses called on behalf of the Town of Camp Verde.

IN WITNESS WHEREOF, the Town of Camp Verde, Arizona, has caused this agreement to be signed and executed in its behalf by its Mayor, and duly attested by its Town Clerk, and Mr. Horton has signed and executed this agreement, both in duplicate, the day and year first above written.

Background Information: This item appeared on the Oct. 6 meeting agenda but is being resubmitted due to procedural errors. In early August the Clerk's Office realized that our current Fee Schedule for renting facilities to Political groups was not in compliance with State Law. Upon discussion, P&R ceased renting facility space to Political groups pending development of an adjusted fee schedule complying with State law.

Recommended Action (Motion): Move to approve Resolution 2021-1074 a Resolution of the Mayor and Common Council of the Town of Camp Verde, Yavapai County, Arizona, amending fees for Town services for fiscal year 2021-22.

Background: Based on interpretation of the current Town Fee schedule P&R staff was treating Political groups as Class A non-profits when renting facilities. This practice was halted in mid-August when the problem was realized by the Clerk's Office. State statute prevents the "use or expenditure of ...facilities...personnel...equipment...buildings or any other thing of value of the city or town, for influencing the outcomes of elections.". This proposed fee schedule makes modifications for Class D Political groups using Town facilities to bring into compliance with ARS 9-500.14.

Statement of the Problem or Opportunity: The current Council approved Town fee schedule does not allow proper categorization and fee schedule for Political groups in compliance with ARS 9-500.14.

Alternatives/Options/Solutions:

- 1) Do nothing continue status quo Currently P&R is not allowing Political groups to rent facilities for use.
- 2) Refer for further study This would consume more time while the only allowable outcome under State law would be a modification in specific fees.
- *3) Adopt the proposed Fee schedule with changes P&R –* Council approval will allow us to resume renting facilities to all appropriate groups and individuals including Political group.

Comparative Analysis:

Option 1 reduces the scope of services offered by P&R.

Option 2 creates unnecessary delay without a substantive change as a benefit.

Option 3 allows us to resume providing a full range of services to the public

Fiscal impact to the Town: This will provide a small amount of additional revenue to the Town.

Other Impacts: Additional attention to political issues.

Conclusion: Approval of this adjusted Fee schedule will allow P&R to resume providing a full range of services to the public.

Recommendation: Staff recommends Option 3, adoption of the modified Fee Schedule.




