## WRITE-IN CANDIDATE CHECKLIST

- A. As a candidate, you must file a Statement of Organization to form a Candidate Committee within ten days of meeting the committee criteria. (For additional requirements and restrictions refer to A.R.S. § 16-905.)
- B. You may <u>not</u> file as a write-in candidate pursuant to A.R.S. § 16-312(F) if any of the following applies:
  - 1. As a candidate in the PRIMARY election:
    - a. You filed a nomination petition for the current primary election for the office sought and failed to provide a sufficient number of valid petition signatures as prescribed by A.R.S. § 16-322;
    - b. You withdrew from the primary election after a challenge was filed; or
    - c. You were removed from or otherwise determined by court order to be ineligible for the primary election ballot.
  - 2. As a candidate in the GENERAL/RUNOFF election:
    - a. You ran in the immediately preceding primary election and failed to be nominated to the office sought in the current election;
    - b. You filed a nomination petition for the immediately preceding primary election for the office sought (or other than by primary for the office sought) and failed to provide a sufficient number of valid petition signatures as prescribed by A.R.S. § 16-322 or A.R.S. § 16-341.
- C.   - 2. The Financial Disclosure Statement (prescribed by the Secretary of State).
- D. <u>Note</u>: In order to be issued a certificate of nomination or election, A.R.S. §§ 9-821.01 and 16-645 require a write-in candidate to receive a number of votes equivalent to or at least the same number of signatures required by A.R.S. § 16-322 for nominating petitions for the same office.
