

# **Parks and Recreation:**

- Yoga, Qi Gong, and Zumba Gold classes continue weekly. We will be adding an evening Zumba class starting in February. Pickleball is continuing to play 3-4 times per week.
- Staff has continued working on the design principles and concept for Verde Lakes Community Park.
- Staff continues to attend a variety of virtual Forums including tournaments, aquatics, and special events to stay up on what is going on with other P&R Departments around the State.
- Scheduled facility uses this month were as follows: Meeting rooms had 53 uses, Ramadas were at 11 uses, Gym had 54 uses, Sports fields had 50 uses, kitchen 13 uses, PW Conference room 12.
- Staff continues to work with Ron Long on plans for the Sports Complex, including assistance with design of the restroom/concession facility.
- Staff requested Council approval to apply for a matching grant for play structures at the Sports Complex which failed on procedural grounds. We have since been informed that no more funding is available until next Fiscal year. We will be monitoring the Heritage Grant funds and will continue to work on applying for grant funds for additional amenities at the Sports Complex.
- Staff also applied for a non-matching ARPA grant for upgrading the lights at Butler Park to newer, more efficient LED fixtures on the existing poles. This grant was awarded (\$493, 272) and is going to Council on Feb. 2 for acceptance. Staff met with MUSCO and the sub-contractor to finalize the quote. This item will be on the Council agenda for February 16 to award the contract. The initial plan is to have lighting installed in May.
- 5<sup>th</sup>-8<sup>th</sup> grade Grasshopper Basketball has begun. The draft was held January 5<sup>th</sup>, with the first games being held January 15<sup>th</sup>.
- Parks & Rec had 2 community trips in January. We went to Scottsdale Museum of Contemporary Art and Mesa Contemporary Art Museum on Jan. 14<sup>th</sup> and to Desert Caballeros Western Museum in Wickenburg on Jan. 28<sup>th</sup>. We had a total of 11 people travel with us this month. Staff is now planning for the 2<sup>nd</sup> quarter trips starting in April.
- The eight park benches that were acquired through the AARP grant have been put in at the Sports Complex around the perimeter trail, thanks to the Old Guys. The plaques for those benches were installed and this project is now complete with all reporting finished this month.
- Staff continues planning and preparation for the annual Pecan & Wine Festival being held the 3<sup>rd</sup> weekend in March. At this time, we have 13 wineries, 53 outside vendors, and 24 inside vendors registered. We are also partnering with the Northern Arizona Blues Alliance for the Verde Valley Blues and Roots Revue for the music portion of the event. Staff has also received commitments for \$4,800 in Sponsorship for the event so

- far. Marketing has begun in cooperation with the Verde Valley Wine Consortium and their PR firm.
- Staff continues to work on programming and staffing for our summer day camp.
   Seasonal positions have been posted on the website. With the plan to expand camp to
  40 campers this summer, we are looking to hire additional staff. We have also
  approached some additional sponsors for the program, which include continued support
  from the Clif and Dee Jenkins Trust, and potential new sponsors Kiwanis of Camp Verde
  and Yavapai College.
- Staff continues planning for the upcoming pool season. Lifeguard training is scheduled for mid-March. Seasonal positions have been posted on the website. The pool heater has been delivered with plans to have it installed and running by the middle of March.
- Staff has been working with Nicole from the library on new volunteer management software and are making great progress with Volgistics. We utilized the free month of service and have now paid for the first 6 months for this program. The Library, P&R, and HR will be using this program.

# **Wastewater Plant:**



Jan. 11, 2022 Arizona Supreme Court's Newest Justice Kathryn H. King Takes Oath at Investiture Ceremony PHOENIX – Arizona

Supreme Court Justice Kathryn H. King was ceremoniously inducted into the state's highest court on Friday, January 7. The investiture took place at Xavier College Preparatory, Justice King's high school alma mater. Although Justice King officially joined the bench in July 2021, her investiture served as the ceremonial acknowledgement of her appointment. She is the fifth woman to ever serve on the Arizona Supreme Court. Chief Justice Robert Brutinel said in his remarks, "in the time you've been on the Court, you've demonstrated already that you're willing to speak your mind, defend your positions, and try to persuade others ... but you've also demonstrated a willingness to listen and consider other people's points of view and have your mind changed where it's appropriate. "The hour-long investiture featured the official oath administered by Chief Justice Robert Brutinel, robing by Justice King's husband and two children, and remarks by Governor Doug Ducey, U.S. District Court Judge Michael Liburdi, her former law partner Christine Burns, and her mother Anita Hackett. The full Arizona Supreme Court bench and several Court of Appeals Judges from Arizona Divisions One and Two accompanied Justice King on stage during the event. Current and retired justices and judges joined the celebration along with elected officials, personal friends, and family. "Every day when I walk into the courthouse, I feel a deep sense of honor to be serving the state in this capacity," said Justice King during her closing remarks.

**Report from the Library Director:** I believe that it is vital to the success of the library to have a team that:

- is **adaptable**, embraces change, and is willing to master new information and technology which contributes to accomplishing the overall mission of the library.
- that recognizes **teamwork** and **collaboration** which goes beyond verbal support to active participation are required to maintain morale, create a positive work environment, and find solutions that contribute to the success of library operations.
- adopts high work standards that accomplish assigned tasks independently, and shows increased levels of
  involvement, innovation, initiative, and technical skill. Meeting the activity levels and high expectations of
  the organization and the community requires energy, focus, and the ability to prioritize assignments from
  the start of the day to the end of the day.
- treats customers with equanimity and realizes that honoring patron privacy is as vital to **customer service** at the library as active listening, empathy, problem solving, and communication. Problem solving is demonstrated when team members apply technical knowledge and understanding that anticipates the needs of customers and provides suitable solutions.
- embraces practical learning opportunities in 21st Century skills that provide team members the new jobrelated skills they need to contribute to new library services, programs & resources that meet the needs and expectations of the community.
- supports the library's daily operations accurately through attention to detail by following procedures, ensuring high-quality output, and taking appropriate action. Highly valued team members become proficient at self-monitoring for accuracy, planning for contingencies, organizing for efficiency, and communicating appropriately.
- understands that maintaining the right combination of **technical and professional knowledge** is vital for all team members. In the 21st Century, technology does not stand still. Individual team members must demonstrate interest in and aptitude for continual assimilation of new technical information that differs in variety and complexity to perform their job effectively.

Over the past 5 years in our new building, we have worked to build a team that excels in the qualities above and more. Team members enjoy working with each other, support one another's goals, and while they can't entirely do each other's jobs, they can and do fill in for each other in a pinch. In the past year I have come to recognize the success of the library team in that I no longer have to worry about how things are being handled

when I am not there. As individuals we are far from perfect, but as a team we are come pretty darn close. KUDOS and THANK YOU to the Library Team for helping set the standard of excellence: Leticia Ancira, Sandy Boaz, Lisa Carnevale, Sharon Freeman, Zack Garcia, Alice Gottschalk, Janell Leland, Nicole Metz-Andrews, Carson Ralston, Wendy Roberts, and Jaye Valles.

Special recognition and congratulations are in order for Leticia Ancira, known as Ms. Letty in library-land. Letty was one of 10 participants selected by the AZ State Library to complete the Certificate in Early Childhood Literacy through Library Juice Academy online. She successfully completed 6 classes over the course of a year to earn her certificate. Congratulations, Ms. Letty!



Report from Volunteer Services: In collaboration with Camp Verde Parks and Recreation, we have begun to implement a software management program that will enable us to organize, recruit and manage our volunteer force. Angi Grubbs and I (Nicole Metz-Andrews) have been working on the program and have been building it into a system that will be most effective for our needs. This project has been outside of both of our comfort realms, but we have been making significant progress. The Friends of the Library have become revitalized and are making plans for projects at the library and throughout town. The Friends, with the permission of Stuart Hayden of Fort Verde Laundromat, are going to establish a children's bookshelf at the laundromat. This "laundromat library" will be filled with book donations made to the library and with items funded by the Friends. We are looking forward to establishing this in the spring. Our Friends Book Nook crew is also setting side books from the monthly donations they receive to donate to the Yavapai County Jail. We were happy to give 427 books in December and 204 in January toward this project.

**Report from Tech Services:** With Nicole's help, I have begun training library clerks and volunteers to help with some of the physical processing of donated materials. This has allowed me to tackle some of the backlog of donated DVDs on my shelves. In January we added 62 movies to the library collection.

Report from the PC Helpdesk: January was a busy month for the patrons as well as for the library. I cannot begin to name one specific thing this month. With January usually comes a lot of questions dealing with new devices. Either they are Christmas presents or the adult children got their parents something that is new and better for them. I enjoy this part of my job, teaching people how to use the equipment they have in the palm of their hands.

**Report from Circulation:** - by Volunteer, Valerie Trammell - Something special happened the other day at the front desk. A man came walking up with used books he'd selected from the Book Nook. The look on his face was hard to describe so I asked him if he'd found something good. He opened one of the

books saying, "I can't believe it! This is my book!" I asked him if he'd written it, but that wasn't it. "I wrote the inscription. This is my handwriting," he said. He showed me the book cover, a photograph of a shack surrounded by palm trees and a soldier with a gun. He told me that he was stationed there during the Korean War, a shack in the middle of nowhere. He said he found the book many years ago and had it on his shelf when he met a guy who had also been assigned to the same post at a different time, during a different war. After writing a message inside the book, he gave it to his new friend. They lost touch and his friend died before he could get his book back. Then he found it sitting on a shelf in the library Book Nook with his handwritten note still discernable inside. After hearing that, I couldn't charge him for the book. It belonged to him. He walked out the door a happy man wondering at the odds of such a thing happening.

Report from the Children's Library: January brought the feeling of new beginnings as children decorated the area with coloring sheets that read "Happy New Year." The garden is quiet and dormant as it rests before the busy season that is just around the corner. I want to thank Victor, from CV Town Maintenance for installing a rain gauge to capture rain in the upcoming months so that children can see how much rain Camp Verde is getting and determine if we get a lot or not enough rain. We can use this to help bring awareness about the use of water and to teach them to always treat it as a precious gift and protect it. We believe it is important to our garden and hope to utilize the information when it rains. The Children's area did notice less activity and we also took a step back in number of activities we had available due to the Omicron virus. I visited Hope Women's Center to learn about the services they provide to women in need in the community and to talk about how we can collaborate as we both provide services in our community.

Report from the Teen Library: In January attendance for Game Nite inched closer to pre-2020, which is exciting. More kids are coming in daily, and I expect the numbers will keep growing. Once they begin to stabilize around 15-20, I'll bring pizza back. I am working on a new STEM-focused program for teens. The program will use grant-funded kits that are open-ended and encourage learning through experimentation and innovation. The first kit, Makey-Makey, is a programable USB input device that allows you to turn anything conductive, like fruits, into input keys via alligator clips. This allows you to play a piano using bananas, or navigate a video game with Play Doh, and countless other things. The other kits on the way include Little Bits and Snap Circuits, both of which are modular circuit kits. Additionally, funds were approved to be transferred by Verde Valley Forum for Public Affairs to an account held by the Friends of Camp Verde Library, for the formation of the Verde Valley Youth Civic Engagement Group. The group will exist for the advancement of civic engagement in the youth of the Verde Valley in a meaningful and sustainable fashion.



Kanopy is now on OverDrive. Library card holders can now discover Kanopy streaming movies directly from Overdrive's Libby app. Kanopy appears in the Extra section of the Libby app. The Kanopy app and all the ways for users to browse, stream, and enjoy videos from Kanopy remains unchanged.

- Users can stream videos in the Kanopy mobile app, on the web, or via Roku, Apple TV, and other Smart TVs. Access via Libby is simply another way for users to discover the service.

# Joe's Garage to perform at Camp Verde Community Library Thursday, January 20

Join us on Thursday, January 20th from 5:30-7:00p in Camp Verde Community Library's Fireside Room for a special performance by Joe's Garage.

Joe's Garage (Band) is the creation of Joe Newnam. Joe's passion for music led him on a quest to search for musicians with a common interest and good chemistry to play rock, pop, and blues music. Many musicians have passed through Joe's garage over

the years. All have a passion and energy for the music and have shared their knowledge and enthusiasm with those of us who followed after and those who remain.

Joe's Garage consists of *Joe Newnam* - Percussion, acoustic guitar, and lead and harmony vocals, *Alan Williams* - Lead guitar, *Lincoln Thomasson* – Bass, *Ken Simeral* - Electric & acoustic guitars and lead and harmony vocals.

Joe Newnam – Drum, acoustic guitar, and vocals: It was the Beatles in 1964, then Jimi Hendrix, that piqued my interest in music. In the 4th grade, I joined the school orchestra as a drummer and started taking private lessons. After high school, I played on and off with working bands. Things got a bit more serious when I moved to New Mexico (about 12 years ago) and started playing drums with a fine R&B group at the local venues. Upon moving to Prescott, I played gigs with other musicians. After a time, I decided to pick up the guitar. I began reaching out to other local musicians with common interests. My love of rock music kept me in the game and eventually evolved into the present-day Joe's Garage.

Alan Williams - Lead Guitar: I purchased my first guitar at 19. My influences were Chuck Berry, Eric Clapton, SRV, and Mark Knopfler, along with so many of the old blues greats like the three Kings, Muddy Waters, and Robert Johnson to name but a few. In the late 80's I began playing in bands in the Fresno area. I moved to San Louis Obispo in 2000 and played at area blues jams and was a founding member of the Back Pages Band and played lead for The Pickled Beats. I moved to Prescott in 2018 and joined the band in 2019. This band has evolved to play the music I always dreamed of playing. Great guys, great chemistry, great music.

Lincoln Thomasson – Bass: I've been toting a bass for a while. When people ask how long I've been playing, my standard response is "Some nights it feels like 30 years, some nights 30 minutes." That is the nature of playing music live. I have had, throughout the years, the good fortune to surround myself with "A" list players, and have been humbled by them many, many times. I played with a "Margaritaville" group for some time and It really taught me to be "true to the music," and I've never forgotten that mantra. Once again, with Joe's Garage, I've been fortunate to find a group of mates from very different parts of the country with varying degrees of experience, both in life and music. However, when we start to play, it's like we have been doing this together for a very long time. Do what you can, as well as you can and your music will provide all the accolades you will ever need.

**Ken Simeral - Rhythm guitar and vocals:** I grew up in St. Louis, MO during the 50s and 60s. I "played" in garage bands at 16. My motivation was girls. I wanted to be George. In college, I played for pizza, beer, and women (The order was always changing depending upon my appetite.). From 1987-2015, I focused on my marriage, my 3 sons, and my career, while my guitar 'gently wept', in the closet. I retired [from the US Forest Service] in 2015 and decided to dust off my guitar and wipe off the tears. Playing with Joe, Alan, and Lincoln has been a real learning experience, not to mention, a lot of fun.

It has been very satisfying to arrive at that place, with fellow musicians, where everything gels.



# Directors Report for January 2022

At nearly full staff, the Department has turned the corner from backlog recovery to increased training of newer staff to bolster and enhance their skills. Newer staff are starting to study and train for the various certifications which are part of their positions.

<u>Planning & Development Projects</u>: Significant time was spent working with a new Developer, Atlantic Development & Investments. They <u>submitted an application</u> for a Zoning Map Change for a 28+ acre parcel (PAD to R2) in order to build and manage various multi-family housing. A large portion of this new development is planned to be developed under the LIHTC (Low-Income Housing Tax Credit) program and will be managed as rental homes. They are scheduled to present their request to the Planning and Zoning Commission on February 10th.

Planning staff also met with another new developer planning to build market rate homes on a large parcel off of State Route 260 in the area of 260/I-17 interchange. Expect to hear more on this project next month.


Town Council appointed Commissions to the three vacant seats on the Planning and Zoning Commission; Mike Hough (re-appointed), Robert Foreman (new appointment) and Ingrid Osses (new appointment). The Council also re-appointed two members of the Board of Adjustment and Appeals; Buck Buchanan and B J Davis.

The P & Z Commission met twice in January to hear the Town's Use Permit proposal to install an automated, 24-hour library branch in the Verde Lakes area. (First

presented to the Commission in January, but subsequently tabled. This is anticipated to return to P & Z in April with an alternative site/s.

The original proposal received significant pushback from residents, including a petition signed by 50+ persons objecting to the location recommended for the installation. It appears there is great favor for the project, but debate about the best location. The originally proposed

location is a Town owned lot which is located within the flood



The Board of Adjustments and Appeals also met and granted a Variance to Mr. Moscato who had applied for a zero-side-setback where his new property borders Holloman Street. The Variance was unanimously granted. The existing restaurant building (old Verde Café) already sits on the property line along Holloman due to the Town of Camp Verde acquiring the street front property along Holloman Street in 2012 in order to improve and develop street parking for the down-town area. Mr. Moscato is currently under construction and adding a new wine room at the rear of the restaurant which will be in-line with the existing building.

Staff met with property owners of a ~4 acre parcel who started grading and developing their lot this past summer (2021). They have been under a Stop-Work-Order and open Code Compliance case since last August. The owners contacted the Department seeking how they could close the case, mitigate the damages to the property and continue moving forward with developing and dividing this property. It was a very positive meeting and the Town Engineer and Building Official outlined the steps necessary to be completed by them, before they can move forward with their plans for this property.

A Use Permit for RRR Bed and Breakfast was administratively extended for 6-months to allow the owners time to submit the necessary building permits for the additional cabin for their property.




