Feb. 7, 2022 Statement from Chief Justice Robert M. Brutinel on the passing of Judge Rosa Mroz



PHOENIX – The Arizona Supreme Court and Arizona's judicial branch mourn the passing of Judge Rosa Mroz. Judge Mroz served our state since 2004, when she was appointed to the Maricopa County Superior Court. She was an outstanding jurist and rose to lead the Probate and Mental Health Department from 2010 to 2013 during a time of transition. She also served as a leader in improving the judicial system

statewide, serving on many commissions and committees. Most recently, Judge Mroz shared her Probate Court expertise by leading a committee to develop standards for the resolution of probate cases. She also served on the Supreme Court's committee to improve and regulate court interpreters. Rosa was hard-working, unfailingly collegial, and a good friend. We are grateful to Governor Ducey for recognizing Judge Mroz and her service to Arizona by ordering flags lowered to half-staff. The entire judicial branch offers its condolences to Judge Mroz's family during this difficult time. We will miss her.

Report from the Library Director: A big THANKS to Jeff Kobel,

Town of Camp Verde Maintenance Division Manager, for facilitating the installment of LED Stack lighting in the adult fiction area of the library. The lights are unobtrusive and shine directly on the book spines making it easier for patrons who have problems seeing in low light to read the labels. They dim down to 25% when no one is in the aisle and brighten up to 100% via motion sensors when a patron is browsing in the area. The light installment and replacement project started mid-February and is continuing through March. Connolly Electrical is doing the work and they have done a fantastic job cleaning up after themselves and communicating with library staff. After the stack lights are installed, they will work on replacing some of the ceiling lights with LED and install new lights in an area



that is too dark. This project is made possible by a State Grants in Aid Construction grant approved by Council in 2021.

Report from Volunteer Services: February kicked off our Computer and Technology classes; they will be held every other Saturday until May 21st focusing on a variety of topics for community members. The curriculum was determined by surveying various community members and by looking at the topics most asked for at our PC Help Desk. I hope to have another 8-block series of classes for the summer, although it will depend on our group of volunteer leaders and their schedules. Angi Grubbs and I continue to work with Volgistsics, the volunteer management program that I introduced, to create a more streamlined volunteer experience and for a more efficient use of the volunteer managers' time.

Report from the PC Helpdesk: Because of the Information and Technology classes starting in February, we have had an uptick in computer/phone questions. When I am working at the desk, I am constantly taking patrons through steps on how to do something or repair their own devices. It is nice to see the excitement about computers and the involvement of these patrons in learning something new.

Report from the Children's Library: In February we launched Storytime on a new day, at a new time, with library volunteers Ambie Charles and Randy Strickland. Ambie and Randy are popular and well-loved members of our community. Each has had the opportunity to read one of their favorite stories to the families in attendance in celebration of Library Lovers month. On the subject of favorite stories, we gathered favorite

book titles on paper hearts from children and guests to decorate our bulletin board. One child wrote that <u>Pete the Cat</u> is their favorite book series and stated, "I like the cat." Another child's favorite book is <u>Pig the Pug</u> and they exclaimed, "It's so much fun to read !!!!!!"

Thanks to support from the State Library, the Children's Library is adding 50 Wonderbooks, read-along books from Playaway. These include some of the most popular titles in picture books for children ensuring that children do not have to miss out on being read to. Wonderbooks have an audio portion



that reads the story aloud so children can enjoy reading stories without the assistance of an adult.

I had the opportunity to attend the Early Literacy Summit in Chandler, AZ with the theme "back to the basics." This gave me a chance to network with Children's Librarians from Cottonwood, Sedona, Prescott Valley, and Prescott. I believe it's important to attend these functions and network, to stay up to date on new information, and bring it back to our communities. I am grateful for the support from my supervisor for encouraging me in these opportunities for professional development.

I was also part of the Verde Valley Imagination Library fundraiser, which was held Sunday, February 6, 2022, at Blazin' M Ranch and was a huge success. Local businesses had the opportunity to donate to this incredible organization that provides books to children birth – 5 years in our own communities.

Report from Circulation: Prompted by a great idea from a circulation volunteer we set out a basket of notecards and pens so patrons could write notes to Nancy's family. We have received numerous notes to be included in a memory book in highlighting Nancy's impact at the library. Thank you, community for responding!

Report from the Teen Library: The last Monday in February I launched Maker Monday. While it is slow going, there has been quite a lot of interest in the program, so I'm hopeful that it will pick up as time goes on. Looking forward, library volunteer Kevin Karvinen, who runs our Dungeons and Dragons (DnD) program every other Saturday, and I will be attending the Verde Valley Comic Expo on March 26. We will promote Camp Verde Community Library's DnD program and game night, along with similar programs at Cottonwood Public Library and Sedona Public Library. For teens, children, and families playing games together requires reading skills and cognitive skills that they can practice in a fun and encouraging environment. Kevin and I will roll fresh

characters for people interested in the game but unsure where to start and will explain character classes, what different stats and abilities do, and the basics of the game to help people create the characters they want to play. This information will make the game as a whole seem less daunting to newcomers.

Report from CVARP: In the past month we have had 5 students under the age of 18 sign up to take classes with us. That gives us a total of 8 under 18. In the past 6 years, we have not had this many younger students. Last month Sergeant Douglas Sanders, from the Prescott Valley Military recruiting station, came into our office. The military is seeing a lot of potential recruits that are having trouble passing the ASVAB test which allows them entrance into the military. He asked us if we would be willing and able to tutor these candidates so they can pass this exam. Most of them are having trouble with the math and language sections. We told him we would, and our teacher Glenna is now working with these future recruits.



Camp Verde Community Library Observes National Library Lovers Month

This year we are honoring Nancy Raistrick, Library Lover Extraordinaire!

National Library Lover's Month each February is dedicated to people who love libraries because of the people and stories they encounter inside their walls. Camp Verde Community Library is especially grateful for the library lovers who volunteer their time, energy, and expertise to welcome and serve our community. Nancy Raistrick was one of those extraordinary volunteers. She started volunteering at the library over 12 years ago and would still be coming in 6 days a week if she hadn't been taken down by Covid-19.

Nancy showed up faithfully to the staff entrance Monday through Saturday around 8:30a. She didn't have a key so she would pound on the door and wait patiently until someone let her in. She brought the books in from the book drop, set up the computers at the front desk, and got ready to greet every library patron that walked through the front door. During her tenure as a Library Volunteer, Nancy could have easily checked in over 500,000 books with her own two hands. In addition to checking in the books, she helped clean, sort, and shelf them. She knew, that at the front desk, she was the face of the library, so she was unfailingly cheerful and friendly to everyone she encountered.

With an eye for detail and a curious mind always seeking to know the why behind any instruction, Nancy became adept at spotting items that were out of place, didn't belong, or had a mistake that needed correcting. Her affinity and love for crafting made her invaluable as well. Nancy used her technical and creative skills to mend library materials. During the 10 years that she mended broken or damaged library materials, she repaired over 11,500 items saving the library from discarding the items and incurring replacements costs.

As a Library Lover, Nancy was a natural advocate for library services and enjoyed teaching others how to use library resources. She knew the details about the children's programs, such as Storytime, STEAM Hour, and Movie Matinees; the teen programs, such as Game Night and Book Clubs; and the adult programs, such as Music in the Stacks, computer classes, and Health & Wellness programs. If someone had a question or needed help finding something, Nancy did not point the way. She walked with them to the computer or to the shelves and taught them how to find what they were looking for.

Nancy's family can tell you about the many other ways that Nancy influenced and delighted them, how she volunteered for the American Legion, and how much she meant to everyone who knew and loved her. We, at Camp Verde Community Library, can only say that Nancy is incredibly missed by all of us. Not just for what she did for us, but because her example inspired us and her presence blessed us. It is with profound respect that we dedicate National Library Lovers' Month, February 2022, to Nancy Raistrick, Volunteer Extraordinaire!

Additionally, staff have slowly started to move into the vacated Economic Development Office. The full move will mostly take place in March.




Update on the Library Use Permit for Verde Lakes: This project is on hold while library staff investigate alternative sites for its location.




