#### Report from the Library Director: We

decided it was time to update the library logo to coordinate with those used by Economic Development, Parks & Recreation, and Public Works.





A SHOUT OUT to Wendy for tackling technology upgrades and installs in ways she has never done before. Her expertise and enthusiasm for "all things tech" has been a huge asset to the library as well at the community.

Report from Adult Services: Nicole Metz-Andrews, the library's AmeriCorps VISTA worker, successfully implemented Computer and Information Literacy classes at the library to help bridge aspects of the digital divide. She completed a survey of community members to determine the need and put together a series of 8 classes. Each class is led by a volunteer. The first 4 classes have been an overwhelming success with around 20 participants in each. The final four classes run through May, with another 8-week block in the works for the summer. Cottonwood Public Library contacted us about emulating the program in the future.

Report from the PC Helpdesk: This month Kathy and I spent time getting Chromebooks, purchase with Emergency Connectivity Funding, ready for the public to checkout. Until this point, I was unaware of how involved Child Information Protection Act (CIPA) filtering is. I did as much research as I could to find a company that was both affordable and less complex. We found a company called Senso.cloud that has a very simple backend and has very helpful support staff. Lisa Lee, our Senso "guru" has helped me every step of the way. This month has been less about helping the patrons for me and more about getting the patrons devices into their hands so they can help themselves.

**Report from the Children's Library:** March brings the spring season, a much-awaited time for programs involving movement and activity. The Children's area is busy and productive as seen in Story time which continues to grow in attendance by both families and community volunteers. Each volunteer brings their own

personality and strengths adding a rich and diverse experience to the program. STEM+(A) Hour finished March 30th, completing a total of 28 weeks of programming with many families planning on returning in the fall when the program starts up again. Our Saturday programming (movies & crafts) also remains constant. The United Christian School came on a field trip to the library. The children enjoyed the library's tour and the book we read together in honor of World Water Day, We are Water Protectors, by Limstrong and Goade. I enjoyed training sponsored by the AZ State Library in Flagstaff in preparation of the upcoming Summer Reading Program where lots of ideas for programming and crafts were shared to assist libraries during such a busy time. Lastly, I attended the STEM Networking Lunch in Clarkdale where I was introduced to organizations that offer STEM programming in the Verde Valley.

**Report from Circulation:** Lose one, gain one: Saying goodbye to Randy M with many thanks for pitching in and helping out when we needed him most and saying, hello to Paul a new volunteer at the circulation desk.

**Report from the Teen Library**: In March, Game Nite continued to gain traction. Along with that Thursday night staple, I've added two more weekly programs.

- Monday nights are Maker Mondays, where teens learn through play and experimentation with circuits, using Makey Makeys, Little Bits, and Snap Circuits.
- Life Skills Enrichment Academic Program (LEAP) and is a collaboration involving Yavapai County Juvenile
  Probation and various community partners. Prior to the COVID shutdown, we partnered with LEAP and
  attendees learned how to make models in a 3D workspace (TinkerCad) that could then be used in 3D
  printing.

Volunteer Kevin Karvinen and I participated in the Verde Valley Comic Expo on March 19 at the Recreation Center in Cottonwood. We spent the day promoting CVCL's Dungeons and Dragons program, an all-ages game play, as well as Cottonwood Public Library's D&D program at both libraries.



### A Word from the Director

In March we celebrate reading with Read Across America! Started in 1998 by the National Education Association, the program focuses on motivating children and teens to read. Here are a few tools to help adult readers interact with and inspire the kids in their lives.

- read books with kids! Find free books to read, listen to, o r watch online
- help kids enjoy and relate to what they read! Check out these reading tips for parents
- visit the library for free books and resources right in your own community!

The Blazin' for Books 2022 fundraiser was a huge success. The event raised money for the Verde Valley Imagination Library (VVIL), an affiliate of the Dolly Parton Imagination Library. VVIL, a 501(c)3 nonprofit organization is run by volunteers who work to ensure that free books are available to children between birth and 5 years old in the Verde Valley. Last year the organization served 2,000 children with ageappropriate, high-quality, free books mailed directly to their home each month.

Thanks to Ms. Letty, Children's Library Specialist, CVCL is involved in VVIL's literacy work. ### **Directors Report for March 2022**

<u>Staffing & Office Expansion</u>: Interviews for the vacant Permit Technician occurred this month. An offer was made to an excellent candidate who will start in April. Office staff continue to re-organize, sort through old files and clean-out long stuffed cabinets, shelves and files.

The office is still awaiting final approval to cut a door into the wall between the two offices . . . so staff gets lots of "steps" on their pedometers as they walk back and forth between the two offices.

Staff and well as new Board of Adjustment and Planning & Zoning members attended the annual Ombudsman training regarding open meeting law sponsored by the Clerk's Office.

<u>Planning & Zoning (P&Z) Commission</u>: Two neighborhood meetings took place for property owners considering applying for a re-zone of their property. Alcantara Winery, one of those property owners, submitted for a re-zone of all 5 of their parcels to rezone from RR-2A and PAD to C2-PAD. This re-zone public hearing is likely to be on the May Planning and Zoning Commission Calendar.

<u>Board of Adjustment & Appeals (BOA)</u>: Canceled, no business in March, however, the office received an appeal application appealing the Town's position on feather/wind-blown signs being illegal within the Town. This public hearing will likely be on the May BOA calendar.

Pending (possible) Upcoming Projects: There is LOTS of interest in 'adding' or developing small RV parks throughout the Town. Several times a week (sometimes several times a day!) someone walks into the office or calls the office with questions centered upon what it would take to install RV sites on their parcel and develop a small RV park. Often, these are smaller parcels, 1/2 – 2 acre size parcels looking to add 2-5 RV sites on their property. To date, no one has followed through on starting the process, but interest *is very high* by property owners looking to generate income through people living or staying long-term in RV's on their property.

Development Standard Review is in progress for Tractor Supply Retail and one of the Marijuana Cultivation sites.

Additionally, the office was contacted by a new company planning to develop a new large marijuana cultivation site along State Route 260 in the area of Old Highway 279.

The office received preliminary information that Verizon is looking to co-locate on one of the existing cell-towers.




