



At the end of the 1st QTR, Town revenues are right on track with budget. State sales tax is very strong so far this year. While local TPT revenues are slightly off the mark by \$89K (1.3%) they are not short enough to cause any concern. Many items in the other Revenue category show-up in the 2nd half of the year.



Departmental expenses for the 1st QTR under budget by \$336K (3.2%) which completely offset the \$89K shortage of revenues. While Community Development is the highest percentage under budget at 7% under, the Marshal's Office provides the highest cash cushion at \$141K under budget, nearly 3-times that of Community Development. Only Parks & Rec is over budget through September which highlights a strong Fort Verde Days event in the 1st QTR.




