- **Work Session on Code Amendments** Community Development Department staff is working on three possible code amendments. These items are for preliminary discussion and direction only. These are listed separately below.
 - **6.a. Sign Ordinance Amendments** Possible changes to the sign ordinance primarily related to commercial signs. Amendments could include, but are not limited to, exemptions and prohibitions, definitions, and standards for both permanent and temporary signs.

- **6.b. Height Ordinance Amendment** Possible changes to the height ordinance to allow commercial buildings near the I-17/260 Interchange to exceed the current maximum height limit by an additional twenty (20') feet.
- **6.c. Right-to-farm ordinance** Possible addition of a Right to Farm Ordinance that will combine agriculture, ranching and animal numbers in one section of the Zoning Ordinance. References will also be added to reflect state law (Arizona Revised Statutes) sections related to agriculture.
- 7. Current Events Individual members of the Commission may provide brief summaries of current events and activities. These summaries are strictly for the purpose of informing the public of such events and activities. The Commission will take no discussion, consideration, or action on any such item, except that an individual Commission member may request an item be placed on a future agenda.
