FY23 Final Budget Changes from the Approved Tentative Budget

Total Budget Overview

- -State estimated revenues for Income tax and sales tax decreased \$37,955
- -Wages and ERE were impacted by adjustments to specific recommended merit increases and increases in workman's comp rates
- -Total adjustment to Wages and ERE is a \$49,951 decrease
- -Water Fund Capital Expenses were dropped \$4,000 to keep the Net Impact from budget a positive number
- -Total net change in estimated ending fund balances is an increase of \$15,996

General Fund:

Revenues

- -Urban Revenue Sharing decreased to updated State estimate Down \$21,775
- -State Sales Tax decreased to updated State estimate Down \$16,180

Wages

-Total Wages & ERE dropped \$61,091 after suggested Merit, COLA and Position changes

-General Government amount: \$220 decrease

-Municipal Court: \$3,040 decrease -Public Works: \$39,501 decrease

-Community Development: \$3,050 decrease

-Marshal's Office: \$9,535 decrease

-Library: \$5,215 increase

-Parks & Rec: \$12,960 decrease

HURF Fund:

Wages

-Total Wages & ERE dropped \$5,200 after suggested Merit, COLA and Position changes

Wastewater Fund:

Wages

-Total Wages & ERE increased \$9340 after suggested Merit, COLA and Position changes, including an \$18,500 increase to the Utility Director wages (\$9,250 of which, plus related ERE hit Wastewater)

Water Fund:

Wages

-Total Wages & ERE increased \$7,000 including an \$18,500 increase to the Utility Director wages (\$9,250 of which, plus related ERE hit Water) & a change in workman's camp rate that significantly reduced estimated costs.

Capital Expenses

-Capital expenses were reduced by \$4,000 to keep the Net Budget impact in Water positive
