

Background Information: The Town Council is considering options for hiring a new Town Manager. To allow time to identify a new Town Manager, the Town must retain an interim Town Manager. Interim Public Management ("IPM") has assisted other cities and towns (e.g., Phoenix, Glendale, Goodyear, Clarkdale and Sahuarita) in connection with hiring an interim manager and has entered into a cooperative purchase agreement for its services with the City of Phoenix.

Recommended Action (Motion): Move to ratify the Interim Public Management Retention Letter Agreement and authorize the expenditure of \$1,500 for the retainer fee.


