He filed May 12th and was recently informed the appeal has to be delayed because of errors made by the department. He has been working to resolve this over the last 6 months and there is still no date.

She announced that Yavapai Apache Nation received grant funding to develop two dictionaries, (1) Apache and (1) Yavapai.

Meeting that will be held in December. She would like to co-host with Yavapai Apache Nation.

Interim Manager Barbara Goodrich added updates regarding:

- 1. The Library has added a website link for public to look at upcoming displays/exhibits. They have also added a poll for the community to weigh in on library displays. The library has also completed the installation of their rainwater catchment system for their educational garden.

11. Discussion, Consideration, and Possible Appointment of Council members to serve as Town Representatives and alternates to the Northern Arizona Municipal Water Users Association (NAMWUA). Staff Resource: Barbara Goodrich

Interim Town Manager Barbara Goodrich explained NAMWUA represents a group of northern Arizona municipalities and private water providers that cooperate as a collective voice for water policy. NAMWUA's goal is to work cooperatively to develop a regional water supply. The other Arizona cities and Towns that are members include the following cities or Towns: Prescott, Chino Valley, Sedona, Cottonwood, Clarkdale, and Flagstaff. The meetings are held every other month and a zoom option is available.

Ms. Goodrich was notified NAMWUA had approached Mayor Jenkins, asking her to be the representative. Councilor Baker volunteered to be the alternate.

12. Discussion, Consideration, and Possible Appointment of Council members to serve as Town Representatives and alternates to the Reconsideration of Library Materials or Resources Committee. Staff Resource: Barbara Goodrich

Interim Town Manager Barbara Goodrich explained Camp Verde Community Library has a "Reconsideration of Library Materials or Resources Policy". This policy allows a library patron to submit a request for reconsideration of library materials or resources by completing a form and submitting it to the Librarian. The Librarian will review the form and make a determination within 30 days and provide the decision to the patron. Should the patron be dissatisfied with the decision made by the Librarian, the patron may request in writing to have the matter reviewed by a

committee. The review request must be received within fourteen (14) days after the patron receives the Librarian's decision and should include the basis of disagreement with the Librarian's decision. The committee members include voting and non-voting members. The voting members are the Library Director, Town Manager, and a Town Council member. Nonvoting members include the Recording Secretary and the Requestor (member of the community).

Councilor McPhail proposed Councilor Escoffier be the representative and volunteered herself as alternate.

13. Discussion, Consideration, and Possible Direction for Rehabilitation of the Town's Gazebo. Staff Resource: Martin Smith

Capital Improvements Manager Martin Smith reviewed history of gazebo. The wooden gazebo immediately south of the Public Works facility is experiencing structural instability. The support posts are deteriorating, diminishing their structural integrity. The gazebo now has a noticeable tilt to the northwest and has been deemed unsafe for inhabitation by the Town of Camp Verde Building Official. On Monday, June 19th the gazebo was officially condemned by the Building Official and Public Works staff secured the area with metal and plastic fencing. Staff has been in contact with officials administering the State of Arizona JOC contract to secure a scope of work and pricing for the rehabilitation of the gazebo. Four (4) options are currently being explored:

- Removal and replacement of the support posts per the approved plans and addressing electrical work that is out of code. \$0-Vendor chose not to bid this option because of safety concerns.
- Demolition of the gazebo and preserving the existing concrete foundation-bid comes in at \$67,500.
- Demolition of the gazebo and the concrete foundation, installing new sidewalk to connect the existing sidewalk on the west and east sides of the gazebo-bid comes in at \$79,880.
- Demolition of the gazebo and construct a new gazebo utilizing similar architectural appearances. Bid comes in at just under \$280,000.

Staff asks the Town Council for consideration of the four options and their associated costs and advise Staff for direction on which option is to be pursued.

Mr. Martin recommends option #3.

Council discussed the options and JOC. Vice Mayor Moore is concerned about local companies not being able to bid. Director of Public Works Ken Krebs stated the agreement with the local JOC ended in January and they are currently working on a new one. They are considering piggybacking with other Towns and their JOC.

Councilor McPhail suggests working this in two phases. The Town has \$42,000 in the budget. She suggests completing demo in Phase One and leave the slab until Phase 2.

Mayor Jenkins stated direction to staff is to go with Option #3, get rid of the sidewalk and get community feedback as to what they would want to do with this space. Also, go out and get more bids for a lower price and she would like to know where the funds will be coming from for anything over the budgeted amount.

14. Discussion, Consideration and Possible Approval of the FY24 Capital Improvement Plan. Staff Resource: Mike Showers and Barbara Goodrich

Interim Barbara Goodrich introduced the topic. Staff is available if Council has any specific questions.

Finance Manager Mike Showers explained there are only two changes from the document presented to Council on June 14th. A column was added labeled "App'd FY23 to highlight all projects previously approved by Council. Also, a new final park budget has replaced the three previous scenarios. This is only included to highlight what is budgeted for the proposed tentative budget. Council and staff will continue to develop it. Mr. Showers reviewed each fund and the totals in each fund. Mr. Showers explained how the budget works and why he budgets the way he does, specifically for grants.

Councilor McPhail would like to see quarterly and monthly updates.
