Mr. Marshall handed out a sheet with the responses they've received so far.

8. Presentation, discussion and review of the Camp Verde Recreation Association. (Resource Camp Verde Recreation Association Board member)

Parks & Recreation Manager Michael Marshall said the Camp Verde Recreation Association is a non-profit and is just getting started. Unfortunately, no representative from the Association was able to make it to the meeting.

9. Update on Parks & Recreation Commission's Quarterly Report to Council. (Staff Resource Michael Marshall)

Parks & Recreation Manager Michael Marshall handed out the Quarterly Report that will be presented to Council. This report updates Council on what Parks and Rec Commission has been doing.

10. Update on the Public Forum regarding the Sports Complex being held July 24, 2023. (Staff Resource Michael Marshall)

Parks & Recreation Manager Michael Marshall explained they are putting together the same type of Design Principal Plan and Conceptual Map of amenities as was done with Verde Lakes. They will bring the Commission the "Draft" version when it is complete. At that time Commissioners can give their input. The meeting will be held in Council Chambers at 6pm on Monday, July 24, 2023.

11. Update and discussion regarding the use of food trucks at the Sports Complex in lieu of a concession stand. (Staff Resource Michael Marshall)

Parks & Recreation Manager Michael Marshall said the concession stand has gone out for bid and bids are due back next week. He explained that youth groups and other nonprofit partners that we have would like to use the concession stand to make money, so replacing the concession stand with food trucks is not a realistic option. There are other events that would be more appropriate for food trucks. Mr. Marshall said the concession stand will not be a commercial kitchen and described what the concession stand would look like.

12. Update and discussion of possible US Tennis Construction Grant. (Staff Resource Michael Marshall)

Parks & Recreation Manager Michael Marshall updated the Commission after looking into this grant. He went over the processes and typical requirements when submitting for a grant. At this point, Council would like to finish the projects that have been budgeted for and started, before submitting for another grant.

Vice Chairman Faulkner has been enjoying the pool and wanted to say thank you. Commissioner Wade went to the Dewey Humbolt Library for a showing of 'Only the Brave'. Chairman Grondin mentioned there will be good music at the library July 15th.

DONATIONS

<u>PURPOSE</u>: To ensure that donations received by the Town are properly reviewed, accepted, accounted for and reported.

POLICIES/PROCEDURES:

GENERAL DONATIONS

Donations without direct guidance from the donor will be received into the General Fund as unrestricted monies.

II. RESTRICTED DONATIONS

- A. Donations that are restricted in form by the donor as to use or timing of use or any further conditions open the use of such monies must be approved by the Finance Director. Restricted Donations may be returned if it is determined by the Finance Director to be in the Town's best interest to do so. Donations of a de minimis amount or value (less than \$100.00) and for established designated functions do not require the Finance Director's approval.
- B. Employees of the Town may not impose their own restrictions on received donations. Only direct communication from the donor may restrict the use of a donation.
- C. The Finance Director shall be notified as soon as any restricted donations are received, pledged or expected.
- D. Restricted donations are not officially received and accepted until they are deposited by the Town.
- E. Restricted donations must be received with the following information in writing:
 - 1. Donor's Name
 - 2. Donor contact information
 - 3. Conditions of use

Without the above information, restricted donations shall not be deposited until the information is received.


F. Restricted donations shall be identified and tracked in the general ledger and reconciled on a quarterly basis.



Corn Fest 2023 Event Summary

General overview

- Event held July 15 on Hollamon St & adjacent Town grounds including the Gym
- Due to the Gazebo being condemned the event had more vendors on the field than usual and less shaded areas available between 200 & 300 buildings.
- Hollamon vehicle gate and fence was moved back 10' and the Redinger Ramada area added into event area.
- Public hours 11 am to 7 pm, staff 6:00 am to 8:15 pm plus Friday morning and evening.
- Secure event perimeter with staffed access gates & designated footprint for alcohol license.
- Attendance estimated at 4,500.
- Extremely hot weather reduced attendance and shortened average stay time to 30 minutes.
- Added extra evaporative coolers and large industrial fans
- Highest attendance between 10am and 1pm
- 63 vendors outside, 17 vendors inside with a few cancellations and no show due to heat.
- Town volunteers staffed access gates (2); CV Business Alliance provided staff for one entrance gate
- ACE Hardware supplied 2 pop up canopies for use as access gate keeper shade.
- AB Cornhole provided the corn hole tournament.
- We had two commercial vendors to roast and sell corn provided by P&R from Hauser & Hauser Farms. Town purchased 655 dozen ears of corn for all sales.
- Homemade salsa contest run by P&R with volunteer judges and prizes donated by local businesses.
- P&R Camp staff operated free Kids Activity Zone in Rm. 305 Noon 5pm

Non-Profit support

- 8 non-profit organizations provided free vendor space.
- Two non-profits provided fund raising opportunity by Town
 - Kiwanis Club of Camp Verde sold fresh corn raising \$1,012.
 - Town provided shade tent, tables, corn bags and banner as well as arranged to provide corn on site from Hauser & Hauser using trucks and staff to move.
 - CVHS Cheerleaders operated dunk tank for Town.
 - Town covered the cost \$253 to rent tank, set up, arranged for CCFMD to fill and drained and picked up after event.
 - More Than Self supports food for Guatemalan families
 - Raised over \$1,000 profit to feed families, our events are some of her best sales.
- Verde Valley Rangers raised an unknown amount with beer sales.

2024 Corn Fest Improvements/Ideas

- 1. Look at hours of operation evening or starting earlier maybe have O/N security and have all vendors set up the night before so we can start earlier
- 2. Improve our task list details to make sure that we get everything staged and set up as much as possible the days prior to the event.
- 3. Photo booth inside was a hit maybe add a large Photo Booth sign no wind or sun 😉



- 4. Set one of the wooden corn guys up in front of the fresh corn booth other at photo booth
- 5. Make sure that the Hauser Banner gets put on the fresh corn tent
- 6. Look at inside arrangement definitely need as much seating as possible in there. This year we had 16 vendors(one cancellation day of) and seating for 100. Could have fit a few more tables/seating if vendor booths moved a bit.
- 7. Get steps onto the field from the south side of the ramada to allow better flow
- 8. Have specific tasks or task list for volunteers for set-up and tear down.
- 9. Remember to put encouragement to highlight corn or VV agriculture products in the food and vendor sales items -make a corny sign for vendors who have those items
- 10. Order the Corn Fest fans like 2022
- 11. Have tarps in the beds of the trucks so the non-profits can just pull tarp to access corn towards the cab of the truck bed easier
- 12. Consider not having the dunk tank maybe something different dunk tank has not been super productive
- 13. Develop hashtags for FB and Instagram specific for event
- 14. Use Google forms for vendor survey/feedback. May also be beneficial to have a Google survey with QR code at the event to get public input specific to that event
- 15. Work on the street entrances and arrangement of the barricades. It just looks awkward and it was not clear where people were supposed to enter on either end of Hollamon.
- 16. Could we put misters/fans in ramada and music tent to help battle heat? The swamp coolers did not seem to work well this year.
- 17. Continue to work with VV Farmer's Market to increase their involvement
- 18. Should we look at larger music tent and different location for it? This would add more shaded seating, but with ramada, maybe not necessary.
- 19. Start the first 2 trucks in the morning with at least 100 dozen ears of corn.
- 20. Consider counting the corn that goes to the roasters not sure how to battle the large discrepancy in the corn count in 2023
- 21. It was a great idea to have Fire District there for emergencies probably good for all events
- 22. Remember to send Heather the food vendor list when it goes to the Health Dept.

- 23. Work on a way to improve the tracking of COI/Endorsement from vendors who need them access to the Town RM file would be beneficial for us to be able to see who has one on file already
- 24. Combine Food truck and Food vendor application in Eventeny so it is easier to know how many we have coming and easier to limit

Camp Verde Parks & Recreation Commission Quarterly Report July 2023

The P&R Commission (PRC) held its second meeting April 23 followed by Regular meetings May 1 and June 5. The June meeting also included a Work Session with a trip to Verde Lakes Community Park and the Sports Complex prior to the Regular meeting.

The Commission has focused on learning about their new roles and seeking information about various recreation and park activities and functions in the Town with presentations and discussion with P&R staff, Grounds staff and Public Works Director. The PRC members have discussed several options about their future role and requested information about existing policies and procedures.

The PRC has also talked about CIP projects and procedures related to parks and recreation and future options and requested information from staff for future plans. They have reviewed current projects including planning documents for Verde Lakes Community Park and others to provide input.

The PRC has discussed various topics including naming of parks and sites, requested that Parks & Rec create an on-line survey to send out for public feedback and discussed various potential projects moving forward including grant funding.

Parks & Recreation Monthly Report – July 2023

- Summer camp came to an end July 20th. We had 406 camper days in July in only 10 days of camp, that's just over 40 kids per day. Campers did field trips to the library, pool, and Dead Horse State Park. They had visits from the Old Guys, National Park Service, and the Tree Advisory Committee, along with many other activities. Thanks to generous donations from Kiwanis of Camp Verde, The Clif and Dee Jenkins Trust, and Quintus we are able to offer partial scholarships to many of our campers, lowering the cost of camp from \$20 per day to \$11 per day. We had 1204 camper days for the summer, with 120 different kids participating this summer, an average of 41.5 kids per day.
- Corn Fest was another successful event despite the blistering heat. We purchased 655 dozen ears of corn from Hauser that were sold fresh and roasted. Kiwanis of Camp Verde sold fresh corn and profited \$1,012 at the event. We had 84 vendors register for the event, with 80 vendors who did participate. According to the numbers in Placer ai, we had 4,500 attendees whose average stay time was about 30 minutes. Feedback from vendors and public has been positive and we have already created our list of improvements for next year.
- Staff continued to attend a variety of virtual forums including tournaments, aquatics, and special events to stay up on what is going on with other P&R Departments around the State.
- Scheduled facility uses this month were as follows: Meeting rooms had 74 uses, Ramadas were at 28 uses, Gym had 51 uses including being used by the Red Cross as an Emergency Evacuation shelter for the week of July 23rd, Sports fields had 77 uses, kitchen 16 uses, and public showers 26. Note that these numbers do not include summer camp use, they do use the gym, 204, and 305 daily during camp.
- Pickleball increased play to 4 times per week. A few of our partner instructors took a break for the summer but will return in the fall. Friday night Cornhole League continues, and we now have Nerf Wars in the gym on Monday evenings and on Community Center Field on Tuesday evenings in the dark. Staff is working with another Yoga instructor who will start classes in the fall, along with a potential martial arts instructor who is interested in offering classes here.
- Parks & Rec had 2 community trips this month. On July 7th, we went to Bearizona and on June 21st, we traveled to Arrowhead Mall. We had 14 people travel with us this month.
- Our third Diamondbacks trip was scheduled for July 30th. We had 13 people travel to the game with us. Registration is open for our last 2 games scheduled for August 27th and September 17th.
- Staff planned and hosted our 4th Downtown Food Truck Night on Thursday, July 20th. This event had 3 food trucks. We have begun marketing for the next one scheduled for August 17th and have made the decision to extend Food Truck Night through November 16th due to its' popularity.
- Staff is collaborating with the Library for a Dark Sky event in conjunction with our September 21st Food Truck Night.
- The new solar covers arrived for Heritage Pool July 20th and this completes the items for the pool CIP.
- Camp Verde Heritage Pool continued into the regular season. The third and final session of swim lessons are complete with 64 kids participating in July, bringing the total to 188 kids for the summer. The extended season schedule begins August 7th.

- Staff continue to work on the Verde Lakes Community Park improvements. The concrete cornhole boards and BBQ grills were delivered this month and are awaiting policy decision on placement.
- Parks & Rec applied for and was awarded a non-matching grant through AARP to construct a new
 picnic/party area at the pool. The paver installation has been completed and new fencing with a gate
 has been added to the area. The shade structure design was sent to an engineer and the initial design
 was not approved by Community Development. We are waiting for the design to be updated to meet
 wind requirements and then will be looking for a licensed contractor to install per Town code.
- Staff hosted a Regular session of the Parks & Recreation Commission this month and attended a joint Work Session with Council and the Commission on July 26th. Staff has continued to work with the Clerk's Office to learn how to create agendas and agenda packets, post them online, proofread and create final minutes, and learn how to run the computer system in Council Chambers for meetings. Staff posted the Public Notice regarding Corn Fest and the Public Meeting held July 24th and worked on the regular session agenda for the August 7th meeting.
- Staff participated in the Council meeting July 19th to give the Parks & Recreation Commission Quarterly report to Council.
- Staff continues the process of researching and earning accreditation through NRPA and the Commission for Accreditation of Park and Recreation Agencies.
- Staff hired 2 umpires for Adult Co-Ed softball.
- Staff conducted interviews with 8 applicants for the Rec Leader II position that will be open starting Aug. 4th. Four second interviews were conducted as well, and an offer was made.
- Staff worked 10 occurrences with a total of 131 hours for activities outside of regular business hours.
- Staff continues planning for Fort Verde Days, taking nominations and selected the Parade Grand Marshal and parade theme. There are 43 vendors already registered for the event.
- Shawna attended Verde Valley Leadership on July 14th. Mike was a guest speaker for VVL in July as well.
- Adult co-ed softball began June 28th with a record 14 teams playing this season. Games will be played through September at Butler Park.
- Staff had a meeting with Camp Verde Youth Football to discuss their NAYF Jamboree being held at the Sport Complex on Aug. 19th. This event will bring 28 youth football teams and their families to our community for a day of football.
- Staff hosted a Public Forum on July 24th. This forum was held to gather public input on future amenities at the Sports Complex.
- Staff met with organizers of a Walk For Water event planned at the Sports Complex Oct. 7th to go over details of the event and logistics.
