### **Introduction:**

Director John Knight opened the meeting at 5:35 P.M.

To begin the meeting, Ms. Mabery shared some thoughts with the work group. Her thoughts centered around the public outreach process, which led to a great deal of discussion amongst the group members. Transparency to the public is very important to the group.

She expressed her thanks to the group for their work thus far in this process.

### **The Ordinance Discussion centered around:**

- -Bees and the proper setbacks, if any.
- -Animal point chart and the proper categorizing of animals based on their size and nuisance.

- -Size of parcels and the points allowed for each. In which manner do you round parcel sizes, up or down?
- -Swine and the size of properties they are allowed on, to mitigate their nuisance. Additionally, youth permit for swine were discussed. How many permits should be allowed per family?
- -Dog breeding was discussed. It will not be part of this work group, but part of the comprehensive update.

# Work Group Decisions:

- -It was decided to not address bees in the ordinance.
- -In terms of rounding acreage, at this point, there will be no rounding, you must meet the minimum quarter acre.
- -It was decided to categorize animals in these categories to simplify the animal classifications –

Small Livestock Animals (or the like): goats, pygmy goats, sheep- 3 points Medium Livestock Animals (or the like): Miniature horses, llamas, ponies, ostriches, alpacas, emus, mini donkeys- 6 points

Large Livestock Animals (or the like): cattle, horses, deer, mules, donkeys- 12 points Extra Large Livestock Animals (or the like): Bison- 24 points

- -Corrientes, calves, and swine are still being decided on.
- Breeding pigs for 4h will be their own category.
- -The Work Group Site Tour date, time, and list of properties to view was solidified and set.
