Councilor Escoffier attended the Town Manager Candidate Meet and Greet, a US Marshall Academy Graduation in Georgia, and a Cheer Competition in Alabama.

Councilor Baker attended the AZ Office of Tourism Meeting.

Mayor Jenkins attended the Town Manager Candidate Meet and Greet, the AZ Fiber Festival, the Tree Sale, the Opening Ceremonies of Little League; she threw out the first softball pitch, the Wednesday, League Updates Meeting who gives updates on bills going through legislation, the Verde Valley Mayor and Manager Meeting, the Earth Day Celebration, and the Az Office of Tourism Meeting. 8. Public Hearing followed by discussion, consideration and possible approval of Ordinance 2024-A490, an ordinance of the Mayor and Common Council for a Zoning Map Change from RR-2A (Rural Residential; 2-acre minimum) to C2-4 (Commercial: General Sales and Service; 4,000 square foot lot size minimum) for approximately 23.34 acres, specifically described in Exhibit A (APN 403-20-007R), generally located on the North side of West State Route 260 and Horseshoe Bend Drive. Staff Resource: Community Development Director John Knight

Staff Comments

Community Development Director John Knight explained that at the March 20, 2024, Regular Meeting, the Council tabled this item to April 17, 2024. The purpose of tabling was to provide the applicant and property owner time to consider the possibility of a Development Agreement and/or a PAD. He went on to say the Council has 3 options: table this item to the July Meeting, approve the application or deny the application. Staff is recommending Council deny this item because they are not ready with a development agreement.

Public Comment:

Bill Tippett lives behind the property and is opposed to this item. The General Plan hopes to maintain the vistas and hillsides for the ascetics of the community. Considering there are already several RV Parks in the area a little bit of variety would help to maintain the Rural Character.

Applicant Comment

Mr. Rob Witt represents the Selna's and the Mongini's. He said he is frustrated and confused. He went through what he had done so far and said he had done everything that was asked of him. He just found out about this meeting and that staff is recommending denying the application. Councilor Godwin questioned if he withdraws his application does he have to wait a year to submit a new application.

Town Attorney Trish Stuhan wanted to clarify; the zoning ordinance normally has a restriction in submitting the same application again in a year. This would be different, there would not be a year bar for a Planned Area Development and Development Agreement to deal with deed restrictions.

Council Discussion

Councilor Escoffier has a hard time with this rezone without knowing what is going to be put in there. She would prefer to know what will be going in; see something with more details.

Vice Mayor Moore is frustrated about the communication problem. The Council does not want to operate like this; it is not the intention of the Council to put off the application. She felt it was the consensus of the Council at the last meeting that they were not comfortable with doing a straight Zoning Map Change. Her main concern is the neighborhood around it. She said the applicant could come back and reapply for a PAD and a Development Agreement which would allow them to move forward, or the applicant could withdraw the application. She wants to make sure everyone is communicating properly.

Council or Baker asked Mr. Witt, is there a developer interested in preparing a plan for Council so Council can make an informed decision regarding the property? The Council wants to work with developers that come into the community but Council needs all the information possible to make an informed decision. She also asked when they met with staff, after the items was tabled, were you told to take action and you feel like you have done that? Mr. Witt stated he has been trying to communicate to Council that the only thing that could be built there right now is 11 single family homes. He does not have a developer that wants to put in those homes. He feels that there has been no indication of what the Council wants in there. He went through the steps that he was asked to do.

Councilor McPhail said Council were pretty clear at the last meeting, they were not going to be satisfied with C2 across the property. The Council was also clear with having commercial along HWY 260 was a possibility. What was talked about two

weeks ago, was coming back looking at the whole property and diving it into areas that were appropriate for commercial and the areas that were appropriate for residential. The application before Council tonight is still to change everything to C2 across the property. The Council is not in agreement with that. She went through the available options. The applicant could pull the applicant and take all the time you need to determine which areas are appropriate for which type of development and come up with a conceptional plan of what those areas are. It doesn't have to have minute details. Or the Council can deny the application because Council will not approve it in its current state. Then the applicant could work with staff to put together a Development Agreement or a PAD. Councilor McPhail said Council wants to preserve the two Character Areas in that area. She suggests rescinding the application then work with the property owners to decide what areas you'd like to put the Commercial in and then work with staff to see how he needs you to show Council the plans and then come back.

Mr. Witt asked to table this item so he can let his clients know what is happening. He doesn't think he can make the decision without this. He voiced his frustration that he just found out about this meeting fifteen minutes ago.

Staff Comments

Community Development Director John Knight said this item was noticed as a public hearing in anticipation of the Development Agreement being approved prior to the approval of the Preliminary Plat. Public Hearing, discussion, consideration and possible approval of Ordinance 2024-A491 consideration, and possible approval of Ordinance 2024-A491 An Ordinance of the Mayor and Common Council of the Town of Camp Verde, Yavapai County, Arizona, approving a Zoning Map Change from M1-PAD (Industrial: General – Planned Area Development) to C2 (Commercial: General Sales and Service – Planned Area Development) for approximately 24 acres of APN 403-15-003W, specifically described in Exhibit A and generally located southwest of the intersection of Highway 260 and North Aultman Parkway. Staff Resource: Community Development Director John Knight.

Staff Comments

Community Development Director John Knight said this item was noticed as a public hearing in anticipation of the Development Agreement being approved before consideration of the rezone. Staff is still working out the details of the Development Agreement and needs additional time. Councilor Escoffier said this really shows how dedicated Council and staff is, in working with developers to help them get their projects through. It helps the Town to get a really good development agreement in place. She thanked the staff. No action taken.

Town Attorney Trish Stuhan said Council could go into Executive Session if you have questions, but you could also just approve the amendment in public session. She will type up a short agreement to extend the term. Ms. Mabery has said she is willing to negotiate a new agreement after the extension period if Council would like some remote or onsite support during the transition period. This agreement could be brought back at the next meeting.

Acting Town Manager Mabery spoke about the transition time, it's cleaner if the Acting Town Manager role ends when there is a new Town Manager. Her recommendation would be to execute a new contract.

Councilor Godwin would like to have Ms. Fisher's support and see how she feels about this. Ms. Mabery would recommend having the Town Manager execute the agreement.

Motion made by Vice Mayor Moore to approve an amendment to the Employment Agreement between the Town of Camp Verde and Gayle Mabery as Acting Town Manager, extending the termination date of the Agreement to May 27, 2024, and retaining all other provisions of the Agreement. Second was made by Councilor McPhail.
