## **CLERK'S DEPARTMENT**

## **Open Records Requests**

The Clerk's Office prepared a report of all the Open Records Requests received from July 2023 – June 2024 (see attached). The Clerk's Office did not receive any Records Request this week.

#### **Election**

Primary Ballots were mailed out on Wednesday, July 3, 2024. All ballot boxes in Yavapai County are open.

Several people have asked how many candidates will move to the General Election. The easy answer is "it all depends on what happens in the Primary". Arizona Revised Statues guides us in ARS 9-821.01.

For the purposes of this subsection, the majority of votes cast is determined by:

- 1. Calculating the total number of actual votes cast for all candidates for an office whose names were lawfully on the ballot for that office.
- 2. Dividing the sum reached pursuant to paragraph 1 of this subsection by the number of seats to be filled for the office.
- 3. Dividing the number reached pursuant to paragraph 2 of this subsection by two and rounding that number to the highest whole number.
- 4. If more candidates receive a majority of votes cast than there are seats to be filled for the office pursuant to subsection D of this section, from among those candidates who receive a majority of votes cast, the candidates who receive the highest number of votes equal to the number of seats to be filled for the office is declared elected to that office.
- 5. If at the primary election no candidate receives the majority of the votes cast or the number of seats to be filled for the office is more than the number of candidates who receive a majority of votes cast, of the candidates who did not receive a majority of votes cast, the number of candidates who advance to the general or runoff election is equal in number to twice the number of seats to be filled for the office and the candidates who received the highest number of votes for the office are the only candidates at the general or runoff election.

## **APS Substation Update**

APS has started installing some breakers and electrical equipment. The rebuild of some power lines has not been started yet. They still need to acquire a few easements but plan to energize overhead lines. They are still targeting project completion for the first quarter of 2025.

\*\*\* Fun fact\*\*\*: This substation will bring 40 megawatts of electricity to the area. A typical Walmart uses three megawatts of power, so this substation will produce enough power to equip more than 13 Walmart stores.

## LIBRARY

#### **Candidate Meet & Greet**

Library Director, Kathy Hellman and Library Manager, Nicole Metz-Andrews invite candidates and Council members to a Meet & Greet at the Library on Wednesday, July 10, 2024 from 7:00a to 8:30a in the 1st-Floor Terracotta Room. A tour of the library will commence at 7:15a followed by a Q&A in the meeting room. Coffee, tea, and light breakfast snacks will be provided.

#### **E-Rate Services**

At the end of June, the Library Director signed a 3-year agreement with the Yavapai County School Superintendent's office for consulting about and assistance with e-rate services. We have been using these services since 2016 at the same annual rate of \$1500, which has saved the library 70-85% off the cost of monthly internet access, security cameras, wireless access points, severs, and switches. Here are two examples: 1) In 2023 we received a quote of \$15,427 to upgrade 16 wireless access points and 4 switches at the library. We paid \$3,085 after the e-rate discount of \$12,342. 2) We pay less than \$300/month for ISP services. Our current discount is 74%, saving the Town \$823/month or about \$10,000/year.



A big THANK YOU to Library staff for spending the extra time needed to help a group of about a dozen girls from a local girl's boarding school get library cards and checkout books on June 29, 2024. The group came in 20 minutes before closing and it took 15 minutes past closing to get them what they needed and send them happily on their way. This is a great example of upholding our customer service standards and the Town Council's strategic vision. Kathy Hellman, Library Director, overheard a patron telling the group that they should leave and come back on another day when we are open later but that is not how WE do things. We are welcoming and willingly help those who come in minutes before we close with the same kindness as we exhibit when they come in minutes after we've opened.

## **COMMUNITY DEVELOPMENT**

#### **Code Enforcement**

Code Enforcement served its first set of Notice of Hearings and Complaints requiring those residents for non-compliance to appear in front of the Administrative Hearing Office scheduled for July 31, 2024, at 1:30 pm located at the Camp Verde Municipal Court.

## **Building**

Building Official, Roxanne Jasman, and Plan Reviewer, Chris Biggs, attended the AZBO (Arizona Building Officials) Annual Chapter Education Day. The subject of this year's training focused on significant changes to the IBC (International Building Code) between 2018 and 2024, for those interested in adopting the new 2024 code. They each earned .7 CEU's for their 7 hours of training.

## **Planning**

Next week, on Thursday, July 11, 2024, the Planning and Zoning Commission will consider two separate use permits for RV Parks. One is new and located at the end of Road Ranger Lane and the other is an existing park located on Arena del Loma called Green Valley Mobile Home Park. This will be a continued public hearing and the public is invited to attend and comment during the hearing. We are excited about the enhanced transparency, tracking, workflow, notification, and plan review features that this software will provide our department and the citizens of Camp Verde.

The Department held a "Meet and Greet" with council and mayor candidates on Tuesday, July 2, 2024. This was well attended by the candidates and allowed the candidates the opportunity to ask questions and better understand what's going on in the Dept. Staff shared a variety of resources at the meeting, which are attached.

## **PUBLIC WORKS**

This week, Ken Krebbs held meetings with the Community Development team on service improvements, attended a town safety meeting, and participated in Sports Complex/Public Works and directors meetings. At the NACOG session, TIP funding and the Year 26 project were discussed.

This week included trimming trees on Salt Mine Road. Additionally, pit holes were repaired on N. Oasis, Horseshoe Bend, and at the senior center.

This week included meetings on retention/detention plans, the Middle Verde Diversion, Sports Complex/Public Works, and Highview Plat 4. WIFA reimbursement paperwork was processed, and reviews for Feldmeier, Southwest Barricade, and Copper Canyon Venture were conducted.
