Tuesday, 8/18/2015

1:30 P.M. - Resolutions Committee: Good Discussions and comments All Resolutions presented PASSED. See Attached Document.

6:00 P.M. - APS Dinner - Opportunity to hear from leadership of APS. Also provided opportunity to network with council members and mayors from other communities.

Wednesday, 8/19/2015

9:00 A.M. - Opening General Session: Presenter Celestino Fernandez, Ph.D. This was an interesting presentation relating to the Declaration of Independence listing "unalienable rights" including the "pursuit of happiness". This presentation explored the use of thinking differently about leadership, civic engagement and the role of "happiness" in our service as civic leaders. People who are actively involved are happier and live longer than those that don't. He really made some good comparisons about being able to provide for volunteerism especially through 501 c 3 organizations.

1:30 P.M. – Fundamentals of Local Government – Public Service Ethics and Open Government. Great review of four basic guidelines for local government – Open Government, unbiased government, responsible government and efficient government; Open Meeting Law, conflict of interest laws, the Council-Manager form of government and the use of public monies. This was a great review of how our Town should run and be aware of legalities that confront us.

3:30 P.M. – Helping Arizona's Veteran Population: What Your City and Town Can Do. This was an excellent presentation utilizing a volunteer from the audience and having them put on part of the pack soldiers use during a combat excursion. It was interesting to see how the volunteer began to experience and react to the actual combat camera mounted on a soldier's helmet as he was with his squad and actually engaged the enemy. There is the opportunity of setting up a Veteran's Court System utilizing ex-military judges and attorneys in an effort for the court system to better understand the effects of PTSD on our returning soldiers and those who may find themselves running afoul of the law. I plan on doing a little more research with this to see if it might be something that could be utilized within the whole Verde Valley.

6:30 P.M. - Service Award Dinner: Recognition of elected officials and their years of service. Opportunity to network with other councils and mayors.

Thursday, 8/20/2015:

8:15 A.M. – Marijuana Legalization: It's Coming Our way, the Colorado Experience and How It Will Impact AZ Cities and Towns. This session was beneficial in that it give some of the history of how Colorado started, passed, and implemented its new law legalizing recreational use of marijuana. There was an examination of problems of implementation, and the actual funding and banking by lending institutions due to the fact it is still against Federal Law. This will be a topic coming soon to each of our towns and cities as it is being geared to be placed on the ballot in 2016. It is going to be interesting as law enforcement

begins to weigh in with what adverse effects marijuana may have on residents in Colorado. There are cities and towns who have banned the use and growing within their jurisdictions.

10:00 A.M. – Building and Maintaining Effective Mayor, Council and Manager Relationships. This was a panel discussion about how the Council-Manager form of Government has been established to provide the mechanism for small cities and towns to deliver the public policies which are necessary for their community's needs. The exploration of the relationship building of the manager and Council and bringing issues to the table for the entire council to be involved in clarifying the policy and setting policy. Excellent explanation of how the Manager is the CEO for the organization and executes the policies set by the council. It also underscored the need for the council to move forward from the decisions made by the whole council in order to build on the vision and goals which they set for their community.

12:00 NOON: - General Luncheon
Speaker Senator Jeff Flake

2:30 P.M. - League of Arizona Cities and Towns – How can we Better Serve You? Good session with some good ideas coming from the members in attendance. Our Council was well covered in this session. I went into the latter portion of the session on Railroads. This really was geared to those cities and towns with railroads within their borders.

4:30 P.M. Annual Business Meeting: Selection of Executive Officers was approved for the League and ratification of the Resolutions as passed by the Resolutions Committee.

Friday, 8/21/2015

8:00 A.M. - Speed Networking Breakfast for Municipal Officials.

Really very good session focusing on issues that various towns and city officials are experiencing and/or have experienced and have found solutions for them.

9:30 A.M. - Closing General Assembly

My thoughts on the League Conference

The first seminar I attended was the "Forest health and its Impact on Cities and Towns in Arizona". This went over familiar territory about the need for thinning our forests to prevent forest fires and protect our watersheds. I'm sure by now we all agree on the urgent need to get this done. Payson has been working for thirty years to protect and acquire a sustainable water supply and after all this time they have succeeded quite well. My biggest surprise was that the 4FI (four forest initiative) was not zooming forward as I had thought. It turns out that 70% of the material that is thinned out, the biomass, is unusable and creates a problem of what to do with it. If you burn it then it is pollution and you can't just let it sit. We need to find some productive way to market it. Presto logs, anybody?

Next up was "Social Media and Cities: The Pros and Cons of Instant Connection to Citizens"

Queen Creek uses Facebook extensively but there are many variation of social media like; Nextdoor, Snapchat, Twitter, Instagram, Vine, Youtube, and LinkedIn. If you google any of these I'm sure you can find out more details on them. One interesting thing I thought was that you still have to adhere to "Public Records Requests" and Open Meeting laws and maintain records.

During our appraisal process we discussed having a "Manager's Corner" in the local newspaper and after listening to the presentation I wondered if we could create this page using Facebook. We already have a Facebook account and it would be easy to have a page linked to our Town's Facebook page. The difficulty as I see it is getting word out to all our residents. This could be done by putting a news link front and center on our web page and monthly newsletter.

Nest morning I attended the "Marijuana Legalization: It's Coming Our Way, the Colorado Experience and How it Will Impact AZ Cities and Towns" This presentation focused and the problems that Colorado has had in implementing this law. How to determine impairment of drivers and in the workplace. The conflict between federal law and state law and the fact that it is still a cash business. The presenter didn't really state how much revenue was generated. Not all cities in Colorado have enacted Recreational Marijuana ordinances. The edibles has been especially hard to regulate but they have now established what quantities that can be sold thereby stopping the overdoses that happened in the beginning. There is a 2.9% sales tax and a 10% special tax and a 15% excise tax in Colorado. They have over 2 billion dollars in revenue. Near the end of the presentation an audience stated that the Arizona proposition has addressed all of the short-comings of the Colorado law and if passed here should be a much smoother process.

And before lunch was: "Great Ideas That Work: Current Innovative Programs and Solutions Being Utilized that Can Help Your City or Town" There were four main ideas presented at this

seminar; Crowd Funding, Leave a Legacy Project, Donation Bins, and Code of Ethics. *Crowd funding is of course the idea that small funds can add up and help a small business get a start. Often with a small share in the business or discount on the product. We have seen this type of funding with the Verde Brewing Company. *Buckeye has utilized the Leave a Legacy Project by getting sponsors to help fund a nature trail. You advertise that you can buy 14 miles of the trail with your name on it. Why can't Camp Verde do the same with our Community Park? A sponsor can have naming rights to a soccer or baseball field and we get the kids playing on it sooner. *Glendale has had problems with donations bins being put in fire lanes and other inappropriate areas and also not keeping them cleaned up. They have enacted ordinances to address this problem with penalties for non-compliance. So far, we don't have this problem but I think we could add some type of lattice fencing (moveable) around our recycle bins to make it look better. *The City of Maricopa mayor took office and immediately had to face issues of Code of Ethics violations by council members. They undertook to write and clarify the city codes as to what was proper and what was not. Then they defined a Censure and what the penalties could be. It could be loss of committee assignments, no travel allowance, a public apology for the inappropriate actions taken, or being forced to pay for the investigation. These are all written into the codes of the City of Maricopa. I think Mayor German is thinking of revisiting our own codes so some of their ideas may be helpful to us.

My last session that I attended was "Railroads: Their History in AZ and How Cities are Successfully Working With Them". Since we don't have a railroad I only attended the portion on the history which I liked since I enjoy history. Then I sat in on the League of Arizona Cities and Towns – How Can We Better Serve You? There was an interesting question and answer session and I stayed longer than I had thought I would. It is good to hear others problems and suggestions for improvement.

Overall, I think we get just as much out of the conference by networking (talking) with people from other cities in Arizona. Hearing their problems and solutions is very instructive to me. I thought by wearing the military uniform of the 1870's at the Parade of Flags Camp Verde got more recognition as being the home of Fort Verde. I try to promote our town as often as I can. Next year I would like to see us have a youth contingent and think our Library Teen Advisory Group might be interested. And next year Camp Verde really needs to have a booth at the Showcase of Cities. Something like the fort in the background and then take a photo to give to everyone.
