EXCESSIVE OR CRIMINAL SPEED VIOLATIONS in violation of A.R.S.28-701.02A1, A.R.S.28-701.02A2 and A.R.S. 28-701.02A3 are **NOT** eligible for Defensive Driving School and require an appearance before a Judge of this Court. **YOU MUST APPEAR ON YOUR COURT DATE or a WARRANT/SUSPENSION** may occur. Contact the Court if you have any questions.

INSURANCE VIOLATIONS -- ARS 28-4135(a)(b)(c)- MANDATORY MVD SUSPENSION & FINE

By pleading responsible and paying the fine, your license, registration and plates may be suspended by MVD for 3, 6, or 12 months, depending on your prior convictions. Contact the Court for more information.

NOTICE: Upon a conviction of **ARS§28-645(A) (3) (a) or ARS§28-647(1)** State law requires completion of Traffic Survival School if not eligible for defensive driving school (DDS). MVD administers the program and will provide written notification regarding the school. Traffic Survival School is **NOT** the same as DDS. YOU HAVE RECEIVED A TRAFFIC CITATION

Read this information before calling with questions.

1. This is your complaint number.
2. This is where you will find the offenses charged against you, listed by statute number.
3. This is where you will find whether a charge is a criminal offense or a civil offense.
4. **This is your appearance date and time. If you have a criminal offense charged, YOU MUST APPEAR in court at this time for your Arraignment or you must contact the Court for plea by mail options. Failure to do so may result in the issuance of a warrant for your arrest.**

IF YOU HAVE ONLY CIVIL TRAFFIC OFFENSES ON YOUR CITATION, THEN YOU MAY HAVE THREE OPTIONS -->

YOU MUST PICK ONE OPTION ON OR BEFORE THE APPEARANCE DATE SHOWN IN AREA "4" ABOVE.

**OPTION 1
 ATTEND DEFENSIVE DRIVING SCHOOL**

ELIGIBILITY REQUIREMENTS for Taking a Defensive Driving School (DDS):

-You have not attended a Defensive Driving course for an eligible traffic citation issued within the past 12 months. Your eligibility to attend a Defensive Driving Course is based on the date of your current violation not on the date you last attended a Defensive Driving Course.

-Your violation must be on the list of eligible violations (denoted on the fine schedule by an asterisk*)

- If eligible you can attend to have only one violation dismissed

- If you were involved in a serious injury accident or fatal accident you are not eligible.

-If you hold a commercial driver's license you are not eligible to attend DDS, regardless of whether or not you were driving commercially at the time of violation. There are some exceptions to this rule. For further information go to www.az.drive.com

-You must complete your course no later than 7 days prior to your court date. (Listed on your citation at Area "4.")

- You may take the course in person or online. If you were specifically ordered by a judge to attend the course in person, you must register for a class room course.

ENROLL IMMEDIATELY!

REQUIREMENTS FOR NON-ARIZONA RESIDENTS:

-Immediately contact an Arizona Certified Defensive Driving School.

-you may take an internet class

-you may return to AZ for the class

-you can attend a class in your home state ONLY if coordinated through an AZ Certified School.

-you must complete your course no later than 7 days prior to your court date.

**OPTION 2
 PLEAD RESPONSIBLE-
 PAY A FINE**

If you select this option, you are admitting responsibility for the violation(s). The Court will enter a judgment of responsible and will report the finding to the Motor Vehicle Division (MVD). Points will be assessed on your driving record for any moving violation (those violations marked with an asterisk (*) on the fine schedule.



For your convenience you can pay your fine(s) to the Court on ONLINE by visiting: www.AZCOURTPAY.COM (you will need your case number or citation number; which you can find as area #1 to your left). Or:

You may plead responsible by mail using the form on the reverse side, or in person. The amount of your fine, including fees and surcharges, should be listed on the Fine Schedule on the reverse side of this document. Find your charge (in Area "2") and pay the fine for that violation listed on the schedule. If your charge is not listed, call the Court.

If you wish to plead responsible for some violations, but not others, please be sure to circle the appropriate charge letter(s). Your fine may be paid by mail with a cashier's check or money order (**NO PERSONAL CHECKS**). Payments may also be made in person using a credit or debit card, convenience fees will apply.

DO NOT MAIL CASH. Make your money order payable to CAMP VERDE MUNICIPAL COURT. Be sure to write your complaint number (found at Area #1 on the citation) on your cashier's check or money order. **NO PERSONAL or BUSINESS CHECKS ARE ACCEPTED.**

**OPTION 3
 PLEAD NOT RESPONSIBLE-
 REQUEST A HEARING**

Use the form on the reverse side to request a civil traffic hearing. This request MUST be made no later than the date in Area "4." You will be notified by mail of the date for your hearing.

The purpose of the hearing is to contest the charge(s), NOT to admit them and request a reduced fine. If you are found responsible at the hearing, and wish to address the court about the fine you may request a time payment plan. A Time Payment fee of \$20.00 will be added to the total fees. PAYMENTS ARE DUE WITHIN 30 DAYS OF A PAYMENT CONTRACT GIVEN.

If you will have any exhibits (documents, photographs, etc.) you must bring the originals and two sets of copies (one set for the Judge and one for the police officer). The copies can be made by the Court before your hearing, but there is a charge of 50 cents per page for copies.

NOTE: Once you have requested a Civil Traffic Hearing, you no longer have the option of attending DDS (Option 1).
