Town Manager Russ Martin presented a plaque to the Council received from the U. S. Marine Corps Verde Valley Toys for Tots thanking the Town of Camp Verde and the City Council for supporting their Toys for Tots program last Christmas. Mr. Martin stated that over 200 children received Christmas presents from this program.

# 6. Call to the Public for Items not on the Agenda.

Robert Dodd presented a "hand-out" to each Council Member referencing problems with animal control and dogs at large. Councilor German requested that Mr. Dodd be present for Item 9 on this Agenda that is directly related to his concerns.

Robb Witt stated he had met with a land development consultant and requested input from the Council regarding possible land development projects in Camp Verde.

Robert Johnson, Verde Lakes, stated he had read an article regarding the San Pedro River in Southern Arizona regarding water conservation – advising the Council that they are putting in a "catch basin" in an attempt to save water and increase the aquifer levels.

 Discussion, consideration, and possible recommendation of approval for an extension of premises/patio permit for Barbara Goetting-White Hill Winery DBA The Horn, located at 348 Main Street, Camp Verde, Arizona. Staff Resource: Debbie Barber

On a <u>motion</u> by Councilor George, seconded by Councilor Gordon, the Council unanimously voted to approve the permit for an extension of premises for Barbara Goetting-White Hill Winery DBA The Horn.

Barber advised the Council that the request for permit was posted for the required 20 days; no comments were received. Barbara Goetting addressed the Council regarding the request for permit and potential benefits of granting the extension of premises permit and thanked the Council for previous support of her business(es).

## Public Input

There was no public input.

8. Update from Economic Development Director Steve Ayres relative to activities over the past year, along with proposed plans for the upcoming year. Staff Resource: Steve Ayres Council took no action on this item.

Economic Development Director Ayres addressed the Council with a presentation and update of completed/in progress projects and proposed future projects. Projects include: Hwy 260 corridor with construction to begin 2016 with completion projected for 2018; Verde Valley Medical Center campus that is scheduled to break ground early 2015; CV Visitor Center; VisitCampVerde.com website featuring Camp Verde's new brand for tourism; Special Events, noting that this would be transferred to Parks & Rec in the upcoming budget year; a copy of the Water Demand and Conservation Assessment Study by Western Resource will be provided to the Council with a presentation at the May 6 Council Meeting. Projects also include a Historic District; SelectCampVerde.com website; a proposed Economic Development Council; Partnership with Arizona State Parks; Verde Valley Archaeological Center opportunities and upgrades; NAU and Yavapai College education opportunities; Sustainable Economic Development. Proposed future projects include signage uniformity; Rocking River Ranch; Wingfield House Agriculture Museum; "Sense of Place" projects; Dollars and Sense:

Mr. Ayres submitted to the Council that investment in these Economic Development Projects were cost effective and benefit the community as well as producing a long-term, positive financial return for the Town, noting that with an investment of approximately \$118,000 investment, the Town received a return in excess of 6 million dollars.

9. At request of Councilor German: Discussion, consideration, and possible direction to staff to amend Town Code, Chapter 6 Animals, in its entirety.

Following public comment, the Council stated that the animal control, specifically leash law issues, was a priority and directed staff to present to the Council a draft of a revised/re-written Town Code, Chapter 6, Animals, for the Council's consideration at the May 7, 2014 Council regular session.

The Council, having previously discussed the current city code for animal control and the desire the have enforceable park rules with respect to control of domestic animals, the Council discussed having the entire Town Code Chapter 6 (Animals), being revised or re-written and presented to the Council for consideration and approval by May 7 or May 14 Work Session.

Councilor Gordon also stated that he had met with the Marshal and new Fire Chief.

Councilor George stated he attended a presentation by the Verde Valley Caregivers regarding VV Mobility that he would like to see presented to this Council regarding services, transportation, medical alerts, etc. for our seniors and disabled.

Mayor German also commented on the Colorado trip regarding clean-up and trail improvements, funding, and initiative for funding the Heritage Fund.
