On a motion by Vice Mayor Baker, seconded by Councilor Jones, the Council voted unanimously to approve the Consent Agenda as presented.

- 5. **Special Announcements and presentations.**
 - **Possible approval of Proclamation Declaring November as "American Diabetes Month".**
Mayor German declared November as "American Diabetes Month".

- 6. **Call to the Public for Items not on the Agenda.**
Wendy Davis spoke of her support for people who are mentally ill due to depression and how it causes hoarding

and other emotional behaviors. She encouraged Council to consider the people who are losing their homes.

Michael Wayne Dunigan asked for an internal investigation on Deputy Russell Grover, He advised that he spoke with Marshal Gardner and Russ Martin with no response to an incident in which he has an audio of Officer Grover coming to his home while he was off duty.

Irene Peoble let everyone know that there is a blood drive on December 9 from noon to 4 p.m. at the Verde Ranger Station on McCracken Lane and that it is Turkey Tuesday at Bashas' on November 26 from 7 am to 7 pm. You can buy a turkey to drop off for the food drive.

Mike Dunigan Sr. spoke in support of the issue his son had with Deputy Grover, stating that that Deputy Grover was raided several times by special crimes, noting that his roommate was taken in for selling drugs. Mr. Dunigan also stated that Deputy Grover has had a restraining order against him for stalking and harassing and nothing has ever been done about this behavior.

Debra Moody stated that she and many people in the audience were here in support of the Dunigan family.

Vice Mayor Baker ask that item 11 be moved up for discussion after item 6 as a consideration to the public.

7. **Public Hearing, followed by discussion, consideration, and possible approval of Resolution 2013-901, a Resolution for abandonment of roadway easement of approximately 685 feet just west of Arena Del Loma and Montezuma Castle Highway with authorization for the Mayor to sign the Abandonment and Dedication Plats.** Staff Resource: Russ Martin

On a motion by Baker, seconded by Gordon, the Council voted unanimously to approve Resolution 2013-901, a Resolution for abandonment of roadway easement of approximately 685 feet just west of Arena Del Loma and Montezuma Castle Highway with authorization for the Mayor to sign the Abandonment and Dedication Plats.

Manager Martin stated that this was an opportunity to do some right of way road clean up and that it was at the property owner's request. He advised that it will not affect the road, but will straighten out the documents to show that the right of way is not on private property.

8. **Discussion, consideration and possible approval of Resolution 2013-902, a Resolution of the Mayor and Common Council of the Town of Camp Verde, Arizona, approving and authorizing the abatement of dangerous structures located at 3155 Verde Lakes Drive (Parcel 404-13-254), and approving and authorizing the Town Manager to allocate any additional funds required and directing the building official to issue a start work order to demolish and remove the above referenced structures.** Staff Resource: Mike Jenkins and Robert Foreman.

On a motion by George, seconded by Baker, the Council voted unanimously to approve Resolution 2013-902, a Resolution of the Mayor and Common Council of the Town of Camp Verde, Arizona, approving and authorizing the abatement of dangerous structures located at 3155 Verde Lakes Drive (Parcel 404-13-254), and approving and authorizing the Town Manager to allocate any additional funds required and directing the building official to issue a start work order to demolish and remove the above referenced structures.

Building Official Robert Forman advised that he inspected the home and found several code violations on the property, noting that it was vacant at that time.

Baker asked if the owner was going to help with the cost of the demolition and Foreman stated they would try to make payments and that the Town would be putting a lien on the property for the cost. Baker expressed concerns about families being put out on the street and suggested that staff needed to work regionally get a group to refer these displaced people so that they are not homeless. She would said that she like to see Camp Verde take the lead in creating this effort.

Community Development Director Mike Jenkins stated that Code Enforcement Official Lisa Diacik had been asked to find ways to help these individuals.

Public Input

Candy Feltrop who used to live in that house said it was a financial hardship that caused the property to be in such poor condition. She asked that the Town be patient with them and give them time to remove personal items.

Wendy Davis said many people with hoarding or mental problems create their own fires and problems and we need to work with the guidance clinics and hotels to help them.

Debra Moody stated it is overwhelming to get a letter that you have 90 days vacate when you are mentally ill. She said that the very wording is horrifying and you have no clue what to do.

9. **Discussion, consideration, and possible approval of Resolution 2013-900, a Resolution of the Mayor and Common Council of the Town of Camp Verde, Arizona, approving and authorizing the abatement of dangerous structures located at 475 Groseta Drive (Parcel 403-23-086B), and approving and authorizing the Town Manager to allocate any additional funds required and directing the Building Official to issue a start work order to demolish and remove the above-referenced structures.** Staff Resource: Mike Jenkins and Robert Foreman

On a motion by Baker, seconded by George, the Council voted to approve Resolution 2013-900, a Resolution of the Mayor and Common Council of the Town of Camp Verde, Arizona, approving and authorizing the abatement of dangerous structures located at 475 Groseta Drive (Parcel 403-23-086B), and approving and authorizing the Town Manager to allocate any additional funds required and directing the Building Official to issue a start work order to demolish and remove the above-referenced structures. Mayor German, Vice Mayor Baker, Councilors Jones, German, Whatley and George voted aye with Councilor Gordon voting nay.

Foreman stated this property started as a code enforcement issue and upon inspection he found the property to be dangerous living conditions and inhabitable. The owners were given the maximum amount of time to repair the property and upon the second inspection, Foreman discovered the tenant had re-entered the home and was living there again. At that time, Foreman put a padlock on the door and secured the property so there could be no entry.

Public Input:

Alenka Galldin stated it would probably be easier to tear it down, but the owner would like to bring it up to code when she recovers. She asked if it would be possible for the structure to stay and requested to remove the mobile and retain the shed for storage not occupancy.

Debra Moody said many homes in Verde Lakes are also inhabitable and to please remember the mentally ill and poor.

Wendy Davis ask if there were options for composting toilets in this community and that she knows of 65 people per night in Cottonwood that are homeless.

10. **Discussion, consideration and possible approval of Ordinance 2013-A389, an Ordinance of the Town of Camp Verde, Yavapai County, Arizona amending Town Code, Section 11-1-6 Parks-Alcohol Use.** Staff Resource Russ Martin

A motion by Jones and seconded by Baker, to approve Ordinance 2013-A 389, an Ordinance of the Town of Camp Verde, Arizona, amending Town Code Section 100-1-6 Parks-Alcohol Use, to allow the sale of all spirituous alcohol, not limiting sales to beer and wine only, failed with Councilors German, Whatley, Gordon, and George voting no and Jones, Baker, and Mayor German voting aye.

On a motion by Councilor German and seconded by Whatley, the Council voted to approve Ordinance 2013-A389, an Ordinance of the Town of Camp Verde, Yavapai County, Arizona amending Town Code, Section 11-1-6 Park-Alcohol Use removing allowance of only 3 events and to include beer and wine only, pending attorney review. Aye votes were Mayor German, Vice Mayor Baker, Councilors Whatley, German, George and Gordon, with Councilor Jones voting nay.

Martin stated that removing the restriction of no more than three (3) alcohol permits per year does not mean that there can be alcohol on town facilities or the parks, noting that this is for special events only.

Jones said that alcohol is alcohol and felt that it should not be restricted to just beer or wine. Jones stated that if we are promoting economic development, we are also limiting the events by restricting sales to beer and wine.

11. Discussion, consideration, and possible approval of Ordinance 2013-A390, an Ordinance amending The Town Code, Section 3-1-1, 3-2-1, 3-2-4 relating to residency requirements of the Town Manager and Town Marshal. Staff Resource: Russ Martin

As a consideration to the public in attendance, this item was heard after item #6.

A motion by Whatley not to consider the options submitted by Councilor German after the agenda packet was prepared died for lack of a second.

On a motion by Vice Mayor Baker and seconded by Councilor German, the Council voted to approve Ordinance 2013-A390, amending the Town Code, Sections 3-1-1, 3-2-1, and 3-2-4 to read, Residency is required for the Town Manager and Town Marshal to live within the Town limits or 86322 zip code within 120 days of hire for all new hires from this point forward, and that the ordinance be brought back to Council after it has been reviewed by the attorney. Aye votes were Mayor German, Vice Mayor Baker, Councilor Jones and German, with nay votes from Councilors George, Gordon and Whatley.

Mayor German addressed the public as to why this issue was being discussed again, noting that this was action for future hires so that the Code would be very clear. Public Input was heard prior to Council discussion. There was a break at 7:18 p.m. The meeting was reconvened at 7:28 p.m. and Council took up their discussion after affirming that there was no further public input.

Martin advised that the Manager and Marshal believe in the Code and plan to enforce and live by the Code. He also advised that both he and Marshal Gardner are residents of the Town. He also stated that they intend to follow whatever Council decides. Martin advised that he was providing his professional advice to Council, not his personal feelings. He believed strongly that the Town could get quality candidates close to the area, but that adding restrictions might result in the loss of some very qualified candidates.

Gordon said he that he would like to remove all restrictions, noting that communication and technology are so advanced that residency should not be an issue in today's world. He asked Council to select the best and most educated based on performance, not residency. He said that he felt the arguments offered in favor of residency were shallow and superficial.

George reported that he did research on other towns in Arizona, noting that not all require residency within the Town limits. He showed a book about communism that his father had written in the 1960s and said that he felt it was unconstitutional to tell people where they have to live.

Jones stressed that this item was being brought back for future hires and that she was hoping for more options. She did not like the three that were presented; however, there was a section of one option that was acceptable.

Whatley stated that the information attached to the green sheet was brought after the agenda meeting and that Council had asked Mr. Martin for three options, which he provided, and now there were six options to consider. She felt strongly that the options submitted by Councilor German should not be considered because they were submitted too late.

Baker and Councilor German called a point of order. Barber explained that additional information, such as letters from the Council or the public are often received after the agenda packet is printed. This information is then attached to a green sheet so that Council knows that there is additional information relative to a certain agenda item. She added that in all fairness, Council members do not look at the agenda packet during Agenda Meetings, but only the agenda. She noted that Councilor German would not have been aware of the three options that Martin had provided because she did not have an agenda packet. Whatley disagreed and said that Council had set policy not to allow late items unless it was an emergency and there was no emergency. Mayor German said that he would not stifle the democratic process, noting that everyone has an opportunity to provide information and to speak.

Councilor German, reading from the minutes, noted that Council had not asked for only three options as stated by Councilor Whatley. She asked Martin what he had said to her when she asked to see his proposed options during the Agenda Meeting. Martin replied that he had told her that they were not ready yet. Councilor German said that they should have been ready because it was past the time that they were due for the agenda packet. She then covered her suggestions that included leaving the Code as it is; changing the Code to require residency within 120 days of hire with no exceptions; or requiring residency in 86322 zip code within 120 days of hire with no exceptions; and residency requirements for all department heads. She said that she put the third option in because of Whatley's suggestion at the last meeting.

Mayor German, Vice Mayor Baker, and Councilors Jones and German felt that residency should be required of the Manager and Marshal. They also felt that they were representing the concerns of the many citizens who had commented and written letters about the importance of the two top officials residing in Camp Verde. Baker noted that the 'choice' lies with the applicant when they accept the job – if they do not like the residency requirement, they can refuse the job. Referring to the Town Manager as an applicant, Baker advised that the Town gets plenty of qualified applicants every time a position is advertised. She said that no one is being forced to live in Camp Verde.

Councilors George, Gordon, and Whatley felt strongly that the Council should not tell people where they could live because this was an infringement on their personal rights.

Public input:

Danny Parker, Jim Meredith, James McDonald, John White, Jeffery Sordal, Arlene Atkinson, Mike Dunigan Sr., Fred Hauk, Bob Johnson, Cheri Wischmeyer, David Willey, Terry Andrews, TJ O'Malleu and Warren Harris spoke in favor of leaving the Town Code as it is, and some suggested that the department heads should also have their residency in Camp Verde.

Jim Ash, Murray Lichty, and Helen Zimmerli felt that people should have a right to live where they want and that as long as they are doing a good job, their residency should not be an issue.

12. Call to the Public for items not on the agenda

Murray Lichty stated we have a problem with Economic Development in Camp Verde, noting that Jerome is no longer a ghost town, but Camp Verde is. He also stated that we need lighting in the downtown area and lighted signs for businesses.

13. **Council Informational Reports.**

Councilor German reported that she attended a Board of Supervisor's meeting in which the SR 260 IGA was discussed.

Councilor Whatley attended the Verde Valley Land Preservation Open House.

Councilor George attended the Verde Valley Land Preservation Open House, the CDBG public hearing, Verde River Basin Partnership and CYHWRMS meetings.

AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL
OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA,
AMENDING TOWN CODE SECTION 11-1-6 PARKS – ALCOHOL USE

TOWN CODE, SECTION 11-1-6 is hereby amended as follows:

Section 11-1-6 Parks - Alcohol Use (2000-A162) (2009-A367) (2009-A369) ~~(2011-A375)~~ (A2013-389)

Definitions: "Public Recreation Area" shall include a Town park, district or regional parks, riverfront parks, or areas so designated by the Town Council of the Town Hall complex, such as the adjoining sports fields, parking lots, or gymnasium, or other Town property.

Prohibition on Alcohol Use. It is unlawful for any person to consume, possess, give, or sell any alcoholic beverage within the boundaries of any public recreation area or on Town-owned property within the Town limits, or in a public thoroughfare, except that persons may sell, purchase, or consume beer and/or wine by permit from the Town. The Council ~~may approve no more than three (3) alcohol permits on Town property in a fiscal year at the following events only: Fort Verde Days (beer only), Corn Festival (beer only), and Pecan, Wine & Antique Festival (wine only).~~ may approve no more than three (3) alcohol permits on Town property in a fiscal year at the following events only: Fort Verde Days (beer only), Corn Festival (beer only), and Pecan, Wine & Antique Festival (wine only). **SHALL DETERMINE AND APPROVE ALL EVENTS AT WHICH BEER AND WINE/ALCOHOL IS/ARE TO BE SOLD.** A special event license from the Arizona Department of Liquor Control is required and procedures are outlined in the Town of Camp Verde Procedures and Operations Guide, Special Event Permitting Procedures and Handbook. The permit will specify the area and other conditions of use.

- A) Proof of alcohol training from Arizona Department of Liquor Control is required as a condition of the permit.
- B) Signs will be posting stating that no one appearing to be intoxicated will be served
- C) "LAST CALL" promotions are strictly prohibited.
- C/D) INSURANCE IS REQUIRED PURSUANT TO THE TOWN OF CAMP VERDE SPECIAL EVENTS PERMITTING AND PROCEDURES HANDBOOK.

Permit Procedures. ~~The Town Manager~~ TOWN COUNCIL will establish permit procedures under this ordinance, ~~except that the Town Council may~~ **AND SHALL** by motion or resolution determine which events ~~sponsored by the Town~~ will have beer **AND/OR WINE** sold under a Town special event license. SPONSORS OF ALL SUCH EVENTS WHERE BEER AND/OR WINE ARE CONSUMED MUST COMPLETE A PERMIT APPLICATION AND FOLLOW ALL PROCEDURES AS OUTLINED IN THE TOWN OF CAMP VERDE SPECIAL EVENT PERMITTING AND PROCEDURES HANDBOOK AND PROVIDE INSURANCE AS REQUIRED BY THE EVENT PERMITTING AND PROCEDURES HANDBOOK.

Violations and Penalties. Violation of this [section] ordinance is declared to be a Class 1 misdemeanor, punishable by fines up to \$2,500 and 6 months in jail or to the limits as may be amended by State law.

Posting. Signs shall be posted in all public recreation areas warning the public of the provisions of this ordinance.

Effective Date. This Ordinance is to be effective when publication and posting pursuant to A.R.S. § 9-813 is accomplished.

THE RESIDENCY REQUIREMENT FOR THE TOWN MANAGER IS SET FORTH IN SECTION 3-2-1 OF THE TOWN CODE, AND RESIDENCY REQUIREMENT FOR THE TOWN MARSHAL IS SET FORTH IN SECTION 3-2-4 OF THE TOWN CODE.

AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL
OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA,
AMENDING TOWN CODE SECTION 3-2-1.C TOWN MANAGER – RESIDENCY

TOWN CODE, SECTIONS 3-2-1.C IS HEREBY AMENDED AS FOLLOWS:

SECTION 3-2-1 TOWN MANAGER (2000-A160) (2001-A211) (2008-A355)

- A. Office Established. The office of Town Manager is hereby established.
- B. Appointment of Town Manager. The Town Manager shall be appointed by majority vote of the Council on the basis of executive and administrative ability and shall hold office at the pleasure of the Council.
- C. Eligibility. No member of the Council, their spouse or relatives to the first degree shall be eligible for appointment as Town Manager until one year has elapsed after such Council member shall have ceased to be a member of the Council. PRIOR TO JANUARY 2014, The Town Manager shall be a resident of the Town, unless such requirement is waived by the Council. AFTER JANUARY 2014, THE TOWN MANAGER IS REQUIRED TO ESTABLISH RESIDENCY WITHIN THE TOWN LIMITS OF THE TOWN OF CAMP VERDE OR THE 86322 ZIP CODE AREA WITHIN 120 DAYS OF THE DATE OF HIRE. THERE ARE NO EXCEPTIONS TO THIS REQUIREMENT.
- D. Powers and Duties of Town Manager. The Town Manager is the administrative head of the government of the Town under the direction and control of the Council, except as otherwise provided in this Article. He shall be responsible for the efficient administration of all the affairs of the Town that are under his control. In addition to his general powers as administrative head and not as a limitation thereon, it shall be his duty and he shall have the following powers:
1. Law Enforcement. To see that all laws and ordinances of the Town and all franchises, contracts, permits, and privileges granted by the Council are faithfully observed and to report any failure in that regard to the Council. The Council shall then give such instruction and direction as it may desire for remedial, corrective or terminating action by the Manager.
 2. Authority Over Employees. To control, order and give direction to all heads of departments (other than Council-appointed officers) and to subordinate officers and employees of the Town under his jurisdiction through their department heads.
 3. Power of Appointment and Removal. To appoint, remove, promote, and demote any and all officers and employees of the Town, except the Town Attorney and the Town Magistrate, all of whom shall be appointed by the Council. As to these officers, he shall recommend appointment and removal to the Council. All such actions of the Manager shall be subject to all applicable personnel ordinances, rules and regulations, and state statutes.
 4. Administrative Reorganization of Offices. To conduct studies and effect such administrative reorganization of offices, positions, or units under his direction as may be indicated in the interest of efficient, effective, and economical conduct of the Town's business.
 5. Ordinances. To recommend to the Council for adoption such measures and ordinances as he deems necessary.
 6. Attendance at Council Meetings. To attend all meetings of the Council unless the Mayor excuses him individually or unless the Council excuses him, except when his removal is under consideration, in which case the Town Manager's attendance at a meeting shall be governed by the Arizona Open Meeting Law (A.R.S. § 38-431 *et seq.*, as may be amended). He may present recommendations relative to each item on the agenda for approval, rejection, or modification by the Council, and prepare the agenda as provided in Section 2-3-6.A.

7. **Financial Reports.** To keep the Council at all times fully advised as to the financial condition and needs of the Town.
8. **Budget.** To prepare and submit a proposed annual budget and a proposed annual salary plan to the Council.
9. **Investigations and Complaints.** To make investigations into the affairs of the Town and performance of any obligations of the Town and to report all findings to the Council. Further, it shall be the duty of the manager to investigate all complaints in relation to matters concerning the administration of the Town government. If the investigation involves the conduct of a person reporting directly to the Council (the Town Manager or Town Attorney) the Mayor and Vice-Mayor shall designate a person to conduct the investigation. If the Mayor and Vice Mayor cannot agree on such designation, the matter shall be referred to the Council.
10. **Public Buildings.** To exercise general supervision over all public buildings, parks, and other public property under the control and jurisdiction of the Council.
11. **Additional Duties.** To perform such other duties as may be required by the Council, not inconsistent with federal law, state law, or Town ordinances.
12. **Salary Schedule.** To recommend to the Council, a standard schedule of pay for each appointive office and position in Town service, including minimum, intermediate and maximum rates. To authorize the payment of overtime pay for such employees as may work in excess of a normal work period. Such rates of pay and periods of work shall be in conformity with rates and salaries enacted by the Council.
13. **Documents.** To sign contracts for budgeted items and other documents that are necessary to conduct the business and affairs of the Town per the Town Policy and Operations Guide.

E. Internal Relations.

1. **Council-Manager Relations.** The Council and its members shall deal with the administrative services of the Town only through the Town Manager, except for the purpose of inquiry, and neither the Council, nor any member thereof shall give orders or instructions to any subordinates of the Town Manager. The Town Manager shall take his orders and instructions from the Council only when sitting in a duly convened meeting of the Council, and no individual Council member shall give orders or instructions to the Town Manager.

F. Attendance at Commission Meetings. The Town Manager may attend any and all meetings of the planning and zoning commission and all other commissions, boards or committees created by the Council. He shall cooperate to the fullest extent possible with the members of all commissions, boards, or committees appointed by the Council.

G. Other Departments. The Town Manager may, with the concurrence of the Council, establish other departments (in addition to the departments set forth in this Code) to conduct the business and affairs of the Town.

H. Before appointing a person to fill the positions of Town Clerk, Town Marshal, Director of Public Works/Town Engineer or any other department head position, the Town Manager shall solicit input from no more than three persons serving on the Council.

Violations and Penalties. Violation of this [section] ordinance is declared to be a Class 1 misdemeanor, punishable by fines up to \$2,500 and 6 months in jail or to the limits as may be amended by State law.

Effective Date. This Ordinance is to be effective when publication and posting pursuant to A.R.S. § 9-813 is accomplished.

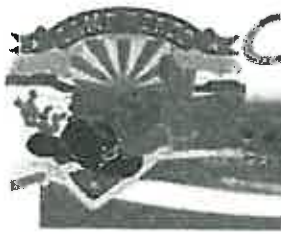

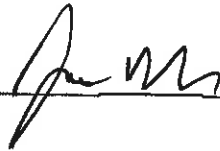

Comments: The annual repayment cost will not impact the approved budget as WIFA requires that the original loan amount of \$5,600,000 is amortized regardless of the outstanding loan amount.

Background Information: In November, 2008, taxpayers approved a loan from WIFA in the amount of \$5,600,000. Of this \$5,600,000 an amount of \$2,701,004 was used for the completion of the new wastewater treatment plant. An additional \$1,918,180 was used to pay off the original Koch loan and refinance with WIFA. The remainder of \$980,815 was intended to carry out upgrades/repairs to the treatment plant that are required under the APP and to complete much needed facilities at the plant site. Staff is requesting authorization to expend the remaining loan funds at this time because of the APP requirements and recent notification from WIFA that the \$980,815 will be withdrawn if not utilized.

The required additions or repairs include:

- **Purchase and Installation of Tertiary Filtration Unit(s)** still being selected - \$461,001. The original design of the wastewater treatment facility specified tertiary filtration, which has not yet been installed causing inconsistent effluent quality which influences the performance, service, and life of ultraviolet disinfection unit and parts. Particles in the non-filtered effluent are baked onto the ultraviolet bulb sleeves rendering them ineffective. Due to the ultraviolet not working at full performance because of non-filtered effluents, chlorine disinfection has been required full-time throughout the life of the facility. The current cost of chlorine is approximately \$1500 per month. It is estimated that if tertiary filtration is installed and used, that chlorine use will drop to only algae removal for a 75% reduction in disinfection costs.
- **Repair or Replacement of the existing Ultraviolet Disinfection Unit** - \$85,000. The existing ultraviolet disinfection unit is not working correctly with fluctuations in treated effluent flow. This existing unit is a sealed vessel type disinfection system and is difficult to service or repair. Due to the existing unit working at full strength (intensity) during low flow conditions, impurities in the effluent are baked onto quartz sleeves over the ultraviolet bulbs causing them to be replaced more often than normal costing thousands of extra dollars annually. The existing unit is being studied to see if the control panel can be replaced or reconditioned to correspond operation with fluctuations in effluent flow. If the existing unit and/or control panel cannot be modified to operate properly with flow fluctuations, it may need to be replaced with a more readily serviceable and operable "bank" style unit that is simply lowered into a flow stream channel.
- **Installation of an Influent Grinder Pump and Rock Trap** at the Septage Hauling Station – \$25,814. Currently the Septage hauling station has no means to assure that pump-damaging large items such as rocks are not ground up or removed prior to those items damaging expensive lift pumps in the treatment plant. This grinder pump and rock trap will guarantee that all items hauled in with the Septage will be ground to a size that will not harm pumps and other equipment.
- **Construction of a Headworks Replacement** to Include Main Fine Screen Channel and a Bar-Screen Diversion Channel - \$84,000. The current headworks at the treatment plant is a raised box style that completely encloses the fine screen unit and makes it almost unserviceable. The box on this existing unit has begun to severely fail (leak) due to corrosion from being an enclosed unit. The fine screen has failed and no longer operates properly and cannot be repaired because the current headworks was not provided with a required flow diversion in order to divert influent flow around the headworks so that the fine screen unit could be repaired. The proposed replacement would be more conventional and place the existing repaired fine screen unit in a main flow channel that is paralleled by a diversion channel outfitted with a manual bar screen. This would allow full open and dry access to the fine screen unit with all flows being diverted around it through the other channel.
- **Construction of Sludge Drying Beds** with Under-slabs and Under-drains - \$205,000. The construction of sludge drying beds would allow de-watering of sludge on site in order to not haul 80% water and 20% sludge and would save approximately 75% on hauling and dumping/disposal fees.
- **Construction of a 40' x 60' Metal Shop** and Equipment/Parts Storage Building - \$110,000. Important and expensive equipment and parts need to be stored on site at the wastewater treatment plant. These items cannot be stored outside without them degrading from the sun and weather. An adequately sized storage building is required. Currently there is no accommodations at the wastewater plant to service or repair

equipment in an enclosed environment and equipment must be worked on outside on the ground and in the weather. A shop area is required to service and repair equipment.

- **Install Dissolved Oxygen (DO) Probe** - \$10,000. This probe is required to regulate treatment process air on the north side of the treatment facility. The south side is equipped with this type of sensor probe already, but the north side is not and requires it for standard operation.

***Note:** the above amounts are engineer estimates; staff will obtain current quotes and/or bids for each improvement as listed; the total improvements will not exceed \$980,815 (all procurement procedures will be followed).*

***Recommended Action (Motion):** Move to authorize staff to utilize the remaining loan funds from the Water Infrastructure Finance Authority (WIFA), not to exceed \$980,815, in order to complete needed improvements at the wastewater treatment facility as required under the Aquifer Protection Permit (APP) issued by Arizona Department of Environmental Quality (ADEQ).*

Additional comments, if any, will come under separate cover. "It has always been and continues to be his concern that public monies are spent in a way that meets the criteria of the "Gift Clause". This is intended to ensure that public monies are spent for public purposes. That being said many communities in the state share accommodations tax with the local visitor bureau and/or the local Chamber of Commerce, many through a professional services agreement to ensure return on use of the public dollar is shown."
- Finance Department:** Not budgeted, Contingency is the best option as other lines through budgeting have been utilized or planned prior to this discussion.

Background Information: The Chamber had requested \$12,000 so that they can earnestly hire someone to do membership services to a level that would support the Chamber without the future assistance of the Town. Since then Tom Pitts who has had a history of being able to get Chambers working again (per attachments) has been engaged by the Chamber of Commerce Board to work to find a way to move them forward. Staff has had a couple of conversations mostly of historic nature and to relay the request from Council that the Chamber consider a future plan. Attached is an update version of their request as well as a contract to engage the

Chamber. The Chamber has stated it is a critical time for them and this request could not wait any longer. Staff would like the opportunity to discuss the complete financial picture that includes potential delay of other budgeted items before Council would agree to any other financial commitments.

Recommended Action (Motion):

Move to deny the Chamber of Commerce request at this time due to budget constraints that Council has yet to review for the second half of the fiscal year and suggest the Chamber of Commerce consider a formal request in the spring prior to budget discussion or following this discussion in late January.

CAMP VERDE CHAMBER

OUTLINE: DEVELOPMENT PLAN

December 11, 2013

A major reorganization of the Camp Verde Chamber of Commerce, Inc., is called for to revitalize the Chamber and to allow it to take its place in helping to promote and develop the community's business potential. The current leadership has worked hard to maintain a skeletal structure upon which a full Chamber can be built, but much work needs to be done. The entire vision and mission of the organization must be properly implemented with a broad-based membership base of support to move forward effectively. The Chamber has approached Tom Pitts, well known in the region for his success with such projects, to develop and implement the planned re-development. Among the tasks at hand:

- Identify, locate, and meet with all current Chamber members to catalogue and quantify immediate needs and to identify and understand past successes and key failures.
- Identify and meet with other stakeholders in the Camp Verde business community to identify their needs and desires going forward.
- Survey those members and stakeholders and seek their direction regarding setting priorities for short term organizational development and to identify the tools that are currently available to be utilized to accomplish those goals while developing a long term plan.
- Identify former and potential new members, with a particular eye toward identifying peer group leaders within various business interest areas.
- Develop a value-added approach regarding membership and membership recruitment that will appeal to specific business interests. In other words, develop and prepare to deliver tools that will call attention to and help to increase business volume and create more jobs in and around Camp Verde that will benefit our stakeholders.
- Meet with Town Council and appropriate Town staff to coordinate efforts to promote civic, commercial, tourist, industrial, and agricultural interests in the community for the best interests of the entire Camp Verde community.
- Market and promote the goods and services that are available in Camp Verde and call attention to the special nature of the community, its location, its assets, its lifestyle, and its value.
- Utilize the reach of regional partnerships to amplify our message and to promote our business interests to visitors throughout the entire region.
- Raise our profile on a local, regional, state, national, and international level to attract our targeted visitor audience to enjoy what we have to offer and to support the Camp Verde way of life.

**Agreement for Contracted Services
Between
The Town of Camp Verde, Arizona,
and the
Camp Verde Chamber of Commerce, Inc.**

This Agreement for Contracted Services (“Agreement”) is entered into this ____ day of December, 2013 (“Effective Date”) by and between the Camp Verde Chamber of Commerce, Inc., an Arizona non-profit corporation, hereinafter referred to as “CHAMBER” and the Town of Camp Verde, an Arizona municipal corporation, hereinafter referred to as “TOWN.”

WHEREAS, pursuant to A.R.S,§ 9-500.11, the TOWN desires to appropriate funds to promote the economic welfare of the Town by enhancing tourism and promoting Camp Verde as a destination and by assisting visitors to Camp Verde and Camp Verde residents with information and facilities which improve the quality of their experience when in Camp Verde; and

WHEREAS, the TOWN receives a significant portion of its tax revenue from tourist spending in the community and sales tax revenue from businesses; and

WHEREAS, the TOWN desires to maintain a strong and vital local economy by assisting in the retention and expansion of existing businesses, the attraction of new businesses, and tourism that are deemed desirable; and

WHEREAS, the CHAMBER is qualified and has the expertise, organization, and commitment to provide business services, and promote Camp Verde, and such efforts will generate tax revenue to assist the TOWN in providing facilities and services to all residents of Camp Verde.

NOW, THEREFORE IN CONSIDERATION OF THE MUTUAL PROMISES AND COVENANTS OF THE PARTIES, AND OTHER GOOD AND VALUABLE CONSIDERATION, THE PARTIES AGREE AS FOLLOWS:

1. **Purpose of the Agreement:** The TOWN hereby retains the CHAMBER to promote, develop business services for the TOWN and its surrounding areas, and to render specific professional and technical services to the TOWN. It is understood and agreed that the CHAMBER, while retained under this Agreement, will also be rendering other services to its members
2. **Marketing/Promotion Coordination:** The CHAMBER, in coordination with the Town shall promote Camp Verde and its events to the businesses and residents of the area and beyond. To this end the CHAMBER shall assist in the development of promotional products such as maps and brochures.
3. **Business Education:** The CHAMBER shall hold business educational seminars to assist in local business development.
4. **Council Relations with Business:** The CHAMBER shall hold business outreach to assist in development of better communications. To this end the CHAMBER shall organize mixers, listening sessions, or other techniques on the TOWN’s behalf as may be reasonably requested by the Town.
5. **General Services:** The CHAMBER shall assist the TOWN in items such as incubator development, lobbying and development of projects for the mutual benefit of the CHAMBER the TOWN and the community as may be reasonably requested by the Town.

6. **Coordination:** The TOWN Council Liaison to the CHAMBER and the Town Manager will meet periodically with the CHAMBER to discuss the coordination between the TOWN and the CHAMBER on items of mutual interest that promotes tourism and provides visitor information.
7. **Payment:** The TOWN shall make payments to the CHAMBER of \$6,000 IMMEDIATELY upon commencement of this Agreement and an additional \$36,000 ~~six~~-THREE months after the Effective Date, with terms to be determined for the budget for fiscal 2014, commencing July 1, 2014.
8. **Annual Financial Statement:** The CHAMBER shall provide the TOWN with a copy of its annual financial statement provided by CHAMBER'S public accountant.
9. **Termination:** If and in the event that a dispute between the parties arises as to the service to be provided under this Agreement, then the TOWN and the CHAMBER shall attempt to resolve said dispute. If the parties are unable to resolve the dispute directly, the parties may elect to mediate the dispute. If the parties are unable to resolve the dispute directly or by mediation within forty-five (45) days following the initial request for mediation by either party, either party may terminate this Agreement by giving the other party thirty (30) days written notice of termination. This Agreement is entered into in the State of Arizona and shall be construed and interpreted under the laws of the State of Arizona including, without limitation, the provisions of A.R.S. § 38-511.
10. **Term:** This Agreement will be in force from the Effective Date through June 30, 2014.
11. **Independent Contractor:**
 - a. The parties agree that the CHAMBER provides specialized services and that the CHAMBER enters this Agreement with the TOWN as an independent contractor. Nothing in this Agreement shall be construed to constitute the CHAMBER, nor any of its personnel, volunteers, or directors, as agents, employees, or representatives of the Town of Camp Verde.
 - b. As an independent contractor, the CHAMBER is solely responsible for all labor and expenses in connection with this Agreement (including, without limitation all workers compensation benefits and employee tax and social security withholding) and for any and all damages, which may arise during the operation of this Agreement.
12. **Insurance, Liability and Indemnity:** The CHAMBER agrees to procure and maintain at its sole expense insurance adequate to meet TOWN Policies currently requiring:
 - a. Certificate of Insurance for a General Liability Insurance Policy against claims for bodily injury, death and property damage with limits of at least:
 1. Each Occurrence\$1,000,000
 2. General Aggregate.....\$2,000,000
 - b. In addition, the Certificate of Insurance must name the Town of Camp Verde, Arizona as an Additional Insured in connection with the facilities as provided herein and must briefly describe the services being performed, e.g. Lease of TOWN Facilities.
 - c. Certificate of Insurance for Workers' Compensation Insurance Policy (Statutory), should CHAMBER hire employees. [NO EMPLOYEES CURRENTLY]
 - d. All Certificate(s) of Insurance referenced above and completed (signed by all pertinent parties) Services and Lease Agreement as provided herein shall be delivered simultaneously to the TOWN. Upon the TOWN's receipt of both the aforementioned documents the Agreement will be considered fully executed.
 - e. CHAMBER liability under this Agreement is not in any way limited by the insurance required by this Agreement.
 - f. CHAMBER shall keep said policies in force for the duration of the Agreement and for any possible extension thereof.

13. **Indemnification:** CHAMBER assumes and agrees to hold harmless, indemnify and defend the TOWN, its officers, agents and representatives from and against all losses, claims, demands, payments, suits, actions, recoveries, judgments and all liability of every kind, nature, and description for injury to persons including wrongful death, or damage to property or both occurring during, or in consequence, of the performance or failure to perform by CHAMBER. The TOWN assumes no liability, obligation or responsibility of any nature whatsoever, in connection with this Agreement except for payment of fees as stated or referred to herein.
14. **Subcontracting:** It is understood and agreed that the CHAMBER is free to contract with other parties or to otherwise provide additional services.
15. **Immigration Law Compliance:**
 - a. Under the provisions of A.R.S. § 41-4401, the CHAMBER hereby warrants to the TOWN that the CHAMBER and each of its subcontractors (if any) will comply with, and are contractually obligated to comply with, all Federal Immigration laws and regulation that relate to their employees and A.R.S. § 23-214 (A) (hereinafter “Contractor Immigration Warranty”).
 - b. A breach of the Contractor Immigration Warranty shall constitute a material breach of this contract and shall subject the CHAMBER to penalties up to and including termination of this contract at the sole discretion of the TOWN.
 - c. The TOWN retains the legal right to inspect the papers of any contractor or subcontractor employee who works on this contract to ensure that the contractor or subcontractor is complying with the Contractor Immigration Warranty. The TOWN agrees to assist the TOWN in regard to any such inspections.
 - d. The TOWN may, at its sole discretion, conduct random verification of the employment records of the CHAMBER and any subcontractors to ensure compliance with Contractor’s Immigration Warranty. The CHAMBER agrees to assist the TOWN in regard to any random verifications performed.
 - e. Neither the CHAMBER nor any subcontractor shall be deemed to have materially breached the Contractor Immigration Warranty if the CHAMBER or any subcontractor establishes that it has complied with the employment verification provision prescribed by sections 274A ad 274B of the Federal Immigration and nationality Act and the E-Verify requirements prescribed by A.R.S. § 23-214, Subsection A.
 - f. The foregoing provisions of subparagraphs a-e of this article must be included in any contract that the CHAMBER enters into with any and all its subcontractors who provide service under this contract or any subcontract.
16. **Miscellaneous Provisions.**
 - a. The titles used in this Agreement are for general reference only and are not a part of the Agreement.
 - b. This Agreement shall be interpreted as though prepared by both parties.
 - c. Any provision of this Agreement held to violate any law shall be deemed void, and all remaining provisions shall continue in full force and effect.
 - d. This Agreement comprises a final and complete repository of the understandings between the parties and supersedes all prior or contemporary communications, representations or agreements, whether oral or written, relating to the subject matter of this Agreement.

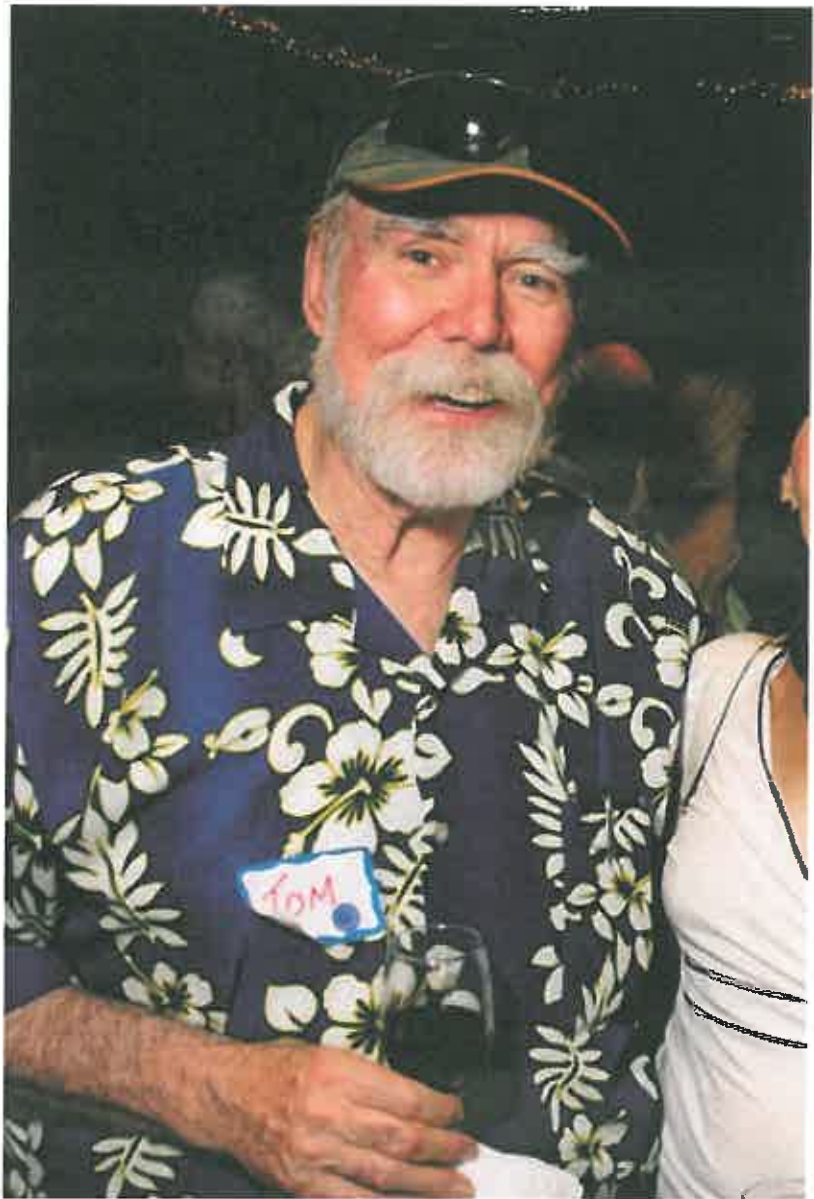
Kinsella said that Pitts not only is a tireless promoter of Jerome but also works to promote tourism regionally and statewide.

"There are so many of us working together, it is a great honor," he said.

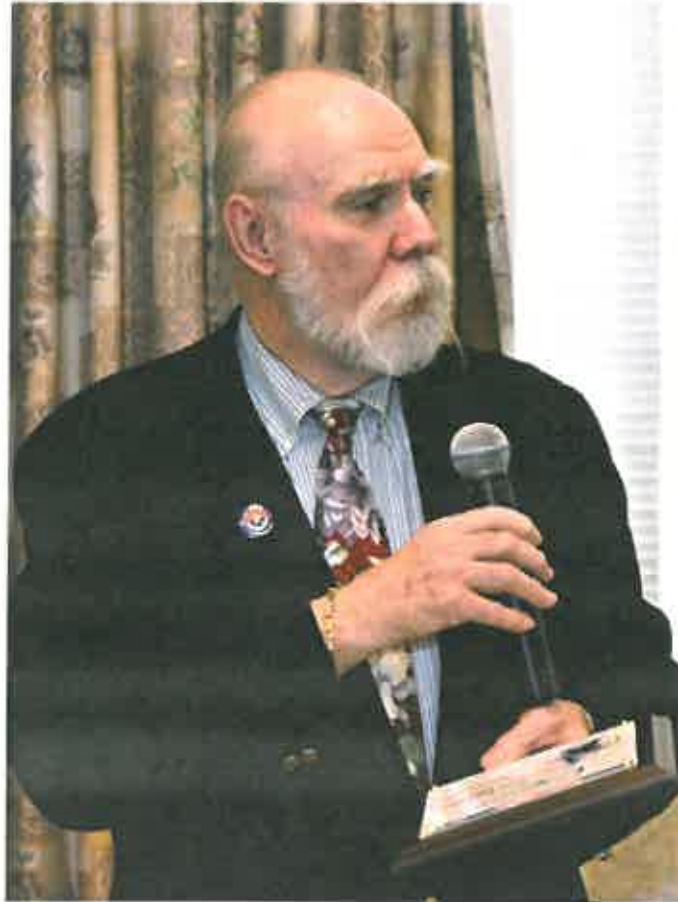
Pitts explained that his core of involvement started with the Jerome Chamber of Commerce after he purchased his business. "That's what got me going on regional efforts," he said.

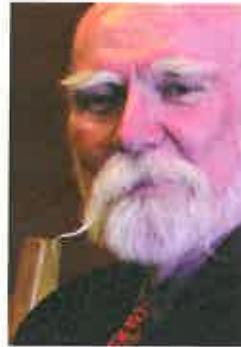
Granted: Our Wine Industry Continues to Grow

September's cover story took a good look at the stunning array of outstanding tasting rooms in Cornville and Cottonwood and gave us a good look at the "front of the house" of some of our local wineries, while singling out some of our top locally produced wines for your attention. This month, I'd like to take a look at the "back of the house" of some of our wineries, where the grapes are grown and the wines are made, to see what's behind the growth of our local wine-producing industry. The No. 1 driving force for this growth, of course, is the vision and the commitment of the men and women who own and operate these establishments. These are the people who will long be recognized as the pioneers who blazed the trail and showed the world what could be accomplished in our high-desert environment in the shadow of the red rocks when it comes to making world-class wine. They've done it by focusing on quality and making

long-term investments in the region in order to make their dreams a reality. We've quickly moved from a curiosity (you're making wine where?) to a recognized wine region that now sports its own Arizona section in each issue of *Wine Spectator*, the largest wine publication in the world. The magazine recently awarded two wines made in the Verde Valley (albeit with southern Arizona fruit) the first 90-point scores ever given to Arizona grown and produced wines. (If you missed the announcements, the two were Page Springs Cellars 2010 Colibri Vineyard Syrah Clone 174 and the Burning Tree Cellars 2010 Colibri Vineyard Syrah Clone 99. Colibri Vineyard is located on the eastern slopes of the Chiricahua Mountains in Cochise County in southeastern Arizona.) Coupled with the numerous competitive awards that are being accumulated on a regular basis by our local wineries, it's clear that we're now on the map to stay.

Some of the reasons for the increased awareness have been well chronicled in these pages, starting with the initial commitments of our local winemakers to create a new high-quality wine destination and sense of terroir – our own sense of place – in the Verde Valley. The growth of the Verde Valley Wine Consortium (VVWC), our wine trade association, certainly helped, as did the development of the only viticulture and enology programs in Arizona here at the Verde Valley campus of Yavapai College. But one element we haven't really discussed before is the surprising level of support provided by the state of Arizona via the state's economic development agency, the Arizona Commerce Authority (ACA). This has taken two primary forms. The first is the award of

more than \$330,000 in ACA Rural Economic Development Grants over the past two years to assist the wineries in purchasing equipment necessary for their expansion. I wrote those grants on behalf of the VVWC to help these wineries keep up with the growing demand for their products. The total expenditures for these projects by the participating wineries in this period totaled over \$2 million. This expansion created more than 50 new jobs in the region with a new annual payroll that exceeds \$1.25 million. That's made a major difference to the Verde Valley and came at a time when the economy was not at its best, to say the least.



Among other projects and equipment purchases, Caduceus Cellars/Merkin Vineyards created a new 28-acre vineyard and installed a high-speed bottling line for production and use for a planned incubator winery project to help new producers get established. Page Springs Cellars installed two new vineyards with approximately 16 new acres of grapes. Freitas Vineyards installed a cellar refrigeration system and purchased a forklift. Javelina Leap secured chillers and tanks to begin in-

house production of white wines. Arizona Stronghold purchased large temperature-controlled stainless steel tanks and a new labeler. Alcantara Vineyards bought a harrow and a sprayer, as well as fermenter tanks, barrels and barrel racks for their cellar operations. The financial support of the grants certainly helped but, almost more important, it signaled to the wineries that Arizona was supportive of their efforts and recognized their commitments to growing a new sustainable industry in Arizona. After all, it takes three to five years to develop full production from a new vineyard and another one to two years minimum before any of that wine production turns into cash flow. These owners are making true long-term commitments and both creating jobs and attracting tourism to our area.

The other key recognition for the wine industry came from the Governor's Strategic Partnership committee, of which I am a member. The committee has been an active force in Arizona in helping to create and recognize economic development "sectors" or "clusters" that are working together and leading the way for the recovery of the Arizona economy, which was particularly hard hit by the economic downturn. Arizona lost more than 330,000 jobs after the 2008 crash. Based at least in part on the economic impact studies of the wine industry conducted by the University of Arizona and Northern Arizona University, the committee now recognizes viticulture in Yavapai County as an economic driver and a key sector for growth in Arizona's economy.

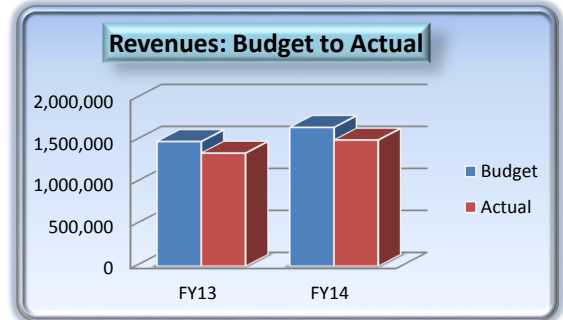

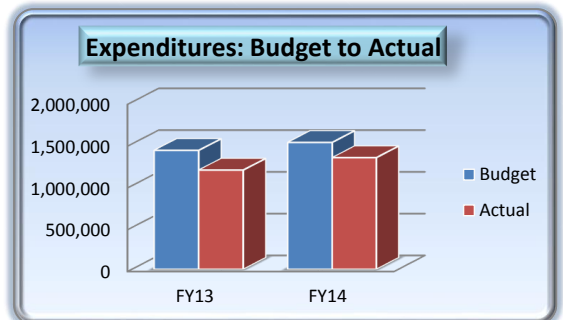

Revenues are short in most categories in this first QTR. The largest impact is felt in Local Taxes which is more than \$80,000 short of budget for the QTR. The 3 biggest culprits of this shortage (\$66,000 worth) is Retail (-\$33K), Construction (-\$22K) and Wholesale Trade (-\$11K). Our next 3 significant revenue sources, URS, State Sales and Vehicle License Taxes are generally right on budget.
