MINUTES WORK SESSION MAYOR AND COUNCIL COUNCIL CHAMBERS WEDNESDAY, AUGUST 14, 2013 at 6:30 P.M.

Public input, where appropriate, is heard prior to the motion

1. Call to Order

Mayor German called the meeting to order at 6:30 p.m.

2. Roll Call

Mayor Charles German, Vice Mayor Jackie Baker, Councilor Gordon, Jones, German and Whatley were present. Councilor George was absent.

Also Present: Town Manager Russ Martin, Town Clerk Debbie Barber, and Recording Secretary Barbara Bridge.

3. Pledge of Allegiance

The Pledge was led by Mayor German

4. Discussion, consideration, and possible direction to staff relative to the Camp Verde Chamber of Commerce's request for funding in the amount of \$12,000. Discussion might include, but not be limited to a proposed agreement for professional services, business plan, audits, year-end reports, financial statements, the Arizona Corporation Commission Certificate of Dissolution, and the 'gift clause' requirements as defined in the Arizona Constitution. Staff Resource: Russ Martin Mayor German opened the meeting by asking Council for their thoughts and concerns on this topic. Manager, Russ Martin advised the Council that he had confirmation that the Chambers non-profit, 501 (c) 3 was in good standing. Vice Mayor Baker began by distributing a chart, which becomes a permanent part of this record, indicating that the Town had paid the Chamber over \$730,000 in eight years with no accountability. She was concerned that the problem with the Chamber now lied with the lack of membership. In response to her questions, Vice Chair Kyle French advised that he did not know the number of members. Baker expressed concern that Council could not give money to a private organization without a direct benefit to the taxpayers. She volunteered to help the Chamber get out and talk to businesses about their needs, explaining that she worked with the Chamber when it was first organized. She said that it started with nothing and they built it up. She suggested that the Chamber take 90 days to try to come up with a plan and determine the viability of the Chamber's future. She was opposed to giving the Chamber money without additional information. Baker reminded the Manager that when he had established the Economic Development Director position that he had told Council that the money was coming from what was being paid to the Chamber for the Visitor's Center. Martin responded that he had said that, but a partnership with the Chamber was important and that there would be no duplication of duties.

Councilor German clarified that the Town had never 'given' money to the Town, but rather, the Town paid the Chamber to operate the Visitor's Center and to promote tourism. She was also concerned about giving money without having more information, noting that the Town is now operating the Visitor's Center and promoting tourism. She also volunteered to work with the Chamber to increase membership.

Whatley felt that there was definitely a need for the Chamber and that \$12,000 was not an unreasonable request, but she was concerned about the business owner's lack of interest. She said that she would like to see a poll of the businesses before the Town moves forward with funding.

Councilor Gordon said that an Economic Development Director was unnecessary in a Town as small as Camp Verde and that he would like to see a cost-analysis done comparing the benefits to investment at the end of the year. He also felt that the Town had not gotten their money's work from the Chamber over the years. He felt that a Chamber is important and that funding should be supported to a certain extent.

Councilor and Chamber Liaison Jones explained that in years past, the Town had paid the Chamber to do certain work and it was her experience that the Chamber did not perform. She advised that the Chamber had imploded when the Town took their funding and they are working now to reestablish the organization. She felt that the Chamber should be supported, but she was not sure to what extent at this time.

Mayor German said that he had talked to several business owners and that they had mixed messages. Referring to previous meeting minutes, German noted that the \$12,000 request was for six months only and he asked for clarification. French responded that \$12,000 would cover a full-time person for six months or a part-time person for 12 months. German also noted that Council had requested a business plan and other information, none of which have been forthcoming. He agreed with the idea of waiting for some period of time to allow the Chamber to get with business owners to determine what kind of organization that they would like to become within the next two years. He suggested several names of people who might be interested in helping to rebuild the Chamber. He also expressed concerns about handing over money without having more information about a viable organization. He was also disturbed that this request came after the budget was completed, noting that it was very tight. He did not feel that it was good to spend from contingency.

Mayor German summarized the discussion, stating that Council wants more information, such as a business plan' where they would like to be in two years; who the Board Members are; how many active members there are; the impact that they intend to have on businesses; take a poll of Town businesses to determine their interest in having a Chamber; and to bring that information back to Council in another work session, in which Council will revisit their request for funding. German suggested that this could occur anytime between 30 to 90 days and that it would fit within the Council's meeting calendar.

Manager Russ Martin stated that by funding the Chamber it would build a strong partnership, which would help promote the Town by marketing and networking with other agencies.

Public Input

Chamber of Commerce Vice-Chair/Treasurer Kyle French joined the discussion to answer questions. He stated the Chamber would not be doing Economic Development or tourism, but that the Chamber's focus would be solely business related. French acknowledged the Chamber had a lot of work to do to rebuild trust among the businesses.

There was no other public input

The meeting was recessed at 7:42 p.m. and reconvened at 7:52 p.m. for a short break.

 Discussion, consideration, and possible direction to staff to prepare a final draft of the revised Personnel Policy Manual for Council approval. Staff Resource: Russ Martin Policy Section 2-3-1 Full-Time Positions Martin asked Council to refer to this policy section that states in part, that all full time positions will be publicized to the general public. Martin suggested changing the policy to reflect that full time positions could be filled internally first if qualified personnel applied. Council discussed some concerns on exempt vs. non-exempt positions and directed Martin to see if the two could be separated in a policy.

Policy Section 3-6-1 H) Nonexempt Employees

Martin explained regular over-time hours and holiday pay, stating that if an employee gets paid time and one-half for a holiday, but then works over 40 hours in that week, the time and one-half is only paid for the holiday and not regular over-time. He explained that the policy should be changes so that the employee who has to work a holiday is paid time and one-half for the holiday and for hours over 40. Council agreed.

Policy Section 3-7 Paid Holiday Leave

Martin explained that the current policy requires employees use or lose accrued hours; however with the shift work hours of the Marshal's Office and the Sanitary District, this becomes a staffing issue and compromises safety of the town. Martin proposed that the Council consider paying the employee for 8 hours if they work the holiday or not to eliminate leaving a department short staffed by being required to take time off. Vice Mayor Baker wanted to know the bottom line cost of this change. Martin will get some figures together for further discussion.

Policy Section 4-10-3 Rate of Accumulation

Martin shared employee concerns about the fairness of topping out on vacation leave at 20 years which is 5 weeks off. He felt that the employees were too generous with the time off and suggested that the differential between exempt and non-exempt employees was unnecessary. He suggested that everyone gets 160 hours after 10 years. Council members will speak to Martin about concerns.

Policy Section 4-12-4, Retirement Plan

Retired Public Safety employees are no longer allowed to contribute to the Arizona State Retirement if they are rehired to another position for the town. Martin suggested the Council consider a possible 3rd option for these employees such as the government's 457 or 401K.

Policy Section 5-1-1 Normal Work Week and Work Hours

Martin suggested that the normal work week is up to the Department Head depending on the needs of the department and services to the citizens.

Policy Section 5-4-3 Prohibited Use

Martin wanted everyone know that playing games on Town time is prohibited and the Town takes it seriously.

Policy Section 5-6-7 Formal Personnel Action Review Procedure Steps

Martin reported this was not his opinion, but that he agreed with eliminating the Hearing Officer appeal process Martin ask Council to consider this option and get back with him.

Policy Section 6-1-4 Reimbursement

Reimbursement rates are on a 2 year schedule and the contract for those are 2 years, but the schedule shows 3 years. Martin advised that the typo was corrected to reflect the proper schedule.

In answer to Martin's questions, Council said that they would like to see all the changes brought back to another work session.

On a motion by German, seconded by Baker, the Council voted unanimously to approve the Consent Agenda as presented.

- 6. Call to the Public for items not on the agenda.

Adrienne Martin from the Yavapai AmeriCorps Project announced her departure due to a new opportunity in Florida, thanked the staff for their support and introduced the new director, Jenna Truman. The new director recognized Adrienne for all her work in the community with AmeriCorps. She introduced herself as a Yavapai County resident for 2 years, originally from Kansas, welcomed any suggestions, and distributed her business cards.

Mayor German thanked Martin her for her service on behalf of the community.

 Public Hearing and discussion, consideration, and possible recommendation of approval of a Series 10 (beer and wine store) liquor license application for Yavapai-Apache Whitehills (Chevron) Store #11208, located at 320 W. Castle Lane. Staff Resource: Debbie Barber On a motion by George, seconded by Baker, the Council voted unanimously to recommend approval of the Series 10 liquor license application for Yavapai-Apache Whitehills (Chevron) store.

Town Clerk Debbie Barber reported that the notice for the license was posted for 20 days with no comments received. Scott Canty, the lawyer for the Yavapai Apache Nation explained to the Council that the license was new in "name only." The business has had a liquor license since 2003 and is now operating under a new business name.

8. Discussion, consideration, and possible addition of Camp Verde Fire District Liaison to the 2013/14 Council Committee Assignments.

On a motion by German, seconded by Baker, the Council voted unanimously to add the Camp Verde Fire District Liaison to the 2013/14 Committee assignments.

Mayor German reported that he addressed the fire board recently and asked their opinion about appointing a liaison. He reported that the fire board was enthusiastic about such an appointment.

Councilors asked questions about the nature of the liaison's responsibilities and inquired about dates and times for meetings. It was explained that the board meetings are once a month on every third Thursday at 2:30 pm. No one on the council remembered having such a liaison, but agreed that it was a good idea since they work with many other organizations and the fire department, which has a substantial impact on the Town, is right across the street.

9. Discussion, consideration, and possible appointment of a representative to serve as the Camp Verde Fire District Liaison.

On a motion by German, seconded by Baker, the Council voted unanimously to appoint Councilor Brad Gordon as the Camp Verde Fire District Liaison and Vice Mayor Baker as the alternate Liaison.

10. <u>DISCUSSION, CONSIDERATION, AND POSSIBLE AUTHORIZATION TO CO-SPONSOR, WITH THE COMMUNITIES OF CLARKDALE AND COTTONWOOD, "A RIVER RUNS THROUGH US" ART EXHIBIT AT THE STATE CAPITOL.</u>

On a motion by Gordon, seconded by George, the Council voted unanimously to co-sponsor the art exhibit, "A River runs through us", at the State Capitol.

Councilor German encouraged all to attend the exhibit in September and to be involved in securing the venue in Phoenix.

Discussion, consideration, and possible instruction to the Mayor as to how to vote on the proposed League 11. Resolutions at the League of Arizona Cities and Towns (LACT) League Resolution Committee meeting on Tuesday, August 27, 2013 at 1:30 p.m. located at the Hilton El Conquistador 10000 N. Oracle Road, Oro Valley, AZ. The following is a summary of the proposed resolutions (the resolution numbers are established by the LACT): 1) develop and pass legislation to make the requirements for annexation simpler and more flexible; 3) prohibit Fire Districts from annexing areas inside a municipal planning area without the consent of the municipality, unless the municipality does not operate a fire department; 4) establish a mechanism enabling local government to create renewable energy and conservation financing districts; 5) promote legislation that grants legislative authority to cities & towns to freeze property tax levels on commercial & industrial zoned parcels that support speculative development at pre-improvement levels until such time as the developed property is fully leased; 6) authorize street light improvement districts to levy and expend money to repair, maintain, and replace lighting facilities; 7) change ARS §34-603, which deals with alternative project delivery methods to allow the use of the final list in the procurement until a contract for construction is entered into; 8) place reasonable limits on the frequency of requests for public records and on requests that are overbroad or abusive; 9) amend ARS Title 13 (Criminal Code) to ensure that restitution for graffiti includes all costs of a victim associated with graffiti abatement; 10) support implementing a pilot program to restrict trucks to the two right most lanes when traveling on Arizona highways in urban areas with three or more lanes in each direction; 11) stop future sweeps of Highway User Funds (HURF) allocated to AZ cities & towns and restore HURF funding to FY 2008 levels; 12) develop and pass legislation to ensure the viability of

AZ State Parks, including but not limited to allowing municipalities to enter into long-term leases of State Parks and the restoration of the AZ State Park Heritage Fund; 14) pass legislation that supports efforts to reduce the shortage of health care professionals in the State of AZ; 15) grant municipalities the option of providing workers compensation benefits to employees of another agency when working under the municipality's control or in its jurisdiction through and IGA or contract, especially as it relates to public safety personnel; 16) include one representative from a large city along with one representative from a small non-metropolitan city on the Public Safety Personnel Retirement System Board of Trustees; 17) request that the Public Safety Retirement System review their actuarial assumptions with regard to salary increases and base assumptions on current historical actual; 18) equalize the maximum tax credit and the timeframe allowed for collection of funds for qualified charitable organizations, private schools and public schools to qualify as a tax credit in any given year; 19) pass legislation or engage in other activities that support and advocate for resources to improve Arizona's ports of entry with Mexico and related infrastructure; 20) support the long-term retention of Arizona's military installations. League Staff Recommendations: 1) Preserve the tax-exempt status of municipal bonds and 2) pass the Marketplace Fairness Act.

Council reviewed the proposed resolutions and instructed the Mayor to vote as discussed. A copy of the summary is attached and becomes a permanent part of this record.

Mayor German asked Town Manager Russ Martin to prioritize these items for the Council. Martin organized the issues into three categories. He recommended a "Yes" vote for Resolution #4 on page 39, despite it not being recommended by the League for approval. He said the resolution left it optional for Towns to opt-in to the program.

On Resolution #8, the Council suggested making an amendment to implement fees which would deter unlimited requests, which would unduly tax the resources of the Town. Concerned about communicating the wrong message, the Council determined it would be best not to limit the number of requests for public records. Despite the legitimacy of the issue, as well as Camp Verde's experience with such, Council determined that taxpayers pay for this service, and though some citizens may abuse it, governments have to take the good with the bad. One Councilor referred to the federal Freedom of Information Act which accesses fees for documents in excess of a certain number of pages. Although, this would not solve the issue, since some may simply bring in their own paper, assessing a reasonable fee would act as a deterrent to abusing the system.

Council agreed with the League's recommendation to vote "No" on Resolution #10 that would allocate funds to a pilot program that simply conducts a study, rather than implementing actual changes.

Council agreed with voting "Yes" on Resolution #18. Two of the three educators on the board were in favor of equalizing tax credits, which are currently unfair. It was mentioned that voting "Yes" on public school tax credit issues, which are not directly related to the cities and towns, could set an unwanted precedent for other unrelated issues to be pushed to the League for consideration.

Martin recommended voting "Yes" on all the Significant Municipal Issues: Resolutions #7, #14, #15 and #17.

On the League's two Staff Recommendations, Martin agreed with Recommendation #1, explaining that it saves taxpayer money. He also agreed with Recommendation #2 that would implement an internet sales tax. He explained that it was important to support brick and mortar businesses, to collect revenue for the Town, and to consider how the lack of internet sales tax may diminish the Town's revenue source--such as from property taxes.

The Council considered the ability of the government to enforce such taxes, discussed the unfairness to brick and mortar businesses, considered the fact that other states have already implemented internet sales tax, and predicted that this would likely be implemented at the state and possibly even at a federal level.

12. Call to the Public for items not on the agenda.

There was no public input.

13. Council Informational Reports.

Jones attended two Yavapai Apache Nation tribal meetings where ADOT and a consulting design group presented Highway 260 plans. She plans to attend the Town Chamber of Commerce meeting on August 22, 2013.

Baker attended a Middle Verde Water Advisory Committee meeting where Mayor Doug Von Gausig presented a PowerPoint study. She recommended that the Council become familiar with such information. She plans to attend NACOG and the Intergovernmental meeting on August 22, 2013.

George attended a Fossil Creek meeting with the Forest Service and looks forward to more in the future.

Gordon attended a League of Towns meeting, a General Plan work session, and met with APS about the deregulation of the energy market. He mentioned that Felipe Zubia of ReSEED offered to help with the General plan.

Mayor German reported on the ongoing issues with Bull Pen involving flood events that has caused 23 deaths. He explained that the camping areas are in the flood plain and that it will cost an estimated \$40,000 to address the issue, which includes: risk assessment, surveying, mitigating 67 trees, and building camp sites above the flood plain. Bull Pen is expected to open in the spring for day-use only.

14. Manager/Staff Report

Martin reported being asked for his opinion on the article in the Verde Independent about the solar usage monthly fee, and recommended that the Council consider their direction for this issue.

He reminded Council that the carpool group departs at 5:05 pm for the Intergovernmental meeting and asked Council to RSVP. He expressed the importance for the Council to attend to help debunk the misconception that Camp Verde is privy to more information about the Highway 260 construction plans. He announced that per diem reimbursement checks could be made available before the event, if needed, and explained that the Town has already covered the cost of their hotel rooms.

FRIENDS OF THE VERDE RIVER GREENWAY and TOWN OF CAMP VERDE COOPERATIVE AGREEMENT

This Cooperative Agreement for Habitat Improvement is entered into between
("Land Owner"),Town of Camp Verde
and Friends of Verde River Greenway (FVRG), a nonprofit corporation under the laws of Arizona, for the purpose of mapping and removing invasive plant species on lands owned by Landowner ("Subject Property") as illustrated in the attached Exhibit A, incorporated herein by reference.

Background Information: Verde Lakes consists of 1,580 lots. The first subdivision developed in Verde Lake was recorded in 1969, the final plat recorded in 1971. Verde Lakes experienced severe flooding events from West Clear Creek in September 1970, December 1971, October 1972, February 1976, February 1980, January & February 1993, January 2010 in addition to continued repetitive minor flooding from monsoon events (including the current incidents). In 1994, FEMA assistance was used to repair damaged roads in the subdivision.

Verde Lakes was developed without a drainage plan; stormwater overtops the rights of way, deteriorating street surfaces and the water carrying silt, gypsum, and other debris flows onto resident's properties. The result of inadequate funding of a Stormwater Division, is that the Town has been mostly reactive to these circumstances: repairing or rebuilding roads and cleaning low water drainage crossings by bringing them back to the same conditions (or slightly better) prior to the storm damage. Thus repeating the same losses the next year.

In 2010, staff began studying Verde Lakes as a whole, manageable situation; looking for solutions that account for multiple drainage problems in and surrounding the subdivision. The lack of localized drainage affects over 80% of the properties to some degree. The first step of a proactive approach to stormwater management in Verde Lakes is The PDM Grant application. If approved, the funds will be used for construction of culverts to improve localized drainage by carrying stormwater runoff to West Clear Creek.

For this project, staff has estimated that 288 - 12" culverts, 288 - 18" culverts and 144 - 24" culverts, multiple 24" cross-intersection culverts, miles of road side ditch rehabilitation, driveway and channel easements and drainage road crossings will be required to better handle the stormwater flows.

A subsequent Grant application will address the second phase of this project: Verde Lakes Dr. Low Water Crossing. The topography of Verde Lakes Dr. requires additional scoping and engineering to account for the localized drainage improvements and to plan a cost effective, efficient design that will function as a crossing in a 100- year flood event.

Staff worked on part of the solution last year by making some improvements to one area of Verde Lakes Drive, additional funding in the FY 13/14 budget has been allocated for other minor improvements. By requesting grant funding, for both the Localized Drainage issues and Verde Lakes Dr. Low Water Crossing a comprehensive plan could be completed much faster and ultimately be more effective.

Recommended Action (Motion): Move to direct staff to prepare, complete and submit a Pre-Disaster Mitigation (PDM) Grant application under the Federal Hazard Mitigation Assistance guidelines; requesting funding, not to exceed \$1,500,000 for Stormwater Drainage Improvements in the Verde Lakes subdivision.
