Background Information:

The Arizona Professional Land Surveyors (APLS) have passed a resolution calling for the designation of the geographical center of Arizona. To that end, the Town of Camp Verde has been designated as the official "2012 Centennial Closest Community to the Geographic Center of Arizona".

The Town is very enthusiastic about this designation. In commemoration and on behalf of the Town's Mayor and Council (via a press release), residents and visitors were invited to the following two special events:

- February 15, 2012: Town Hall will conduct its business and a special council meeting at the Verde
 Lakes Clubhouse. The clubhouse is located at 2867 East Verde Lakes Drive, Camp Verde and is the
 nearest facility to the designated Center Point adequate for conducting Town business.
- 2. April 1, 2012: A Centennial Legacy marker will be placed at Rezzonico Park honoring Camp Verde as the official Center of Arizona Community. The educational display will focus on surveying, mapping and engineering in addition to water rights and usage issues during Arizona's formative years. Rezzonico Park is located adjacent to the Verde River on Moser Lane near Black Bridge. The cost of the display will be covered by APLS and their corporate sponsors who will be recognized at the dedication ceremony. The Town has invited the Honorable Governor Jan Brewer to read a Resolution approved by the Town of Camp Verde declaring and identifying the Center of Arizona Community and a Proclamation declaring April 1 as Arizona Geographic Center Day.

In summary, this is an opportunity for the Town to receive a designation and a Centennial Legacy marker. The Town can add said marker to the list of the many other Town attractions and events including:

Camp Verde is the home of Fort Verde Historic State Park, the best preserved fort in the state, as well as Montezuma Castle National Park, Out of Africa Wildlife Park, and Cliff Castle Hotel and Casino. Annual events enjoyed by visitors from all over the country include Fort Verde Days, Kingdom of the Spiders, Comfest and the Pecan, Wine and Antique Festival.

WHEREAS, The Town is very enthusiastic about being designated as the official *2012 Centennial Closest Community to the Geographic Center of Arizona".

NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE RESOLVE THAT:

- To commemorate this event the following Town celebration is planned: Town Hall shall convene to conduct its business and hold a Special Session Council Meeting on February 15, 2012, at the Verde Lakes Clubhouse located at 2867 East Verde Lakes Drive. The clubhouse is the closest facility to the Center Point that has accommodated the Town's Council Meeting/business previously; and
- 2. On April 1, 2012, a Centennial Legacy Marker will be placed at Rezzonico Park to commemorate Camp Verde as the "Official Center of Arizona".
