ORDINANCE 2004-A276

AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA, AMENDING CHAPTER 12, ARTICLE 12-2-3 USE OF COASTERS, SKATES AND SIMILAR DEVICES RESTRICTED OF THE TOWN CODE

WHEREAS, the Town Council adopted Ordinance 96-A116, adopting the Town Code which included Town Code Chapter 12, Section 12-2-3, Use of Coasters, Skates and Similar Devices, and

WHEREAS, it would be in the best interest of the public to update and revise Town Code Section 12-2-3 Use of Coasters, Skates and Similar Devices to include skateboard restrictions on any public street, sidewalk, alley or specified limits within the Town in order to address health and safety issues,

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE AS FOLLOWS:

<u>Section 1</u>. Chapter 12, Article 12-2-3 – User of Coasters, Skates and Similar Devices Restricted, of the Town Code is amended to read:

Section 12-2-3 Use of Coasters, Roller Skates, SKATEBOARDS, and Similar Devices Restricted

- A. It is a civil traffic violation for any person upon roller skates, COASTER, SKATEBOARD, GO-CART or riding any coaster, toy vehicle, or similar device to go upon any roadway except while crossing a street on a crosswalk, and, when crossing, such person shall be granted all of the rights and shall be subject to all of the duties applicable to pedestrians.
- B. NO PERSON SHALL RIDE UPON, IN OR BY MEANS OF ROLLER SKATES, COASTER, SKATEBOARD, TOY VEHICLE, GO-CART, OR ANY SIMILAR COASTING OR SKATING DEVICE, ANY SIDEWALK INCLUDED IN THE FOLLOWING PROHIBITED AREAS OF OPERATION:
 - 1. MAIN STREET FROM THE WESTERN MONTEZUMA CASTLE HIGHWAY INTERSECTION WITH HIGHWAY 260/MAIN STREET TO THE HIGHWAY 260 BYPASS INTERSECTION WITH MAIN STREET.
 - 2. ON ANY PUBLIC PROPERTY, EXCEPT THOSE AREAS DESIGNATED FOR USE OF THESE DEVICES.

- 3. ON ANY PRIVATE PROPERTY WITHOUT THE PERMISSION OF THE OWNER.
- C. WHENEVER ANY PERSON RIDING SUCH A COASTING OR SKATING DEVICE UPON A SIDEWALK IN A RESIDENTIAL AREA, SUCH PERSON SHALL YIELD THE RIGHT OF WAY TO ANY PEDESTRIAN AND SHALL GIVE AUDIBLE SIGNAL BEFORE OVERTAKING AND PASSING SUCH PEDESTRIAN.

<u>Section 2</u>. All ordinances or parts of ordinances adopted by the Town of Camp Verde in conflict with the provisions of this ordinance, or any part of the code adopted herein by reference, are hereby repealed, effective as of the day this ordinance is effective.

<u>Section 3</u>. This ordinance is effective upon completion of publication and any posting as required by law.

<u>Section 4</u>. Penalties. Any person found guilty of violating any provision of this ordinance shall be guilty of a Civil Traffic Offense.

<u>Section 5</u>. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
