

ORDINANCE NO. 2000-A157

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA, MODIFYING THE REGULAR COUNCIL MEETING DATES, TIMES, AND LOCATION

WHEREAS, ARS Section 9-233 requires the Town Council to fix the time and place of regular council meetings by ordinance, and file a written statement with the Town Clerk pursuant to ARS Section 38-431.02.A.3 where notice of the meetings will be posted, and

WHEREAS, the Town has already adopted a regular meeting date of the first and third Wednesdays of the month, special meeting for planning and zoning matters on the fourth Wednesday, and work sessions, as needed on the second Wednesday, as set forth in Section 2-3-1 of the Town Code, and

WHEREAS, the Town has established the posting of notices of the council meetings and their agenda to be at the Town Hall, the United States Post Office, at Bashas' store at Outpost Mall, and other locations or changes as may be prescribed by resolution, as Section 2-3-3 of the Town Code

NOW, THEREFORE, be it ordained by the Common Council of the Town of Camp Verde, that:

- 1. Repeal.** Section 2-3-1 of the Town Code of the Town of Camp Verde is hereby repealed, and replaced with the provisions of this ordinance.
- 2. Regular Council Meetings.** The Town Council will hold regular meetings at 6:30 p.m. on the first, third and fourth Wednesdays at the Town Hall complex on Main Street for general business, planning & zoning matters, and public hearings as may be required by law, with the second Wednesday set aside for work sessions as needed. A work session, in lieu of or in conjunction with a regular meeting, may be called. If a regular meeting or work session is cancelled, such as the 5th Wednesday of a month or near a holiday, notice of the cancellation shall be posted.
- 3. Posting of Alternate Meeting Locations.** In addition to the locations and content specified by Town Code Section 2-3-3 (Posting of Legal Notices), the Town Manager may request that a meeting with an agenda item or public hearing which may attract a large audience, or need special presentation facilities, be scheduled for the gymnasium, school auditorium, or alternate site suitable for public participation. If the Council votes to change the location for that meeting, notice of the location change shall be posted in the normal locations, plus at the site, and the meeting may be

called to order at the site without first being called to order at the Town Hall Council Chamber. This does not preclude Council from relocating a meeting that is in progress to accommodate a crowd that exceeds maximum occupancy limits as established for Council Chambers.
