## ORDINANCE NO. 99A-139

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF CAMP VERDE GRANTING TO CITIZENS UTILITIES COMPANY, A DELAWARE CORPORATION, ITS SUCCESSORS AND ASSIGNS, THE RIGHT, PRIVILEGE AND FRANCHISE TO CONSTRUCT, MAINTAIN AND OPERATE UPON, OVER, ALONG, ACROSS AND UNDER THE PUBLIC RIGHTS-OF-WAY OF THE TOWN OF CAMP VERDE, ARIZONA.
