## ORDINANCE NO. 91-A61

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA APPROVING THE STREET NAMING AND ADDRESSING STANDARDS/GUIDELINES

The Town Council the Town of Camp Verde hereby ordains as follows:

- I. The Town Council hereby finds as follows:
  - A. The Town of Camp Verde does not have an authorized, comprehensive addressing program for the land within the incorporated limits of the Town of Camp Verde. In an effort to provide proper emergency services and to coordinate with other addressing programs within the County, the Town has determined that a Street Naming and Addressing Program is essential.
  - B. The Street Naming and Addressing Standards/Guidelines were reviewed and discussed by the Town Council on October 9, 1991 in public hearings which were advertised and posted according to State Law.
  - C. The proposed standards/guidelines will enhance the health, safety, welfare and convenience to the general public and should be approved in order to ensure the proper administration of emergency services and provide for the comprehensive mapping in the Town of Camp Verde.
  - D. The Street Naming and Addressing Standards/Guidelines are recommended for approval, based upon the following findings:
    - 1. The standards/guidelines, as proposed, will enhance the public health, safety welfare and convenience.
    - 2. The standards/guidelines have been prepared with careful consideration of the existing land uses, staffing needs, and coordination with the addressing program of the County for unincorporated areas near the Town for continuity if future annexations are proposed.
    - 3. The standards/guidelines, as proposed, meet all requirements of Arizona State Law and the laws and regulations of the Town of Camp Verde.

- (the addressing requirements of) this Ordinance (within 30 days of initial notification by the Addressing Official,) shall be subject to a petty offense for the first offense, and a Class 3 Misdemeanor for a second or subsequent offence as to the same property, with each day the property is not in compliance may constitute a separate offense. "Person" includes the property owner, occupant or any persons having control over the use of the property.
- III. The Town Council of the Town of Camp Verde hereby adopts by reference the "Street Naming and Addressing Standards and Guidelines" as declared a public record in Resolution 91-165 and establishes this program as the only legal addressing system for the incorporated areas within the Town of Camp Verde.
- IV. This ordinance shall become effective after publication as required by law, and not earlier than thirty (30) days from enactment, and, pursuant to ARS 9-813, shall be in force from and after posting in three (3) or more public places within the Town limits.
