ORDINANCE NO. 90-A42

AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA APPROVING THE ACCESS CONTROL PLAN FOR STATE ROUTE 260 WITHIN TOWN LIMITS

The Mayor and Common Council of the Town of Camp Verde hereby ordains as follows:

- I. The Mayor and Common Council hereby finds as follows:
 - As required by the agreement with the Arizona Department of Transportation (ADOT) for the dedication of the section of road known as Zane Grey Hwy., General Crook Trail, Main Street, Finnie Flat Road and Highway 279, the Town of Camp Verde was to prepare and approve by Ordinance an Access Control Plan. This roadway was dedicated to the State in 1989 and is now referred to as State Route 260.
 - B. The Plan was reviewed by the Planning Commission on April 5, 1990 and by the Town Council on April 25, 1990 in public hearings that were advertized and posted according to state law.
 - C. The Access Control Plan is designed to meet existing development standards for access, parking lot design, medians, and intersections along that section of SR 260 which is within the Camp Verde Town Limits. This Plan applies to any new development or redevelopment of properties which gain access from or directly front onto SR 260.
 - D. The proposed Access Control Plan will not constitute a threat to the health, safety, welfare or convenience to the general public and should be approved.
 - E. The Access Control Plan is approved, based upon the following findings:
 - The Plan, as proposed, will not injure the public health, safety welfare or convenience.
 - 2. The Plan, as proposed, meets the requirements of the Arizona Department of Transportation.
 - The Plan, as proposed, is consistent with the proposed Land Use and Transportation Study of the Town of Camp Verde.
 - 4. The Plan, as proposed, is designed to reduce traffic conflicts and increase the efficiency of SR 260 and the permitting procedures contained therein are designed to streamline the process and reduce costly time delays to potential developers.
 - 5. The Access Control Plan, as proposed, meets the contractual requirements as established between ADOT and the Town.

II. The Mayor and Common Council of the Town of Camp Verde hereby approves the Access Control Plan as contained in Exhibit A to Town Council Resolution No. 90-107, with the deletion of the second sentence in the first paragraph on page 53.
