## TOWN OF CAMP VERDE ORDINANCE NO. 87-A02

AN ORDINANCE OF THE COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA ADOPTING AN INTERIM BUDGET FOR THE PARTIAL FISCAL YEAR ENDING JUNE 30, 1987, AND DECLARING AN EMERGENCY.

WHEREAS, the Town of Camp Verde is authorized, pursuant to A.R.S. Section 42-313, to adopt an interim budget for the partial fiscal year ending June 30, 1987, and

WHEREAS, the Common Council adopted Resolution No. 87-03 proposing an interim budget and calling for a public hearing thereon January 12, 1987, which was published for two successive weeks in the manner prescribed by law, and

WHEREAS, a public hearing for the purpose of hearing taxpayers on the subject of the proposed interim budget was held on January 26, 1987, in accordance with Resolution No. 87-03.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA, AS FOLLOWS:

SECTION 2.
