

NOTICE OF ELECTION
RESOLUTION 88-37

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE, ARIZONA, PROVIDING NOTICE OF THE NON-PARTISAN ELECTION OF A MEASURE PROPOSED BY INITIATIVE PETITION WHICH SHALL ENACT AND IMPOSE A PRIVILEGE AND EXCISE TAX ("SALES TAX") AND CODE OF ONE PER CENT (1%) OF GROSS INCOME, EXCLUDING SALES OF FOOD FOR HOME CONSUMPTION, AND EXCEPT FOR GROSS INCOME FROM LODGING RENTAL, WHICH SHALL BE TWO PER CENT (2%); ESTABLISHING POLLING PLACES AND VOTING DISTRICTS AND THE TIMES THAT SUCH POLLS WILL BE OPEN; AND APPOINTING ELECTION OFFICERS.

WHEREAS, it is provided by law for holding a non-partisan election of a measure proposed by initiative petition; and

WHEREAS, the Mayor and Common Council by resolution called a non-partisan election of a measure proposed by initiative petition to be held on May 17, 1988.

NOW, THEREFORE, be it resolved by the Mayor and Common Council of the Town of Camp Verde, Arizona as follows:

Section 1. Designation of Election Date

That the Town Election be held on Tuesday, May 17, 1988 for the purpose of deciding a measure proposed by initiative petition which shall enact and impose a privilege and excise tax ("Sales Tax") and code of one per cent (1%) of gross income excluding sales of food for home consumption, and except for gross income from lodging rental, which shall be two per cent (2%).






