
SANITARY LANDFILL AGREEMENT

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA, AUTHORIZING EXECUTION OF AN INTERGOVERNMENTAL AGREEMENT WITH YAVAPAI COUNTY FOR PAYMENT BY THE TOWN FOR LANDFILL SERVICES.

BE IT RESOLVED by the Mayor and Common Council of the Town of Camp Verde, Yavapai County, Arizona as follows:

That the Town shall execute the intergovernmental agreement dated December 7, 1988, with Yavapai County and reimburse the County for operational and maintenance costs in the amount of twenty one thousand, eight hundred, ninety two dollars and forty cents (\$21,892.40) for the fiscal year July 1, 1988 through June 30, 1989, payable as set forth in the agreement.

INTERGOVERNMENTAL AGREEMENT.

FOR FY 1988/89

This agreement, made this 7th day of December, 1988, by and between YAVAPAI COUNTY and the TOWN OF CAMP VERDE,

WITNESSETH that:

WHEREAS YAVAPAI COUNTY operates a sanitary landfill near Camp Verde, Arizona, for the benefit of residents of the unincorporated portions of Yavapai County, that is convenient for use by the residents of the TOWN OF CAMP VERDE,


IT IS AGREED:

1. Those persons residing or having businesses in the TOWN OF CAMP VERDE may use the landfill, either personally or through sanitary collection services.
2. All users of the Camp Verde Landfill shall comply with the regulations of YAVAPAI COUNTY governing times of use, prohibition of scavenging, separation of certain materials and disposal at the landfill.
3. The TOWN OF CAMP VERDE agrees to pay YAVAPAI COUNTY the sum of \$21,892.40 for use of the landfill during the period of July 1, 1988, through June 30, 1989, with payments to be made in two quarterly installments of \$10,946.20 due and payable on October 1, 1988, and January 1, 1989.
4. YAVAPAI COUNTY shall pay all expenses relating to the operation, maintenance, partial site closure and site development of the landfill.
5. The TOWN OF CAMP VERDE and YAVAPAI COUNTY each agree to hold the other party harmless and indemnify the other for any loss, liability or damage arising from any action, omission or negligence of each parties' employees, officers or agents, regarding the performance of this contract.
6. This agreement may be continued from year to year by the parties upon their agreement as to compensation to be paid by the TOWN OF CAMP VERDE to YAVAPAI COUNTY, and provisions shall be made in the budgets of each of the parties for their respective costs.
7. Each of the parties has provided adequate funds in its budget for FY 1988-89 for the expenditures contemplated in this agreement.
8. This agreement shall be effective only after it has been approved by the respective parties' Attorneys, authorized by resolution, executed


by the Boards of Supervisors and Town Council and filed with the Yavapai County Recorder.


