WHEREAS. Camp Verde 19 a town located within the defined boundaries of the Verde Resource Association; and.

WHEREAS. the Town of Camp Verde is interested in protecting the resources of the Verde River Watershed in the State of Arizona; and.

CHAIRMAN

THE CHAIRMAN WILL BE SELECTED FROM AND BY THE BOARD OF THE VERDE RESOURCE ASSOCIATION.

VERDE RESOURCE ASSOCIATION EXECUTIVE BOARD

THE VERDE RESOURCE ASSOCIATION BOARD WILL BE SELECTED FROM THE RESOLUTIONS RECEIVED BY DECEMBER 30TH BY THE VERDE RESOURCE ASSOCIATION STEERING COMMITTEE.

ORGANIZATION

THE VERDE RESOURCE ASSOCIATION WILL BE COMPOSED OF ONE DESIGNATED REPRESENTATIVE FROM EACH LEGALLY ORGANIZED INCORPORATED GROUP WITHIN THE VERDE RIVER WATERSHED. BOUNDARIES OF THE VERDE WATERSHED ARE DEFINED BY THE WORKING GROUP.

MEMBERSHIP OF THE EXECUTIVE BOARD

MEMBERSHIP ON THE EXECUTIVE BOARD WILL BE LIMITED TO THE FOLLOWING REPRESENTATION FROM EACH LEGALLY ORGANIZED RESOURCE WORK GROUPS.

GOALS

- 1) TO MAINTAIN THE QUALITY OF AIR AND WATER AND TO CONSERVE ENERGY, WATER, VEGETATION, SOIL AND WILDLIFE.
- 2) TO RETAIN OUTSTANDING NATURAL SCENIC LANDMARKS AND VISTAS.
- 3) TO PROVIDE PUBLIC CONSCIOUSNESS-RISING THROUGH EDUCATION IN RESPECT TO THE PRECIOUSNESS OF THE NATURAL ENVIRONMENT.
- 4) TO ENCOURAGE THE EXPANSION OF PASSIVE RECREATIONAL SITES AND ACTIVITIES.
- 5) TO PROMOTE CONSERVATION OF NATURAL RESOURCES IN COORDINATION WITH ECONOMIC PLANNING ACTIVITIES.
