## NOTICE OF ELECTION

## CAMP VERDE WATER SYSTEM FRANCHISE

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA, FINDING AND DECLARING THAT SAID MAYOR AND COMMON COUNCIL DEEM THE GRANTING OF A CERTAIN WATER FRANCHISE BENEFICIAL FOR THE TOWN OF CAMP VERDE; ORDERING A SPECIAL ELECTION TO BE HELD ON THE 21ST DAY OF MARCH, 1989, AT WHICH ELECTION THERE SHALL BE SUBMITTED TO THE VOTERS OF SAID TOWN, WHETHER A FRANCHISE SHALL BE GRANTED TO CAMP VERDE WATER SYSTEM; PROVIDING FOR THE GIVING OR NOTICE OF SAID ELECTION AND THAT ALL QUALIFIED VOTERS OF SAID TOWN SHALL BE ENTITLED AND QUALIFIED TO VOTE AT SAID ELECTION; DESIGNATING THE DEADLINE FOR VOTER REGISTRATION; ESTABLISHING POLLING PLACES AND VOTING DISTRICTS AND THE TIMES THAT SUCH POLLS WILL BE OPEN; AND APPOINTING ELECTION OFFICIALS FOR SAID ELECTION.

BE IT RESOLVED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA:

Section 1: Notice of Election

The notice of said election shall be given by the Clerk of the Municipality by causing a copy of this Resolution. Including the proposed franchise, to be published in full in The Journal and the Bugle Call, weekly newspapers of general circulation in said County, for five (5) consecutive weeks prior to the election, with less than one (1) full week elapsing between the last publication and the date of election.

That a special election is hereby called and ordered to be held in the Municipality on the 21st day of March. 1989. for the purpose of submitting to a vote of the qualitied electors of the Municipality the question as to whether the proposed franchise, as available at the Town Hall and published pursuant to ARS 9-502.C, shall be granted to Camp Verde Water System.
