A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA, TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH YAVAPAI COUNTY FOR UNIFIED EMERGENCY SERVICES.

WHEREAS, the Town of Camp Verde needs to plan and prepare for emergency services in the event of natural disasters or military action, in accordance with ARS 9-240.B.29 and ARS 25-307.A, and

WHEREAS, the Yavapai County Joint Department of Emergency Services is able to provide said emergency planning for the Town, and

NOW, THEREFORE, be it resolved by the Mayor and Common Council of the TOwn of Camp verde, Yavapai County, Arizona:

<u>Section 1</u>. The Town shall enter into the proposed intergovernmental agreement with the Yavapai County Joint Department of Emergency, dated June 3, 1992.

Section 2. This resolution is made pursuant to the requirements of ARS Section 11-952.H to file and effect the provisions of the agreement.

AGREEMENT

THIS AGREEMENT, made and entered into this <u>3eb</u> day of June, 1992, by and between YAVAPAI COUNTY, a political subdivision of the State of Arizona, hereinafter called "County" and the Town of Camp Verde, hereinafter called Town.

- 1. The County and the Town hereby agree to establishment of a unified emergency services organization for the purpose of preparing plans for the preservation and safety of life and property and making provisions for the execution of these plans in the event of enemy attack upon the United States of America and/or in the event of any nuclear or non-nuclear disaster within the County or Town.

 (A.R.S. Section 26-307 and 26-308.)
- 2. The unified emergency services organization is hereby designated as the Yavapai County Joint Department of <u>Emergency Services</u>.
- 3. The County will assist in performing the following services with the Town:
 - a. Include emergency operations of the Town in the approved County

 Emergency Operations Plan covering disasters;
 - h. Aid, and advise the Town with training of employees;

- of the following areas, such list not to be mutually exclusive:

 Health and Medical, Welfare, Law Enforcement, Rescue, Public Information, Radiological Safety, Engineering, Fire, Transportation and Supply, Shelter, Communications, etc. The above plans and programs are to be coordinated with the government of the Town;
- d. Develop and keep current an inventory of all equipment and supplies available in the County and Town for use in event of any disaster;
- e. Provide technical assistance in obtaining Federal or State Funds which may become available to the Town for emergency services purposes and in the acquisition by the Town of surplus or other property for emergency services purposes;
- f. Complete and submit all report requirements emanating from State or Federal;
- g. In the event of disaster confined to the Town, provide assistance as requested, within the limits of the ability of the County to so provide and coordinate assistance furnished by other agencies in accordance with mutual aid agreements;

4. That the Town shall:

- a. By this agreement become a member of the Yavapai County Joint

 Department of Emergency Services;
- Accept joint responsibility for the maintenance and currency of the Yavapai County Emergency Operations Plan;

- c. In the emergency services area, delegate to the County such lawful authority and responsibility as shall be deemed necessary by the Town;
- d. Budget and contribute to the County for the fiscal year commencing July 1, 1992 and ending June 30, 1993 the sum of \$674.30 in advance.
- It is hereby mutually agreed;
 - a. The Yavapai County Department of Emergency Services will include representation of all signatory parties;
 - b. The Yavapai County Department of Emergency Services shall be comprised of a County Coordinator appointed by the Yavapai County Board of Supervisors and a Town Coordinator appointed by the Town Council, and other personnel as deemed necessary by the County Board of Supervisors and the Town Council;
 - c. The County Coordinator who is and shall be appointed by the Yavapai County Board of Supervisors shall act as a coordinator of the Yavapai County Joint Department of Emergency Services;
 - d. The term of this agreement is for one year commencing July 1, 1992, and may be extended from year to year by mutual agreement of the parties prior to June 30 of the term, stating the compensation to be paid for service during such extended term and other charges;

e. This agreement may be terminated by any of the parties by written notice given the other parties, which notice shall be given at least sixty (60) days prior to the date the termination is to be effective. In the event that such termination occurs, the consideration to be paid shall be prorated and payable only for the term of the agreement up to the date of termination, provided that said funds are not irrevocably committed.
