NOTICE OF ELECTION

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA, PROVIDING NOTICE OF THE PRIMARY ELECTION; ESTABLISHING POLLING PLACES, VOTING DISTRICTS, TIMES THAT SUCH POLLS WILL BE OPEN, AND APPOINTING ELECTION OFFICIALS.

WHEREAS, it is provided by law for the holding of a Primary Election; and,

WHEREAS, the Mayor and Common Council, by resolution, called a Primary Election to be held on March 9, 1993.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the Town of Camp Verde, Yavapai County, Arizona as follows:

Section 1: Designation of Election Date

That the Town Primary Election be held on Tuesday, March 9, 1993 for the purpose of electing candidates for the offices of Council Member.




