
A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA DECLARING AS A PUBLIC RECORD THAT CERTAIN DOCUMENT FILED WITH THE TOWN CLERK AND ENTITLED AS THE FOURTH AMENDMENT TO VOLUME II OF THE PLANNING AND ZONING ORDINANCE RELATING TO OFF PREMISES SIGNS.

BE IT RESOLVED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA:


THAT, certain document entitled as the Fourth Amendment to the Sign Ordinance, an amendment to the Planning and Zoning Ordinance (attached hereto as Exhibit A), three copies of which are on file in the office of the Town Clerk, is hereby declared to be a public record, pursuant to ARS 39-802, and said copies are ordered to remain on file with the Town Clerk.

WHEREAS, the fourth amendment to the Sign Ordinance relates to the definitions and criteria for off premises signs within the Town of Camp Verde and amends existing portions of the Ordinance.

PASSED, APPROVED AND ADOPTED THIS 27th day of January, 1993 by the affirmative vote of a majority of the members of the Common Council of the Town of Camp Verde, Yavapai County, Arizona.

EXHIBIT A

4th AMENDMENT TO SIGN ORDINANCE

Page 210, Paragraph 1:

Permanent off-premise directional signs are permitted for businesses which by their nature must be located away from arterial highways. Such signs shall be:

- (1) Located at the arterial highway and/or intersections of access road leading directly to the business.
- (2) Limited to eight (8) square feet of panel area per side, not to exceed two (2) faces per sign, not to exceed eight (8) feet in height above grade, unlighted.
- (3) Limited in content to a generic description (one or two words) of the facility, an arrow or words giving directions (such as "next right"), and a symbol or logo identifying the chain or name of the business;
- (4) Limit of one standard within 60 feet of each corner of the intersection;
- (5) Required to obtain an off-premise sign permit (even though under the minimum size otherwise requiring a permit);
- (6) Limit to three such signs providing direction to any one parcel.

Page 221, paragraph 3:

- (3) Name, address, phone number of property owner or agent, if any, and written permission of property owner in the event of off premise sign.
