RESOLUTION TO CANVASS VOTE

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON MARCH 9, 1993; AND ORDERING THE RECORDING OF SUCH RESOLUTION.

WHEREAS, the Town Council of Camp Verde, Yavapai County, Arizona, by Resolution 93-212, adopted on the 20th day of January, 1993 did cause to be submitted to the qualified electors of the Town at a Primary Election called and held in and for the Town on the 9th day of March, 1993 for the election of three (3) Council Members; and

WHEREAS, the Town Council did cause notice of the Primary Election to be given by the Town Clerk, publishing notice thereof in the local newspapers as provided by law, such newspapers published in and having general circulation within said Town, which said notice as so published did specify the place where such election was to be held, and the candidates to be voted upon, copy of said notice with the affidavit of publication attached thereto, being now on file and a part of the official records of the Town Council of said Town, and

WHEREAS, the election returns have been presented to the Town Council and have been certified by the Yavapai County Election Officer, pursuant to ARS 16-622.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the Town of Camp Verde, Yavapai County, Arizona, as follows:

SECTION 1. That the total number of ballots cast at said Primary Election was 934.

SECTION 2. That the total number of ballots counted at said Primary Election was 934.


SECTION 4. That is hereby found, determined and declared of record, that the following candidates did receive a number of valid votes cast and are hereby issued a Certificate of Election:


