ESTABLISHING PARKS AND RECREATION FEE SCHEDULE**





(13 days per year, no single period to exceed 2 consecutive days.)

(Fee includes 10 tables/50 chairs)

Key deposit of \$20.00 required by all users. Cleaning deposits are refundable after inspection of facilities by staff \*

### FIELD RESERVATIONS:

Tournaments \$ 25.00 Day  
Leagues \$ 5.00 Day  
Soccer Field (practice & games) \$100.00 Season  
Butler Lights \$ 5.00 Game

### CONCESSION STAND ( BUTLER ) :

\$25.00 day ( 3 hours or more)  
\$10.00 ( 2 hours or less )

PUBLIC ADDRESS SYSTEM \$25.00 per use \$100.00 deposit

### SPECIALTY CLASSES: TOWN SPONSORED:

90 % of fees generated to instructor  
10 % of fees generated to town

### SPECIALTY CLASSES: NON-TOWN SPONSORED:

50 % of fees generated to instructor  
50 % of fees generated to town

### MEETING ROOM RENTAL:

\$10.00 per meeting or class use ( not to exceed 3 hours )

### SUMMER YOUTH DAY CAMP:

Fees established each year. Participants of family members may work off fees if unable to afford them, and/or receiving state of federal assistance.

Youth groups/organizations may perform community service projects in lieu of established fees.

Fees are established by the Town Council with input from the Parks & Recreation Commission and the Parks & Recreation Director.

Fees for activities or combination of facilities not listed will be determined on an individual basis.

\* Damages to equipment / facilities may result in replacement/damage cost.
