## RESOLUTION TO CANVASS VOTE

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 16, 1995; AND ORDERING THE RECORDING OF SUCH RESOLUTION.

SECTION 1. That the total number of ballots cast at said General Election was 904.

SECTION 2. That the total number of ballots counted at said General Election was 904.

SECTION 3. That the votes cast for the candidates for Mayor were as follows:

SECTION 4. That the votes cast for the candidates for Council Member were as follows:

John D. Garello 490 Dottie Simonis 379

SECTION 5. That the cotes cast requesting Title 9 Authority were as follows:

SECTION 6. That is hereby found, determined and declared of record, that the following candidates did receive a number of valid votes cast and are hereby issued a Certificate of Election:
