**A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA, APPROVING A REDUCTION IN POOL USE FEES**


*WHEREAS*, the Town Council recently approved fees for Town services in various departments by Resolution 98-389, and

*WHEREAS*, Section 13-1-2 of the Town Code requires that charges for parks and recreation facilities will be set by resolution of the Town Council, and


*WHEREAS*, it is in the best interests of the public to reduce fees for use of the public pool,

**NOW THEREFORE THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE RESOLVE THAT THE FEES FOR A FAMILY PASS SHALL BE REDUCED TO THE SUM OF \$100 FOR A SEASON, WITH USAGE ALLOWED FOR ALL IMMEDIATE FAMILY MEMBERS, AND RESOLUTION 98-389 IS SO AMENDED.**

**RESOLUTION OF THE MAYOR AND COMMON COUNCIL  
OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA  
ADOPTING FEES FOR TOWN SERVICES**


**WHEREAS**, the Town Council is authorized by various sections of the Town Code to set fees for public services, permits, and inspections, and

**WHEREAS**, the Town Council has previously set fees for business and peddlers licenses (sections 9-1-5 and 9-3-7) and for use of public facilities (Section 13-1-2), and all departments have submitted proposed fee schedules for 1998 until later modified, as detailed in Exhibit A presented to the Council on January 7, 1998,


**NOW THEREFORE THE COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA, RESOLVES AS FOLLOWS:**


1. All fees charged to the public established by prior resolution, custom and usage, and as presented in Exhibit A, except as modified herein, are hereby adopted.
2. The following modifications to Exhibit A are hereby made:
  - Except for the Marshal's Office, the charge for photocopies will be first three pages are free for 8 ½ x 11", \$.10 per page thereafter, and larger sizes are first two pages free, \$.25 per page thereafter
  - General program revenue for youth recreation events and programs will not be set to recover any minimum percentage of direct costs, but instead the fees will not be less than \$10 per child, unless waived by the Parks & Recreation Director for financial hardship
  - Zoning clearance fee for camps, clubs, churches shall be \$.025 per square foot under roof, not \$.25
3. Fee schedules as modified shall be available to the public without charge as public documents, and posted at the respective departments.
