**A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE
TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA
PERTAINING TO THE ESTABLISHMENT OF A MEMORANDUM OF
UNDERSTANDING BETWEEN THE TOWN OF CAMP VERDE AND THE VERDE
VALLEY OFFICE OF PARENTS ANONYMOUS**

WHEREAS, the Town of Camp Verde has the authority under ARS 9-240 to control the finances and property of the Town, and

WHEREAS, the Town of Camp Verde is aware of the lack of social service resources within its boundaries, and

WHEREAS, the Town is concerned and has an ongoing commitment to improve the quality of services to local residents, and

WHEREAS, the Town of Camp Verde and the Verde Valley Chapter of Parents Anonymous have a mutual interest in helping to strengthen families and provide quality diversion programs for youth in Camp Verde,

**NOW THEREFORE THE MAYOR AND COMMON COUNCIL OF THE TOWN OF
CAMP VERDE, YAVAPAI COUNTY, ARIZONA, RESOLVES AS FOLLOWS:**

1. That the Town of Camp Verde approves the signing of the attached Memorandum of Understanding with the Verde Valley Chapter of Parents Anonymous, and thereby
 - a. Approves the submission of a joint grant application to the Northern Arizona Behavioral Health Authority, and
 - b. Requests funding for the hire of a full time Parent and Child Resource Coordinator to be based at Town Hall, and
 - c. Commits in-kind resources towards the grant in the form of office space, utilities, office equipment and telephone lines.

Memorandum of Understanding

The Town of Camp Verde is geographically situated in Yavapai County, Arizona. Over the course of the past few years, Camp Verde has experienced an alarming increase in youth delinquency. Regrettably, there currently exist very few programs in Camp Verde to proactively mitigate against this disturbing dilemma. The Town of Camp Verde and the Verde Valley Chapter of Parents Anonymous recognize the importance of developing accessible resources within the Town's boundaries to help families, schools and justice agencies address this concern.

As such, the Town of Camp Verde and the Verde Valley Chapter of Parents Anonymous are pursuing a joint-grant application for submission to the Northern Arizona Behavioral Health Authority (NARBHA), in an effort to facilitate funding for the hire of a full time Parent and Child Resource Coordinator assigned to and geographically situated in Camp Verde for as long as funds are available from the grant.

Responsibilities of each party are as follows:

Parents Anonymous will:

- Administer and oversee the project.
- Take responsibility for hiring, training, supervising and providing direct compensation to a qualified Parent and Child Resource Coordinator.
- Provide all administration required for the NARBHA grant.
- Pursue active outreach in Camp Verde to attract and directly assist families
- Commit to working collaboratively with schools, community based institutions, justice agencies and other social service agencies in an effort to comprehensively address the needs of clients
- Commit to referring clients to other local resource providers as needed to address other outstanding needs or deficiencies

The Town of Camp Verde will:

- Provide accessible space (properly equipped with utilities, reasonable and necessary office equipment and telephone lines) for the Parent and Child Resource Coordinator to work on a full time basis.
- Refer families through the local court and criminal justice systems.
- Use available resources to disseminate information about the program publicly in the area (issuing public service announcements, etc.)
- Provide any data needed by Parents Anonymous to comply with NARBHA record keeping and report requirements.
