## APPROVING THE APPLICATION FOR LRSP HERITAGE FUNDS

WHEREAS, the Legislature under A. R. S. §41-503 has authorized the establishment of the LRSP Heritage Fund program, providing funds to the State of Arizona, its political subdivisions and Indian Tribes for acquiring lands and developing outdoor recreation facilities for public use; and

WHEREAS, Arizona State Parks Board (BOARD) is responsible for the administration of the program within the State, setting up necessary rules and procedures governing application by local agencies under the program; and

WHEREAS, said adopted procedures established by the BOARD require the applicant to certify by resolution the approval of applications, signature authorization, the availability of local matching funds (if applicable), and authorization to sign a Participant Agreement with the BOARD prior to submission of said applications to the BOARD; and

NOW, THEREFORE, BE IT RESOLVED THAT <u>The Camp Verde Town Council</u> hereby:

- 1. Approves the filing of an application for FY 2003 LRSP Heritage Fund assistance, and
- 2. Certifies that the application is consistent and compatible with all adopted plans and programs of <u>The Camp Verde Parks & Recreation Department</u> for outdoor recreation improvements; and
- 3. Agrees to comply with all appropriate procedures, guidelines, and requirements established by the BOARD as a part of the application process; and
- 4. Certifies that <u>The Town of Camp Verde</u> will comply with all appropriate state and federal regulations, policies, guidelines, and requirements as they relate to the application; and

- 5.
