Library Director's Report February 2011

Statistical Report

We have been learning the new statistical program that comes with our new library automation system. We are now at a point where we can start reporting some monthly statistics. They will be on a separate sheet attached to this report. Over the next few months, we will be adding to the sheet and revising figures as we get a better handle on this program. The network training session held on Feb 9th was a great success. The key questions I needed answered, were. I can inform you that 1870 people walked into the library in February. There were 229.5 work hours volunteered in February.

Physical Changes to the Current Library / New Library Developments

Over the last month, we have been working to resolved potential safety concerns in our building identified by the Safety Committee's inspection. Some concerns have been resolved and others require more extensive measures. We had Purinton Electric come in and give us recommendations and a quote on what work needs to be done to make this building safe. The town's maintenance and public works department will authorize the work to be done.

We are also looking into various enhancements we can make to our building and surrounding environment with our capital improvements money.

Books Videos, Computer Updates

In February, we added 140 items to the collection including 5 DVDs and 42audio books

We have set up all of our new public access computers and are working through the last couple of glitches. When we our last new staff computer (for checking out patrons and controlling the public access computers), everything should run smoothly.

Between now & April 15th, we have set aside 2 machines to print out state & federal tax forms free of charge. Both the state & federal governments have limited or eliminated the tax forms the provide us to give to the public. We will charge the public for instruction booklets printed out at \$.10 (ten cents) per page

Programs & Activities

In February, we hosted 6 adult programs, 7 children's program, 2 programs for all ages, and 3 school visits. We had a total of 68 adults 15 teens and 132 children at our programs. We will also be looking at free and low cost programs for adults and kids. We are continuing to do the classes for our LSTA grant project.

We started an adult reading program in January. The response continues to be very positive. 10 people attended in January and 16 people attended in February. Those who attended had a great time discussing what they had read and generally socializing.

We are starting to plan for a visit from the OneBookArizona Author for 2011. Carolyn Davis will be here on April 13th to talk about her book Hopi Summer

Funding & Fund Raising

The Library Endowment is soliciting donations for & selling tickets to its s annual Denim & Lace event this coming April 9th. It is shaping up to be another fun time for those who attend. I have tickets here at the library at \$30.00 each for those who would like to attend. We hope to be working on the 2011 / 2012 library budget in earnest by the end of March. We continue to be on the lookout for grants and gift to supplement our budget. Hopefully we only have 1 or 2 more years of tight budgets to get through. The monthly book sales continue to be popular fundraisers for the Endowment. A handful of volunteers maintain the book sale area and provide the smiling faces that sell the stock once a month. These sales bring in around \$600 a month. The Basha's "Shop and Give" program is in finished for another year. You will be able to link your Thank You cards to the numbers for the Library Endowment (23066) and CCCVL (25034) when the program resumes again in the fall. You may attach up to 3 numbers to your Thank You Card and your shopping dollars will be split that many ways.

Publicity

The newspapers ran a nice article about our volunteer appreciation lunch on Jan. 31st. We also had articles in the paper about our adult reading program, and an upcoming reading by local children's author Sherry Rossman on March 2nd. We are getting ready to publicize the OneBookArizona author we are bringing here in April.

Meetings Attended

I attended a meeting of Yavapai County Educational Technology Consortium on Feb 10th to get more information about SACCNET. SACCNET is a state wide project to bring expanded Internet bandwidth to rural areas. I was able to ask the many questions that need to be answered before I can recommend our participation. I hope to get the answers to those questions soon. Jan attended a network cataloging meeting on Feb. 17th. She is involved in updating our network manual.

Miscellaneous Items

We are continuing to present lessons as part of Alice's grant. We are always looking for ideas on lessons to present. The programs we are offering are well received and we will be continuing this line or library programming well after our grant is fulfilled. Our new adult reading club is gaining in popularity. More people attended in February and there was more positive response.

I am still looking into acquiring a better internet connection for the library and maybe for the town. I attended a meeting in Prescott on Feb. 10th and was able to ask the questions that needed to be asked. I am waiting for the answers. At this time, it seems like the project is too good to be true. As I get these answers, I will continue to discuss this with the Manager to determine what we should do next.

Public Works Monthly Report for February 2011

Public Works wants to welcome Steve Burroughs, if you have not met him please make time to stop by. Steve will provide additional knowledge and support to the Department in Streets, Engineering and Storm Water; we are looking forward to working with him.

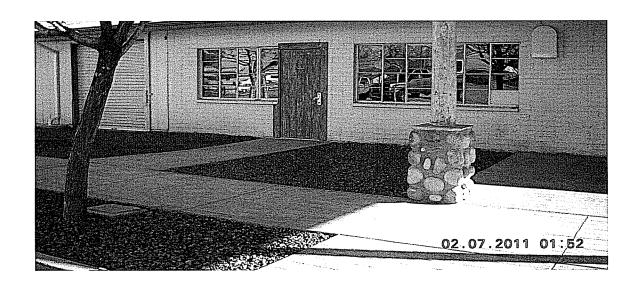
Streets Division: The Crew started pruning and completed a major clearing project on the streets of Prince, Princess and Queen; the work was required to allow emergency vehicles access to residences on these streets. The Crew provided Town Signs and place them in the ROW, to prepare for the closure of Montezuma Castle Highway for the February 26th Yavapai Apache Nation Exodus event; the VIP'S placed them on the streets the day of the event. Supplies were ordered and equipment prepared for the Crack Seal Program; the Crew expects to begin work the first week of March. New Bus Stop signs were installed on Cliffs Parkway by the Maverick station. No Parking signs were installed on Finney Flat across from the Thrift Store/park & swap lot. Crosswalk signs were installed near LA Fonda's. Republic ITS performed a semi-annual inspection of the two traffic signals owned by the Town and made minor repairs.

Engineering: The Pre-Bid meeting for the Library HVAC Retrofit was held February 15th, we had five contractors attend the meeting and hope to receive bids from all five on March 1st. This project will be funded mostly with remaining funds from the AARA/EECBG that was received for the larger HVAC retrofit on the Public Works Building; APS rebate funds will be added to the remaining grant. Ron attended meetings: Northern Arizona Stormwater Protections Association (NASPA), Stacy Barker of CVUSD regarding Shared Resources, Carl Stewart of NACOG regarding the Hollamon St. Project, Fort Verde State Park, and owner of Outpost Mall and a representative of Chase Bank regarding the entrance to their businesses.

Parks and Recreation: The 1^{st} through 4^{th} grade Grasshopper ended and was a success. We have just completed sign-ups and had our 1^{st} game for the 5^{th} through 8^{th} grade league. We have six teams in the 5^{th} & 6^{th} grade league and 3 teams in the 7^{th} and 8^{th} . Games are played every Wed. and Sat., so if you get a chance come out and cheer them on.

Maintenance: Contracted with Pacific Gutter for the installation of rain gutters at the entrance to the gymnasium moving the rain water to an underground drain. Decorative rock was then laid by the Crew (photo attached). Safety items were addressed at the Library also; the bulletin board at the Teen Center was moved to the Library. The crew completed OSHA medical, physical and fit tests for their respirators. New "Rules" sign installed at the Skate Park. Staff worked with Verde Entertainments to prepare for the Pecan/Wine festival including hanging and removing Main Street banners. Ballasts in several street lights were replaced. Moved the IT room and installed an antenna. Trimming/pruning of the plants on Main Street was complete.

Stormwater: Significant time was spent at Garner Lane to correct a drainage situation: Staff dug a dry well, hauled several loads of dirt and installed a grate and culvert and then lined the dry well with river rock, this will mitigate the issue of pooling water. Work to the ditch at Yaqui Circle was done.
