

RESOLUTION 2001-469

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAMP VERDE, YAVAPAI COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION OF THE TOWN HELD ON MARCH 13, 2001.

WHEREAS, the Town of Camp Verde ("Town"), held a primary election on March 13, 2001, for the nomination and/or election of Mayor and three (3) Council members, and

WHEREAS, the election returns have been presented by the Yavapai County Elections Department have been canvassed by the Town Council,

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Town of Camp Verde, Yavapai County, Arizona, pursuant to A.R.S. §16-646 and 9-821.01:

1. **The total number of ballots cast at the Primary Election, as shown on the poll lists, were 2,246, and the total number of registered voters in the Town was 4251, for a turnout of 53.23%.**
2. **There were 2 ballots to be verified and 22 mail ballots; 24 voters were found to be ineligible, and 24 ballots rejected.**
